## Submission to the Panel on Manpower for Monday 25 January, 2010

The Lion Rock institute supports the idea of the transport subsidy scheme whereby disadvantaged working individuals and families can access services and training in outlying areas to better improve their standard of living.

HOWEVER, we would like to see several changes to the current scheme.

1. The Lion Rock Institute understands that the current subsidy is given to individuals in 12 monthly installments within a 2-year period. We believe that the 2-year period is too short, and will merely encourage recipients to exhaust their subsidy.

To remind the administration, the reason why installment is better than a continuous stream of subsidy, is because you want to create the incentive for individuals who can leave or not enter the scheme to do just that. With the time period (in this case 2 years) as an incentive to conserve these monthly payments that when the time period is set to 2 years, what will actually happen is the recipients and the vested interest that assists them, will merely ask for "another 2 years/12 monthly installments"

In order for the street innit to work, instead of 2 years limit to this subsidy, the Lion Rock Institute suggests that person's lifetime eligibility for this subsidy should include its entire working life from 18 till 55 years of the White the monthly installment limits (currently 12 installments) can be changed to reflect a larger strip ble grand.

2. We have heart from many sources that there could be wide spread fraud and abuse in the current substily scheme white by middlemen" would entice individuals to apply and exhaust their benefits.




