Employment applications

The Scheme was implemented on 15th July 2003. Between 1st October 2009 to 31st March 2010, **3865** entry applications for employment were received (monthly average: **644**). In the same period, **3351** applications were approved, **240** refused and **350** withdrawn/no further action taken. As at 31st March 2010, **744** applications were under processing.
