I. Confirmation of minutes

Report on Stage One Public Engagement Exercise for the West Kowloon Cultural District project

Application of the findings in the Public Engagement exercise

- 3. <u>Members</u> in general considered that the findings of the Report on the Analysis of Views for the Stage 1 Public Engagement Exercise for the West Kowloon Cultural District ("the Report") were comprehensive, but expressed concern as to how the West Kowloon Cultural District Authority ("WKCDA") would translate these views in the planning of the West Kowloon Cultural District ("WKCD"), given their wide variety and in some cases diversity.
- 4. Mrs Sophie LEUNG stressed that WKCDA should identify the key issues to be addressed instead of emphasizing on an all-encompassing approach in the design of the Conceptual Plan ("CP") Options, in order that the planning of WKCD would not be lacking in focus. The Chairman and Prof Patrick LAU considered that WKCDA should provide clear directions on the findings to be incorporated into the CP to facilitate the work of the CP Consultants. Mr Paul TSE opined that public views should be an inspiration rather than constraint in the planning of WKCD, and maximum room should be allowed for creativity and innovation in the design of WKCD.

5. Representatives of WKCDA and the Administration responded that -

- (a) to foster a sense of ownership and build up consensus among the public on WKCD, it was of utmost importance to engage the public in its planning and development. During the Stage 1 Public Engagement ("PE") exercise, WKCDA had conducted a total of 66 PE events to capture public views, especially those of young people, on their expectations on the overall planning of WKCD and requirements for the various arts and cultural venues from both the professional and users' perspectives. The Authority had also conducted a questionnaire survey and commissioned the Public Policy Research Institute of the Hong Kong Polytechnic University ("PPRI") to conduct face-to-face interviews to collect public views (including those of visitors to Hong Kong) regarding key planning aspects that were fundamental to the preparation of the CP Options. The exercise had identified, inter alia, key concepts/common themes for the development of WKCD, such as green setting, environmental friendliness, Hong Kong characteristics, more open space, etc.;
- (b) the three CP Consultants should have a good understanding of the aspirations and preferences of the stakeholders and the public in the design of WKCD through their participation in the 66 PE events, and by making reference to the Report as well as the compendium which contained completed questionnaires and written submissions collected during the PE exercise. On the basis of the planning/development parameters set out in the Design Brief, the Consultants could capitalise on their professional experience/knowledge and creativity to translate the public views into their respective CP Options. Moreover, each of them

would be required to produce a statement on how public views had been taken into account in their CP. Given the scale of the WKCD project, where feasible and practicable, there should be room for the Consultants to accommodate opinions/suggestions apart from the key themes identified in the PE exercise;

- (c) in Stage 2 PE exercise scheduled for summer 2010, the CP Consultants would present the three CP Options to the public and stakeholders to seek their views on the three Options, including the Option which was most acceptable to the public and could serve as the foundation of the Development Plan ("DP"). The Consultant of the selected Option would be required to incorporate features of the other two Options preferred by the public and stakeholders; and
- (d) based on the selected CP Option, the Project Consultant would develop the detailed DP for public consultation at Stage 3 PE exercise tentatively scheduled for 2011.

Use of public open space and facilities in WKCD

6. <u>Dr LAM Tai-fai</u> envisaged that the open space at WKCD would become a focal point for public enjoyment/relaxation, as well as a gathering place/meeting point for migrant workers, particularly during the weekends. As this would have a direct impact on the image, management, design and operating cost of WKCD, he asked whether views on the use and management of open space had been collected in the PE exercise. <u>Dr LAM</u> added that WKCDA should be mindful of the needs of the grassroots who made up a large proportion of the Hong Kong population in the planning of WKCD. <u>Mr CHEUNG Kwok-che</u> sought WKCDA's views on the offer of free or concessionary rents to encourage the establishment of social enterprises at WKCD. <u>Ms Cyd HO</u> enquired WKCDA's stance on having a literature museum in WKCD.

7. Representatives of WKCDA and Director of PPRI responded that -

- (a) views on the use and effective management of public open space in WKCD had been incorporated in the Report, and 8.1% of views collected on other facilities to be built in WKCD were related to literary museum. These views would be conveyed to the WKCDA Board; and
- (b) given WKCD was primarily a cultural project and was still under development, it would be more advisable for social enterprises to make use of other district facilities which could better serve their immediate needs.

PE exercise arrangements

8. Mr CHAN Kam-lam enquired about the possibility of shortening the duration of the subsequent PE exercise, with a view to facilitating the early commencement of the construction work and ensuring the timely completion of Phase 1 facilities in WKCD in 2014-2015. For arrangements in the subsequent PE exercise, Ms Cyd HO suggested that participants should be allowed to select the focus group meetings which they were interested to join so as to motivate more meaningful discussions, and the questions of the questionnaire should facilitate the expression of more in-depth views from the respondents. Mr Paul TSE opined that apart from visitors from the Mainland and other Asian countries, WKCDA should also gather views of visitors from Europe and North America, as well as potential visitors from other places for a more comprehensive perspective on the WKCD development. Mrs Sophie LEUNG enquired about the arrangements to enable the public to visualize the future design of WKCD.

9. Representatives of WKCDA responded that -

- (a) it would not be possible to take forward the WKCD project without adequate public consultation, considering that views solicited in the PE exercise was an intrinsic element for the planning of WKCD and building of a people-oriented WKCD, and due consideration would be given to members' suggestions regarding the arrangements for the future PE exercise; and
- (b) digital and interactive 3-D models would be used for the presentation of the CP Options in Stage 2 PE exercise to facilitate public understanding and expression of views.

Development of cultural software to complement the WKCD project

Role of the Administration and WKCDA

10. <u>The Deputy Chairman</u> expressed concern about the delineation of responsibility between the Home Affairs Bureau ("HAB") and WKCDA in the development of cultural software. He called for closer collaboration between the two parties to ensure the re-alignment of the existing public arts and cultural facilities to complement the WKCD project.

11. Representatives of WKCDA and the Administration responded that-

(a) the planning and development of performing arts programmes and exhibition programmes in WKCD would be made based essentially on the recommendations of the Museum Committee and the Performing Arts Committee;

- (b) given HAB's role in overseeing arts and cultural policy to complement the WKCD project, the Administration was mindful of the need to ensure effective co-ordination between HAB and WKCDA, which would be further strengthened pursuant to the appointment of senior management/arts professional to the WKCDA and the creation of a dedicated post in HAB to take charge of such a task later this year;
- (c) the relationship between the existing and new cultural venues was complementary rather than competitive given their different positioning in terms of arts and cultural programmes and target audience; and
- (d) the new cultural facilities in WKCD should address the venue shortage problem currently encountered by the arts and cultural sector. The Administration was committed to building up a solid audience base to complement the expanded capacity of performance venues brought about by the WKCD development.

Funding support for arts development

12. The Deputy Chairman urged the Administration to increase the subvention to the Hong Kong Arts Development Council ("HKADC") to strengthen its support for budding artists and small and medium-sized arts groups. Mrs Sophie LEUNG considered that HKADC should assume a more proactive role in audience building and arts programme development. Ms Cyd HO considered that funding support for various arts groups should aim at promoting diversity and balanced development of the local arts scene.

13. The Administration responded that -

- (a) for the long-term development of arts and culture, HAB had commissioned a consultancy study in early 2010 to develop a new set of assessment criteria and funding mechanism for major performing arts groups ("MPAGs"), an entry and exit mechanism to the league of "majors", and an articulation ladder for the second and lower tier arts groups to become majors. The Administration would also inject \$3 billion into the Arts and Sport Development Fund as seed money and use the annual investment returns to subsidize the long-term development of sports and culture and the arts; and
- (b) given the significant financial and manpower resources involved, the Leisure and Cultural Services Department ("LCSD") had been playing a key role in audience building and bringing culture and the arts to the public, while the core mission of HKADC was to nurture budding artists and support the development of small and medium-sized arts groups through its various funding schemes and programmes.

Manpower development

14. <u>The Deputy Chairman and Dr LAM Tai-fai</u> asked whether the Administration had set any specific target in the training and development of arts personnel/professionals. <u>Dr LAM</u> further enquired about the support for nurturing new talents for Cantonese Opera.

15. The Administration responded that -

- (a) an additional funding of \$32 million would be earmarked in the next five years to launch training programmes for the development of some 140 arts administrators. These programmes would be organised by LCSD and its venue partners to provide training and internship opportunities for people who aspired to a career in the arts and culture. For the nurturing of museum professionals, WKCDA was planning to organize a sixmonth museum internship programme to provide on-the-job training for students of arts and cultural fields in local universities; and
- (b) of the \$69 million proposed capital injection into the Cantonese Opera Development Fund, \$9 million would be used for the nurturing of new talents for Cantonese Opera under the "Hong Kong Cantonese Opera Troupe for New Talent" Three Year Grant Scheme.

Audience building

16. To enhance students' exposure to and participation in arts and cultural programmes, Ms Cyd HO suggested distributing unsold tickets for arts performances to students for free, increasing the quota of student concessionary tickets for programmes offered in the Hong Kong Arts Festival, and soliciting sponsorship from the Hong Kong Jockey Club for students to enjoy high quality arts performances. The Deputy Chairman suggested that ticket discount should not be restricted to the performances organized in a specific arts event or by a particular arts group, but be extended to all events/programmes staged throughout a year to provide incentive for public participation in a variety of arts programmes. Given the strategic role of the 18 District Councils ("DCs") in bringing the arts and culture to the community, the Deputy Chairman considered that DCs should be encouraged to promote quality programmes which would enhance public appreciation of the arts and culture.

17. The Administration responded that -

(a) the Government is planning to provide additional resources to the Hong Kong Arts Festival for supporting the production by local artists and arts groups. With more local productions, the tickets for the Festival might become more affordable;

Action

- (b) members' suggestions regarding the arrangements for the unsold tickets and the discount mechanism for arts programmes would be conveyed to the relevant authorities/bodies; and
- (c) a one-off funding of \$180 million had been earmarked for the 18 DCs to support local organizations in launching a wide variety of community activities, including the promotion of quality cultural and arts programmes at district level.

Arts education

18. <u>Dr LAM Tai-fai and Ms Cyd HO</u> were doubtful about the effectiveness of the \$21 million additional resources for enhancing the promotion of the arts in schools in view of the small amount of allocation per student basis. <u>Ms HO</u> suggested that vocational training in technical stage works (such as lighting, sound, property making) should be included in the Applied Learning Courses under the "334" New Academic Structure to prepare interested students for further education in stage administration or related subjects at tertiary level.

19. The Administration responded that -

- (a) to tie in with the new senior secondary curriculum, the \$21 million additional resource would be used for developing young people's interest in the arts and culture and their appreciation abilities in these areas through their participation in programmes for free outside the classroom setting, such as "A Journey on Learning the Arts for Senior Secondary Students Scheme" and "Arts Experience Scheme for Senior Secondary Students"; and
- (b) the Hong Kong Academy for Performing Arts had launched a series of short programmes relating to stage management in the areas of Technical Management, Lighting, Sound, Property Making and Scenic Art, which were well-received by the public.

III. Any other business

20. <u>Members</u> considered that the Subcommittee should meet with the new Chief Executive Officer of WKCDA, who would take office around mid August 2010, in order to have a better understanding of his vision on the WKCD development. <u>Members</u> agreed that the Clerk should liaise with the Administration on the date of the next meeting.
