Action

I. Community care services for the elderly

[LC Paper Nos. CB(2)1868/09-10(01) to (03), CB(2)1911/09-10(01) to (02), CB(2)1928/09-10(01) and CB(2)1944/09-10(01) to (04)]

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

- 2. The Subcommittee received views from 12 deputations on the community care services for the elderly. Major views of the deputations are summarised as follows -
 - (a) while supporting the Government's elderly care policy of ageing in place, most deputations were concerned that the provision of the residential care services and community care services for the elderly was far from adequate to meet an ever increasing demand arising from the ageing population. The Administration should step up its efforts in enhancing the services and relieving the waitlisting situation. It should also formulate a long-term strategy for the provision of community care services for the elderly according to the users' needs and ensure that the community care services should be allocated to those who were most in need of the services;
 - (b) the Administration should further develop community care services for the elderly through the participation of the private sector, and consider introducing a voucher scheme for community care services so as to allow the elderly to choose the types of services that most met their needs;
 - (c) the Administration should consider introducing a carers allowance so as to relieve the burden and stress of family carers of the elderly;
 - (d) given that the impairment level and care needs of elders who were on the waiting list for subsidised residential care services were assessed under the Standardised Care Need Assessment Mechanism for Elderly Services ("SCNAMES"), some deputations urged the Administration to review SCNAMES expeditiously with a view to improving the assessment mechanism; and

- (e) the Administration should take note of the increasing trend of employing temporary staff and casual workers in the provision of community care services, bearing in mind this would affect adversely the quality of services provided to the elderly.
- 3. <u>Members</u> generally agreed with the direction of promoting "ageing in place" and considered that the Administration should come up with measures to meet the long-term care needs of the elderly. <u>Mr IP Wai-ming, Mr LEUNG Yiu-chung and Mr LEE Cheuk-yan</u> urged the Administration to actively consider introducing a carers allowance so as to relieve the burden and stress of the family carers in taking care of the frail elders. <u>Mr LEE Cheuk-yan and Mr LEUNG Kwok-hung</u> further cautioned that the provision of residential care services for the elderly could not be replaced with the community care services and the Administration should step up its efforts to relieve the waitlisting situation of residential care services and community care services for the elderly.
- 4. In the light of the views of deputations and members, Principal Assistant Secretary for Labour and Welfare (Welfare)3 ("PAS(W)3") said that the Government provided a range of subsidised centre-based and home-based community care services to help elders with long-term care needs age in place. This apart, the Government had introduced a number of new initiatives to support elders to continue to live in the community, viz. the District-based Scheme on Carer Training, the Integrated Discharge Support Trial Programme for Elderly Patients, the Home Environment Improvement Scheme for the Elderly and the Pilot Scheme on Home Care Services for Frail Elders ("Pilot Scheme"). PAS(W)3 elaborated on the three-year Pilot Scheme which would provide a new package of intensive and tailor-made home care services for frail elders, so as to better serve their special needs and help relieve the pressure of their carers. There would be an interim review to be followed by an overall review upon the completion of the Pilot Scheme. If the review findings of the Pilot Scheme were encouraging, the Administration would consider financing the projects under recurrent funding and extending the scheme to other districts after the three-year pilot period.
- 5. PAS(W)3 said that while ageing in place was the Government's policy objective, residential care places would continue to be provided to those elders who were in need of such services. Further development of community care services would encourage elders to age in place and thus avoid premature and unnecessary institutionalisation. Issues relating to the feasibility of introducing a licensing scheme and a voucher scheme for community care services, and the need for a review of SCNAMES would be covered in the consultancy study led by the Elderly Commission in the context of possible service enhancement on community care services with a view to further encouraging elders to age in place and thus avoid premature and unnecessary institutionalisation.

6. PAS(W)3 further said that the Government fully recognised that family carers played a crucial role in supporting elders who aged in place. Therefore, in designing the service model and content of the Pilot Scheme, the Administration would look at the needs of the elders and their family carers as a whole, so as to maximise the care capability of the carers, instead of allocating services to elders only according to their physical conditions and care needs. In addition, the launch of the District-based Scheme on Carer Training in October 2007 provided funding for District Elderly Community Centres to partner with community organisations in their districts in organising carer training programmes. was to enhance carers' capability through training so as to alleviate their stress resulting from taking care of elders. As regards the proposal for providing an allowance to family carers, PAS(W)3 advised that this would require thorough and careful consideration in view of the fact that impaired elders required various kinds of care services which would better be met by care professionals of residential and community care services.

II. Any other business

- 7. <u>The Chairman</u> said that the Subcommittee would discuss the implementation of the Integrated Community Centre for Mental Wellness and the update on Pilot Scheme on Home Care Services for Persons with Severe Disabilities at the next meeting to be held on 13 July 2010.
- 8. <u>The Chairman</u> further said that the review of SCNAMES would be discussed in the next legislative session.
- 9. There being no other business, the meeting ended at 1:05 pm.
