DUTIABLE COMMODITIES (AMENDMENT) REGULATION 2010

(Made by the Secretary for Financial Services and the Treasury under section 29A of the Interpretation and General Clauses Ordinance (Cap. 1) by virtue of section 6 of the Dutiable Commodities Ordinance (Cap. 109))

1. Commencement

This Regulation comes into operation on 27 April 2010.

2. Licences and fees

 - (b) in item 2, by repealing "17,950" and substituting "20,650".
- (3) Part III is amended in item 2, by repealing "17,950" and substituting "20,650".

 - (5) Part VII is amended—

Explanatory Note

This Regulation increases certain licence fees and other miscellaneous fees payable under the Dutiable Commodities Regulations (Cap. 109 sub. leg. A).

- 2. The fees that are increased are fees payable for—
 - (a) warehouse licences;
 - (b) import and export licences;
 - (c) special import licences;
 - (d) liquor licences;
 - (e) a manufacturer's licence for tobacco;
 - (f) a manufacturer's licence for hydrocarbon oil;
 - (g) the transfer, substitution or amendment of a licence;
 - (h) landing certificates, certificates of shortages or breakages of cargo and certificates of accuracy;
 - (i) storage of goods in a Customs and Excise warehouse;
 - (j) attendance of a member of the Customs and Excise Service at a warehouse or any other place or for certain purposes.
