## PRISONS (AMENDMENT) (NO. 2) ORDER 2009

(Made by the Secretary for Security under section 4 of the Prisons Ordinance (Cap. 234))

## 1. Commencement

This Order comes into operation on 25 February 2010.

# 2. Discontinuance of the use of places and buildings as prisons

The places and buildings specified in Schedule 1 are discontinued from use for the purposes of prisons.

# 3. Setting apart of places and buildings as prisons

The places and buildings specified in Schedule 2 are set apart for the purposes of prisons.

#### 4. Schedule amended

The Schedule to the Prisons Order (Cap. 234 sub. leg. B) is amended by—

- (a) repealing "Hei Ling Chau Addiction Treatment Centre (Annex) on the island of Hei Ling Chau, except those parts of the buildings known as Dormitories 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10";
- (b) repealing "Ma Po Ping Prison (the site and buildings situated at Tong Fuk on the island of Lantau, New Territories, and until now known as "Ma Po Ping Addiction Treatment Centre")" and substituting "Nei Kwu Correctional Institution on the island of Hei Ling Chau, except those parts of the buildings known as Dormitories 1 to 10 and 15";
- (c) repealing "Tong Fuk Centre (the site and buildings situated at Tong Fuk on the island of Lantau, New Territories, hitherto known as both the Tong Fuk Detention Centre and the Tong Fuk Addiction Treatment Centre)" and substituting "Tong Fuk Correctional Institution (the place and buildings situated at No. 31, Ma Po Ping Road on the island of Lantau, New Territories)".
