### 資訊共融基金會 就 立法會資訊科技及廣播事務委員會特別會議 提交文件 16/6/2011

- 1. 「上網學習支援計劃」(Internet Learning Support Programme,ILSP)執行機構的徵求建議書(Request for Proposal)中規定,執行機構(Implementer)必須為一間新成立機構,申請人(Proponent)則可以是私人機構或者個人。信息共融基金會有限公司(eInclusion Foundation Limited,下稱基金會)作為一間依據《稅務條例》第88條註冊的非牟利機構,符合作為ILSP執行機構的上述規定。互聯網專業協會(下稱 iProA)夥拍香港小童群益會作為基金會的核心夥伴,共同草擬投標建議書以及管理和執行該項目。其他參與投標的團體,亦須成立新機構作為執行機構以符合此規定。
- 2. 基金會董事會包括 iProA 和香港小童群益會的代表,以及9位知名的獨立專業人士。在現時的管治架構中,董事會以下設有由獨立專業人士領導的3個專責委員會和3個附屬委員會(見附表一Governance Structure)
- 3. iProA 是絕對政治中立的專業 IT 團體,現時擁有 2,600 多名會員。與其他專業 IT 團體一樣,iProA 積極推動本港資訊通訊科技業以及從業員專業的發展。iProA 的獨特之處,在於早在 12 年前成立時,已積極推行消除數碼隔膜的項目,並以此作為協會的宗旨之一,是香港最早提倡並推行數碼共融的團體,經驗豐富。iProA 在過去 10 年曾參與多項縮窄數碼鴻溝的社會服務項目,取得良好成果,服務有需要市民超過 20 萬人次。
- 4. 香港小童群益會服務香港 75 年,為低收入家庭及兒童提供眾多項目,經驗豐富。多年以來,該會為服務市民建立了廣泛而優良的社區網絡及地區關係。
- 5. iProA 與香港小童群益會有豐富經驗和實力。作為「上網學習支援計劃」的合約擔保機構,雙方均會確保基金會能完全按照政府的要求來執行計劃,並作出積極的配合。
- 6. 基金會在整個投標過程中,完全依照「上網學習支援計劃」的招標規定和既定程序進行。
- 7. 為低收入家庭提供上網津貼及服務,是 iProA 與香港小童群益會多年來堅持倡議的政策。自 2009 年起,兩個組織均曾在不同場合,建議政府落實推行該項政策。
- 8. 在葛輝先生提交的各項文件中提及與其他官員的對話或通訊內容,屬於政府內部溝通, 本會毫不知情。基金會不可能涉及葛輝先生提及的「政治任務」,也對此全不理解。
- 9. 在投標期間,基金會就「上網學習支援計劃」與政府接觸的主要聯絡機構為資訊科技總 監辦公室(下稱 OGCIO),主要聯絡人為葛輝先生。
- 10. 基金會推行「上網學習支援計劃」沒有政治動機,iProA 與香港小童群益會政治中立,與任何選舉或者政治活動無關。
- 11. 基金會就核心夥伴的分工早有共識,前線與地區工作由香港小童群益會負責及統籌,技術支援及上網、硬體等技術服務則由 iProA 負責統籌。分區統籌中心的分佈可參考附件二 Education Bureau Circular Memorandum No. 83 / 2011。

- 12. 基金會會將「上網學習支援計劃」受眾的資料儲存於獨立資料庫,資料受到個人資料 (私隱)條例有關敏感資料的保障,並由董事會委派的獨立成員構成的審計委員會監管。
- 13. 基金會在整個投標過程中未有得悉評分情況,直至葛輝先生於 5 月 27 日向立法會提交文件後才得悉。
- 14. 在政府的徵求建議書檔中,其評分標準 60%為執行機構的能力,而執行機構必須是新成立及符合《稅務條例》第 88 條的註冊免稅慈善團體。因此,基金會確信本會作為已經成立的載體(Entity),並根據標書要求組成董事會,是合情合理的。始料未及的是,不少投標機構及媒體,甚至議員,竟以"缺乏往績"為理由質疑本會的中標合理性,基金會對此感到震驚和極度失望。基金會希望在評核過程中,遴選委員會的成員有正確理解基金會成立的理據,並希望遴選委員會未有因此誤解而影響對基金會的評分。
- 15.「雙執行機構」方案,是在以受衆利益為前題下,一個可以接受的方案。採用是項方案,令學童需要的服務能趕及在本年九月份新學年開學時推出。作為嶄新的社會服務項目,不論本港和海外均有超過單一執行機構、分區推行的成功先例。基金會不同意有評論指其為一個"差"的方案。
- 16. 基金會的建議書在商業模式上有獨特之處,可讓計劃持續運作下去。葛輝先生在 2011 年 6 月 7 日的聲明中亦承認商業模式是基金會較其他投標者優勝之處。
- 17. 在招標後期,基金會曾應 OGCIO 邀請,致力與社聯探討"共同成立一間非牟利機構"去推行「上網學習支援計劃」的可能性,及後因與社聯就成立機構的模式有分歧而未能合作。
- 18. 基金會正密鑼緊鼓為預計於七月推出的「上網學習支援計劃」作最後籌備衝刺,努力為 有需要的學生趕及九月開學時提供上網服務。本會對任何調查方法沒有既定立場,但極 不希望因現時的爭議令計劃有任何延誤,影響幾十萬低收入家庭子女上網學習的機會。

### Statement by the eInclusion Foundation Limited

for Panel on Information Technology and Broadcasting, Special Meeting

#### on 16 June 2011

- 1. As stipulated in the Request for Proposal (RFP) to implement the Internet Learning Support Programme (ISLP), the Implementer has to be a newly established organization while the Proponent could be a Private Company or an individual. The eInclusion Foundation Limited (the Foundation), a non-profit making organization registered with the Inland Revenue Department under Section 88 has met with the requirement to function as the Implementer of the ILSP. The Internet Professional Association (iProA) and the Boys' & Girls' Clubs Association of Hong Kong (BGCA) are core partners of the Foundation to jointly prepare the proposal, manage and implement the project. This requirement to set up a new organization as Implementer also applies to other bidding organizations.
- 2. Members of the Board of Governors of the Foundation include representatives of iProA and BGCA, and 9 other distinguished independent members from different professions. Under the current governance structure, there are 3 Committees and 3 Sub-committees all headed by independent professionals reporting to the Board. (see Appendix 1 Governance Structure)
- 3. iProA is an IT professional association with over 2600 members and it has no political affiliation. Being one of the IT professional associations in Hong Kong, iProA has been active in exploring and creating opportunities for the Information & Communications industry and industry practitioners. Founded in 1999, iProA is amongst the first to advocate and promote the bridging of digital divide in the community and this has been one of its key missions set. For more than 10 years, iProA has organized and supported numerous community programs and events in bridging digital divide, involving personal service over 200 thousand times to target recipients with remarkable results.
- 4. Serving Hong Kong for 75 years, BGCA is known for its solid experience in serving the low-income families and children in Hong Kong. Over these many years, it has built extensive and exceptionally good community network and relations of a purely service nature in the districts.
- 5. Backed by the solid experience and unique strengths of iProA and BGCA, the 2 organizations have contractual commitment to act as guarantors for the Foundation for the successful implementation of the ILSP fully in accordance with and responding proactively to the requirements set out by the HKSARG.

- 6. The Foundation has acted in strict accordance with the bidding procedures and requirements set out in the RFP for ILSP throughout the entire tendering process.
- 7. For years, both iProA and BGCA have been persistent in their advocacy to support low-income families to get economical internet access and related services. Back in 2009, both organizations have provided policy recommendations at various occasions to the HKSARG to set related policy in this subject matter.
- 8. The Foundation has no knowledge of the related conversation and communications between various Government officials on the ILSP stated in the various papers presented by Mr. J. Godfrey. The Foundation is not and has never been in a position to receive, involve with or comment on the so-called 'political assignment' which we do not and cannot apprehend.
- 9. Throughout the tendering period, the prime contact for the Foundation with the HKSARG on the ILSP has been the Office of Chief Information Officer (OGCIO) where Mr. J. Godfrey has been our prime contact person.
- 10. The implementation of the ILSP by the Foundation does not entail political motive. Both iProA and BGCA have no political affiliation and involvement in election or political campaign related activities.
- 11. The roles and responsibilities of the 2 core partners of the Foundation has been agreed to where BGCA shall take charge of all front line coordination work to reach out to the low-income families and iProA shall take charge of coordination work on technical support, on-line service and hardware. See details on the distribution of the district service centres on Appendix 2 –Education Bureau Circular Memorandum No. 83 / 2011
- 12. The client data base of the ISLP shall be stored in an independent server, subject to the guidelines from the Personal Data (Privacy) Ordinance and audit by the Audit Committee of the Foundation with independent members from the Board of Governors.
- 13. Throughout the entire tendering process, the Foundation never received any information on the scores of the tender proposals until after the submission of the paper by Mr. J. Godfrey to the Legco on 27 May 2011.
- 14. As stated in the RFP, the assessment weighting on the capability of the Implementer is 60%, and the Implementer has to be a newly established non-profit making entity recognized as a charitable institution by the Inland Revenue Department under Section 88, it was our belief and understanding that the forming of the Board of Governors for the then already set up Foundation on a

tailor made Governors composition structure for the RFP would be most appropriate to meeting the RFP requirements. We are stunned and extremely disappointed that it is for exactly this reason to comply that the Foundation was accused of no prior track record and seen as not qualified to win the project not only by some bidding organizations, the media, and even some of the Legco members. We hope that we have established that the full picture of the Foundation is quite the opposite and that such misconception were not held by any of the Judging Panel members during the process of assessment.

- 15. The 'Dual Implementers' approach is an acceptable option to address the immediate public need. This is an option to allow the launch of the needed service for students when the new school term starts in this September. For new community service projects both at home and overseas, there are many successful cases that adopt more than one implementer or by district approach. The Foundation cannot agree to some who describe this as a 'bad' option.
- 16. The proposed 'Business Model' by the Foundation would well allow the ILSP to sustain and flourish in achieving the ISLP of its own initiative. This distinct "in house" advantage sets our proposal apart from the rest which Mr. J. Godfrey pointed out in his statement made on 7 June 2011.
- 17. At the later stage of the tendering process, the Foundation was invited by the OGCIO to explore the possibility to 'jointly establishing a non-profit organization' with HKCSS to implement the Programme but without success, due to the different views on the formation of the new entity to collaborate.
- 18. The Foundation is working very hard on all facets of the programme, targeting for the launch of the ILSP in this July so that students can enjoy the benefit at the start of the new school term this September. The Foundation do not object to any kind of investigation by the Legco as deemed fit, but the last thing we would like to see is the delay of the programme launch as that will jeopardize the interests of tens of thousands of needy school students from low-income families for whose benefit the ISLP has been exclusively designed.



### Internet Learning Support Programme - "i Learn at home"

### **Summary**

The purpose of this circular memorandum is to inform primary and secondary schools of the **Internet Learning Support Programme** – "i **Learn at home**". Heads of schools and teachers are requested to inform eligible students of the captioned programme and to participate in the forth-coming briefing sessions.

### **Details**

- 2. **"i Learn at home"** (programme) is a 5-year programme funded by the Office of the Government Chief Information Officer (OGCIO) aiming to provide necessary support to facilitate online learning at home. The programme will commence in the 2011 / 12 school year to assist eligible students and their parents to acquire affordable Internet access service and computers, the provision of technical support / training as well as advisory services on safe and healthy use of the Internet.
- 3. Two non-profit organisations, namely the WebOrganic and the eInclusion Foundation Limited (eInclusion) will be responsible for the implementation of the programme. Details of their services provided, eligibility and application procedures can be found in the Annex.
- 4. To introduce the programme to school heads, teachers and school social workers, OGCIO and the two organisations will conduct 3 identical briefing sessions in the morning and afternoon of 15 June 2011 (Wednesday) and in the morning of 24 June 2011 (Friday) to further explain the details. Schools are invited to nominate a maximum of

3 representatives to attend any one of the briefing sessions. Please enroll through the EDB Training Calendar System (TCS) [Course ID: EI 0020110258].

5. Besides, 2 posters (Chinese version only) will be distributed to schools in due course for posting at prominent places of your school premises to promote the services.

# "i Learn at home" Internet Learning Support Programme

### Introduction

In this digital age, use of the Internet for teaching and learning is common. Web-based learning and research is now an integral part of education and students' social life. Students conduct research, do their homework, network with friends, acquire knowledge and explore the world through the Internet, not only in school but increasingly at home. While the Internet enhances learning, some parents and teachers are concerned about the possibility of obsessive use and improper Internet behaviour like cyber bullying. They hesitate to set up Internet connection at home for want of knowledge and support to ensure its effective use for learning by their children. Others may have financial difficulties in acquiring computers and related services. These factors hinder the wider adoption of Internet learning among students.

In order to mitigate the impact of digital divide on the quality of learning and drive wider adoption of Internet learning in a safe and healthy manner, the Financial Secretary announced in his 2010-11 Budget a two-pronged strategy to assist eligible students to undertake web-based learning at home, which includes —

- (a) *Provision of an annual Internet Access Subsidy* at full grant of \$1,300 or half grant of \$650 to eligible families; and
- (b) *Implementation of a five-year Internet Learning Support Programme* to help eligible families acquire affordable Internet services and computer equipments and to provide them with user and social support.

The Internet Access Subsidy has been disbursed to eligible families since last year. The Government will launch a five-year "**i Learn at home**" programme in July 2011 to support eligible students in undertaking web-based learning at home. Two non-profit organisations, namely, eInclusion Foundation Ltd (eInclusion) and the Hong Kong Council of Social Service (WebOrganic), are engaged to implement this programme.

### **Services to be Provided**

Under the 'i Learn at home' programme, the following services will be provided to eligible families —

- (i) economical Internet access service;
- (ii) affordable computer equipment with flexible payment options;
- (iii) technical support through hotline and helpdesk;
- (iv) training for students;
- (v) training for parents; and
- (vi) group based and one-on-one advisory service.

### **Service Centres**

eInclusion and WebOrganic will implement the "**i Learn at home**" programme in different districts. They have set up service centres in their service zones, the locations and contact numbers of which are detailed at the <u>Appendix</u>.

### **Eligibility and Application Procedures**

Families and their school age children receiving the Internet Access Subsidy through the Student Financial Assistance Agency (SFAA) or the Comprehensive Social Security Assistance (CSSA) scheme in the 2011/12 school year are eligible for the services provided by the Implementers.

To enjoy the services and offers, eligible families should register with the relevant Implementer according to their home address by visiting the service centres and providing one of the following support documents as proof of eligibility —

- (i) certificate of CSSA recipients (for Medical Waivers) issued by the Social Welfare Department; or
- (ii) notification on eligibility assessment result or copy of the Eligibility Certificate (Financial Assistance for Primary and Secondary Students) issued by the SFAA for the current school year.
