Letter from Clerk to Security Panel to the Administration Regarding the Security Panel Meeting on 2 November 2010

I enclose for your reference the above letter from the Clerk to Security Panel, Legislative Council (LegCo), of 15 October 2010.

The follow-up actions to the 23 August 2010 Philippine Tour Group Incident will be discussed at the LegCo Security Panel meeting scheduled for 2 November 2010.

In this connection, the Panel requested (vide para. 2(b) of the attached letter) the Security Bureau to provide, among other things, the Police's investigation report / interim investigation report on the Philippine Tour Group Incident on 23 August 2010, and if necessary, to seek consent from the Coroner for release of such report to the Panel.

Section 10 of the Police Ordinance (Cap. 232) stipulates that the Police have a duty to take lawful measures to assist coroners to discharge their duties and exercise their powers under the Coroners Ordinance (Cap. 504). The Coroners Ordinance also provides for the Police to assist coroners to carry out investigation. The Police are now performing their statutory duty to investigate into the eight deaths following the hostage incident in Manila as per the Coroner's decision.

Section 13 of the Coroners Ordinance stipulates the procedure for a "properly interested person" to request from the coroner various documents (including the Police's investigation report for the coroner) in the possession of the coroner. "Properly interested person", as defined in section 2 and Schedule 2 of the Coroners Ordinance, includes the family of the deceased, Government departments which are concerned with the death of the deceased, and other specified parties. In view of the specific procedure stated in the Ordinance, the Administration is unable to state whether the LegCo Security Panel is a "properly interested person" within the meaning of the Ordinance and to make a request to the Coroner, on its behalf, for the provision of the Police investigation report.

Upon the Panel's request, we forward a copy of the letter dated 15.10.2010 from the Clerk to Security Panel for your reference.
