RE: Copyright (Amendment) Bill 2011 should be passed without delay

The American Chamber of Commerce in Hong Kong (**AmCham**) is a non-profit business organization representing 1,800 members of 40 nationalities from over 800 organizations, including multinational firms, small and medium enterprises, entrepreneurs, and non-profit organizations.

After consultation with our members through the Intellectual Property Committee, we urge the Honourable Members of the Legislative Council to pass the Copyright (Amendment) Bill 2011 (Bill) proposed by the Administration during the current session of the Legislative Council and not delay it further for the following reasons:

- 1. As pointed out in our earlier submissions to the Administration, AmCham's members have been suffering significant losses as a result of rampant illegal downloading and uploading activities in Hong Kong. Hong Kong's copyright legislation lags behind many jurisdictions in respect of its ability to address challenges arising from the digital environment. This Bill is urgently required as a step towards tackling serious online piracy problems that stifle creativity and innovation. Moreover, the bill creates a shared responsibility between content owners, online servers and users which maximizes creativity and innovation.
- 2. The proposal to introduce a fair dealing exception to allow the use of works for parody and satire is one that has merit but would require further consideration, especially as it was not part of the comprehensive public consultation associated with the Bill. Such a proposal should not deter the swift passage of the Bill. We would support any separate consultation exercise by the Administration on this issue after the Bill is passed.
