Bills Committee on Legislation Publication Bill (the "Bill")

Response to request for information by members on the Bill

At the meeting on 14 February 2011, the Bills Committee asked the Administration to provide written information to address the concerns raised by members on the Bill.

Status and availability of printed version of legislation

2. Annex 1 is a table containing the relevant provisions on the status and availability of the electronic version as well as the printed version of legislation in a number of jurisdictions with electronic legislation database. All these jurisdictions (except Queensland whose database is for information only) accord equal status to the electronic version and printed version of legislation. The relevant provisions allow users to download authenticated printed versions from the database directly and provide for the availability of printed versions from other authorized sources.

Summary of relevant standards and guidelines

- 3. Below is a summary of the relevant parts of the standards and guidelines issued by the Office of the Government Chief Information Officer on information technology operation management and information security incident handling—
 - (a) Defining continuity management framework Bureaux and Departments ("B/Ds") should set out the objectives, scope and management framework of continuity management.
 - (b) Performing business impact analysis (BIA) B/Ds should carry out analysis to evaluate the impact over time of disruption to critical business functions in order to determine the maximum tolerable downtime of IT services supporting the functions.
 - (c) Performing risk analysis (RA) B/Ds should conduct analysis to identify threats that could cause a disruption to business functions and to assess likelihood and impact of those threats on critical business functions and corresponding IT services supporting the functions.

- (d) Formulating continuity management strategy B/Ds should formulate risk reduction and recovery strategies for supporting the critical business functions and determine the duration of time within which a business process must be restored after a disruption. The strategies and the duration of time should commensurate with the assessment results of the BIA and RA.
- (e) Developing continuity plan B/Ds should develop detailed action plans for management of continuity and recovery of critical business functions and corresponding IT services supporting the functions.
- (f) Reviewing continuity plan for improvement B/Ds should review the continuity plan regularly to ensure its workability by checking validity of the design (e.g. the assumptions, risk assessment, recovery strategies, etc.) against the actual business requirements, and by testing the recovery plan on a regular basis to ensure effectiveness and comprehensiveness of the recovery procedures.

Clarification of Clause 5 of the Bill

- 4. Clause 5 of the Bill empowers the Law Draftsman to certify the consolidated version of an Ordinance to be an authenticated copy of the Ordinance at a particular time on a particular date. The inclusion of the "time" element is to cater for those provisions which may not commence on the beginning of the date provided for. Users can access the authenticated copy of an Ordinance at any time. They can check the latest consolidated version of the Ordinance (which will state the time and date of commencement of the latest incorporated amendments) to ascertain the currency of that version.
- 5. To enable users to have convenient access to different versions of a principal ordinance as it is amended over time, the Database will contain consolidated versions of the ordinance incorporating amendments that have commenced operation at different dates. Indeed BLIS also contains historical and current versions of Ordinances. The difference between the Database and BLIS is that while copies of versions of Ordinances in BLIS are for information only, copies of some consolidated versions of Ordinances accessed from the Database are authenticated copies and carry legal status.

- 6. Clause 5 provides that only copies of Ordinances accessed from the database that have been certified by the Law Draftsman to be the consolidated versions of Ordinances as at a particular time on a particular date are authenticated copies of Ordinances. These copies carry "presumed to be correct status". Copies of Ordinances that have not been so certified are for information only.
- 7. Assuming an Ordinance is authenticated and uploaded to the Database after its launch in 2015 and the Ordinance is subsequently amended in 2018, the Database will contain an authenticated current version as at 2018 and an authenticated past version in 2015. We would accumulate authenticated past versions of an Ordinance from 2015 onwards in the Database, which will not be removed.
- 8. We would include the past versions of legislation referred to in Clause 4(1)(a) and (b) of the Bill since 1 July 1997 in the Database for information.

Examples of special commencement arrangements

9. Annex 2 is a set of examples with special commencement arrangements. Both the Dutiable Commodities (Amendment) Ordinance 2009 and the Public Revenue Protection Order 2009 came into operation at 11 a.m. on 25 February 2009. We have to be flexible in respect of the system design to include both date and time so as to cater for special commencement arrangements.

Clause 17 revision powers

10. Annex 3 contains examples of the exercise of Clause 17 revision powers under the existing legislation. The legislative intent of Clause 17(e) is to make alteration to the text to reflect the change of the name, title, location or address of a department, office, officer or place. It enables a textual amendment to the text of the laws to reflect a change that has been effected and is not for the purpose of effecting the change of powers of a department or office.

Explanatory Note

Section 4D of the Official Languages Ordinance (Cap. 5) empowers the Secretary for Justice to make formal alterations to the text of an Ordinance in one official language to achieve consistency between a word, expression or phrase with another word, expression or phrase where both such words, expressions or phrases purport to be the equivalent of the same word, expression or phrase in the other official language in the same context. The Secretary for Justice has authorized the Law Draftsman pursuant to section 7 of the Legal Officers Ordinance (Cap. 87) to make such formal alterations.

11. Completion of works, and restoration of road

When the company has opened or broken up any portion of any road, it shall be under the following further obligations, namely—

- (a) it shall, with all convenient speed, complete the work on account of which it opened or broke up the same, and (subject to the formation, maintenance, renewal or alteration of, addition to, or removal of the tramway) fill in the ground and make good the surface and, to the satisfaction of the Director, restore the road to a good condition;
- (b) it shall in the meantime cause the place where the road is opened or broken up to be fenced and watched, and to be properly lighted at night.
- If the company fails to comply with any of the provisions of this section it shall (without prejudice to the enforcement of specific performance of the requirements of this Ordinance or to any other remedy against it) be liable to a fine of \$1,000, and in case of a continuing offence to a further fine of \$250 for every day after the first on which the default continues. (Amended 30 of 1911 s. 10; 5 of 1924 s. 13 & Schedule; 33 of 1939 Schedule; 48 of 1962 s. 5)

12. Further provisions as to construction of tramway

In addition to the requirements of section 10, the company shall, when it gives notice as aforesaid to the Director of its intention to open or break up any road for any of the purposes aforesaid, lay before the Director, if so required by him, a cross section showing the proposed mode of constructing, laying down, maintaining, renewing, altering, adding to or removing the tramway or works in respect of which it proposes to open or break up such road, and a statement of the materials intended to be used therein; and the company shall not commence the construction, laying down, maintenance, renewal, alteration of, addition to or removal of such tramway or works, or any part thereof respectively, except for the purpose of necessary repairs, until the required cross section and statement, if any, have been approved by the Director; and the work shall be executed under the superintendence and to the satisfaction of the Director, and where there are an approved cross section and statement in accordance therewith.

PART I

SHORT TITLE AND INTERPRETATION

1. Short title

This Ordinance may be cited as the Bankruptcy Ordinance.

2. Interpretation

In this Ordinance, unless the context otherwise requires—

- "affidavit" (誓章) includes statutory declaration, affirmation and attestation on honour;
- "bailiff" (執達主任) includes any officer charged with the execution of a writ or other process;
- "bankruptcy debt" (破產債項), in relation to a bankrupt, means—
 - (a) any debt or liability to which he is subject at the commencement of the bankruptcy; and
 - (b) any debt or liability to which he may become subject after the commencement of the bankruptcy (including after his discharge from bankruptcy) by reason of any obligation incurred before the commencement of the bankruptcy; (Added 76 of 1996 s. 2)
- "court" (法院、法庭) means the Court of First Instance sitting in its bankruptcy jurisdiction; (Amended 92 of 1975 s. 59; 25 of 1998 s. 2)

Schedule 3 to the Education Ordinance (Cap. 279) ("the Ordinance") contains a list of specified schools.

- 2. Under section 40AC of the Ordinance, a school shall not be specified in Schedule 3 to the Ordinance unless—
 - (a) the school is a primary school or secondary school;
 - (b) the school is neither an aided school nor a school which has joined the Direct Subsidy Scheme;
 - (c) the school is a school without incorporated management committee;
 - (d) the school is not operated for the purpose of making profit;
 - (e) the sponsoring body of the school is not a profit-making organization;
 - (f) the school receives any subsidy from the Government; and
 - (g) the school is, in the opinion of the Permanent Secretary for Education and Manpower, financially sound.
- 3. The Ordinance allows a specified school to establish an incorporated management committee in accordance with sections 40BJ to 40BN of the Ordinance.
- 4. This Notice amends Schedule 3 to the Ordinance—
 - (a) to delete 3 schools from that Schedule;
 - (b) to update the English name of one school set out in that Schedule;
 - (c) to update the addresses of 2 schools set out in that Schedule; and
 - (d) to add 2 schools to that Schedule.
