#### I. **Confirmation of minutes**

[LC Paper Nos. CB(2)1118/10-11 and CB(2)1381/10-11]

The two sets of minutes of the meetings held on 18 January and 9 February 2011 were confirmed.

# II. Meeting with The University of Hong Kong and the Administration

[LC Paper Nos. CB(2)1746/10-11(01) to (03)]

- 2. <u>The Chairman</u> informed the meeting that Dr David LI, Member in charge of the Bill, was out of town and could not attend the meeting.
- 3. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).
- 4. <u>Members</u> noted the joint letter dated 9 May 2011 from the Academic Staff Association of The University of Hong Kong and the University of Hong Kong Employees Union [LC Paper No. CB(2)1746/10-11(03)] indicating their support in principle for the Bill, on the understanding that The University of Hong Kong ("HKU") would consider granting certain rights currently enjoyed by "Teachers" (such as membership of Faculty Board and Board of Examiners, rights to nominate and vote for Department Headship/Faculty Board Chairmanship/Senate members) to academic-related staff when they were given the new Lecturer I/II/III titles.

# <u>Legislative intent of having five Legislative Council ("LegCo") Members in</u> the Court of HKU

- 5. In response to members' request made at the last meeting, <u>Professor Johannes CHAN</u>, Dean of Faculty of Law, briefed members on the background to and the legislative intent of the provision in the University of Hong Kong Ordinance (Cap. 1053) for having five LegCo Members in the Court as detailed in HKU's paper [LC Paper No. CB(2)1746/10-11(02)].
- 6. Professor Johannes CHAN elaborated that in 1953, Sir Ivor Jennings and Dr D W Logan were invited to review the constitution, function and financial requirements of the University. The Court of HKU at the time enjoyed wide powers, including the power to veto decisions made by the Council and the Senate, conferring honorary degrees, establishing teaching positions, formulating teaching and research directions, and setting up scholarships. All Executive and LegCo Members and various Government officials were then ex-officio members of the Court.
- 7. <u>Professor Johannes CHAN</u> further said that Sir Ivor Jennings and Dr Logan concluded from the review that changes should be made to the powers and composition of the Court with a view to conferring the University with a greater degree of autonomy. Subsequent to the review, the University Bill was presented to LegCo in 1958 with one of its main objects being the conferment upon the University greater autonomy in the

management of its affairs. Major changes were made to the composition of the HKU Court including, inter alia, the provision of the present membership category of five members from LegCo. Also the powers of the Court had been reduced whereas those of the Council and the Senate had been increased. The Council had since then exercised its increased powers while the Court had continued to undertake its role in recommending Ordinance and Statutory instruments and the approving of the University's annual accounts, etc. The fundamental functions of the Court and Council of HKU had not been changed since 1958.

8. Responding to members' enquiry raised at the previous meeting, <u>Assistant Legal Adviser 1</u> confirmed that any change to the composition of the Court and Council of HKU necessitated amendments to Statutes XV and XVIII respectively.

#### LegCo representation in the Council of HKU

- 9. Mr LEE Cheuk-yan said that LegCo Members, as representatives of the public, should be represented in the governing body of HKU. LegCo Members sitting on the governing bodies of universities would not interfere with the autonomy of the universities. Having regard to HKU's reservations about putting in place a mechanism in law to institutionalize LegCo Members' participation in its Council, Mr LEE suggested that HKU should consider establishing a convention of appointing LegCo Members to its Council and giving an undertaking in this regard. In his view, HKU should appoint two LegCo Members elected from among themselves to its Council as this could ensure a balanced participation of Members belonging to the pro-establishment camp and pan democratic camp.
- Mr CHEUNG Man-kwong shared the view that HKU should 10. consider establishing a convention of appointing LegCo Members to its Council. He trusted that HKU would follow such a convention after it had In his view, it would be beneficial to have LegCo been established. Members sitting on the Council of HKU as they could reflect the views of members of the public to the Council of HKU. He stressed that LegCo Members sitting on the governing bodies of universities had not and would not interfere with the management of the affairs of the universities. Mr CHEUNG further said that since HKU sought to change the role description of its Council as the supreme governing body of the University, it should uphold the original intent of having the representation of LegCo in its governing body. In his view, the number of LegCo Members to be appointed to the Council of HKU could be further discussed. He shared the view that HKU should give an undertaking on the appointment of LegCo Members to its Council.

- 11. Mr James TO said that he had no strong view on whether there should be one or two LegCo Members sitting on the Council of HKU. However, he considered it necessary to have an assurance from HKU that there would be LegCo representation in its Council. In his view, it would be acceptable for HKU to make an open statement that it attached great importance to the appointment of LegCo Members to its Council. He indicated that he would object to the passage of the Bill should HKU fail to give any undertaking in this regard.
- 12. <u>The Chairman</u> said that the undertaking could be conveyed by Dr David LI during the resumption of the Second Reading debate on the Bill.
- 13. In response to the views of members, Professor TSUI Lap-chee, Vice Chancellor and President, said that the Council of HKU had discussed the issue of LegCo representation at three of its meetings. The Council did not object to having LegCo Members appointed to the Council in their personal capacities. There was no membership category for any constituencies and all members served the Council as trustees on an ad personam basis. The Council of HKU firmly upheld the principle of trusteeship and considered it inappropriate to add a membership category for a single body. Members could participate in the Council of HKU through the existing mechanism under several membership categories as set out in HKU's paper (LC Paper No. CB(2)945/10-11(02)) for the previous meeting. Indeed, the Chairman of the Council had indicated that he would actively consider appointing one LegCo Member in his/her personal capacity to the Council when dealing with membership appointments in future. HKU would need time to establish such a convention. He was not in a position to give any undertaking as requested by members at the meeting but undertook to relay members' views to the Council of HKU.
- 14. Mr Henry WAI, Registrar of HKU, supplemented that during the meetings of HKU's Council, the discussion had focused on the appointment of one LegCo Member to sit on the Council in his/her personal capacity through the existing mechanism when a vacancy arose. There was no discussion on the appointment of two LegCo Members elected from among themselves to the Council of HKU.
- 15. <u>Professor Roland CHIN</u>, Deputy Vice-Chancellor and Provost, said that only The Chinese University of Hong Kong had statutory provision for the election of LegCo Members to its Council. Of the remaining seven University Grants Committee-funded institutions, only the Hong Kong University of Science and Technology and the Hong Kong Polytechnic University had LegCo Members appointed in their personal capacity to the Councils of these Universities at present.

16. The Chairman said that LegCo Members had all along been appointed in their personal capacities to governing bodies of universities. She requested HKU to provide a written response to the proposal of appointing LegCo Members elected from among themselves to the Council of HKU and confirm whether HKU would consider giving an undertaking to establish a convention of appointing LegCo Members to the Council of HKU.

#### Clause-by-clause examination of the Bill

- 17. <u>The Bills Committee</u> completed the clause-by-clause examination of the Bill.
- 18. <u>The Bills Committee</u> agreed to the following Committee Stage amendments ("CSAs") to the Bill proposed by HKU -
  - (a) replacing the expression "protection on termination" in clause 5(1) of the English text of the Bill with "protection against termination"; and
  - (b) inserting "and the status of a teacher" before "after the commencement of this Ordinance ..." in clause 5(2) of the Bill.
- 19. <u>The Chairman</u> requested HKU to provide a complete set of the draft CSAs for the Bills Committee's consideration.

#### Date of next meeting

20. <u>Members</u> agreed that the fifth meeting would be held on Thursday, 9 June 2011, at 4:30 pm.
