Matters Concerning Voter Registration

In response to Members' requests for statistics concerning voter registration (VR) at the meeting on 25 January 2011, this paper provides the relevant information.

Electors of Functional Constituencies in 2010

2. The number of electors registered in the 2010 final register (FR) for functional constituencies (FCs) is at **Annex**.

VR of Elected District Council Members in 2008

3. The number of elected District Council (DC) members who were registered in FCs other than the DC FC in the 2008 Legislative Council (LegCo) election is as follows:
