Committee Stage Amendments to the Electorate of Functional Constituencies under the 2010 Legislative Council (Amendment) Bill

Introduction

The Government proposes to amend the electorate of certain functional constituencies ("FCs"). This paper sets out the proposals to be included in the committee stage amendments ("CSAs").

Method for forming the LegCo in 2012

2. At present, we have 28 FCs and 225 600 registered electors on the final register of electors for 2010. According to the Legislative Council (Amendment) Bill 2010, during the 2012 Legislative Council (LegCo") election, the five seats in the new District Council FC would be returned by around 3.2 million registered electors on a one-person-one-vote basis. This will greatly enhance the democratic elements of the LegCo election. Regarding the traditional FCs, our general policy position is that there should be no substantial changes. However, as a regular exercise before each LegCo election, we will review whether there is a need to propose adjustments to the electorate of the traditional FCs to reflect the latest development of these FCs. Since the enactment of the Legislative Council (Amendment) Ordinance 2003, we have received applications from more than 100 bodies asking to join the FCs (Annex A).

Proposed adjustment to the electorate of the traditional FCs

3. Having considered the relevant applications submitted by these bodies, we propose to adjust the electorate of the Transport FC, Wholesale and Retail FC and the Information Technology ("IT") FC.

Transport FC

- For the Transport FC, there are currently 178 registered electors in the 2010 final register. The composition of the FC is at There are views that the electorate of this FC cannot reflect the latest development of the industry and the LegCo Member representing this FC has urged the Administration to consider expanding the electorate on many occasions. Taking into account the development of the industry in recent years, the existing electorate and the applications from individual associations or companies, we propose to add 28 corporate electors at Annex C into this FC. The corporate electors proposed to be added include franchisees and licensees of the Airport Authority Hong Kong, land transport service providers such as taxi associations and company, non-franchised bus associations, car park companies, company managing tunnel, cross-boundary bus association, driving training bodies, logistics association and vehicle maintenance association.
- 5. Air transport has been playing an increasingly important role Last year, the Hong Kong International Airport in Hong Kong. handled over 4 million tonnes of cargoes and over 50 million The essential operation of the Hong Kong International the services provided Airport depends by on bodies/companies. However, majority of the bodies/companies which provide services essential to the operation of the Hong Kong International Airport have not been included in the Transport FC¹. In view of their contribution to the air transport of Hong Kong, the Government considers that they should be included in the Transport FC. It is recommended that ten franchisees and licensees of the Airport Authority Hong Kong are to be included in this FC (Annex C).
- 6. For the taxi trade, over 30 taxi associations/companies are currently included in the Transport FC. In considering the inclusion of other taxi associations/companies in this FC, we have taken into account the representativeness, the level of participation in the sector, the membership/fleet size and the scale of operation of the applicants. Our considerations include whether the association/company has joined one of the Transport Department Taxi Conferences and the number of

drivers/taxis it encompasses. It is recommended that three taxi associations and one taxi company are to be included in this FC (Annex C).

- Association is representing the sector in the FC. In considering whether other associations representing non-franchised buses are to be included in this FC, we have taken into account the representativeness, the level of participation in the sector, the membership size and the scale of operation of the applicants. Our considerations include whether the applicants have joined the Transport Department's Public Bus Operators Conference and the fleet size of the members of the applicants. It is recommended that five non-franchised buses associations are to be included in this FC (Annex C).
- 8. For car park companies, seven companies are currently included in the Transport FC. In considering the applications from other car park companies for joining this FC, we have taken into account the scale of operation of the applicants, including the number of car parks under their management. It is recommended that two car park companies are to be included in this FC (Annex C). These two companies manage 50 to 100 car parks.
- 9. For companies managing tunnels, we propose to include Greater Lucky (HK) Company Limited, which is maintaining, operating and managing the Shing Mun Tunnel and Tseung Kwan O Tunnel, into the Transport FC. As a result of this amendment, all companies which manage tunnels in Hong Kong will be included in this FC.
- 10. For cross-boundary bus associations, one is currently included Transport FC. In considering the inclusion of other companies/associations, we have taken into account the representativeness, the level of participation in the sector, membership size and the scale of operation. Our considerations include whether the association has joined the Transport Department's Meeting with the Cross-Boundary Coach Associations and the fleet size of the members of the association. It is recommended that the China Hongkong and Macau Boundary Crossing Bus Association is to be included in this FC.

- 11. The driving training industry has two sectors, namely private driving instructors and driving schools. With regard to the associations of private driving instructors, there are currently 11 such associations that maintain close liaison with the Transport Department on matters related to driving training. Majority of them have been included in the Transport FC. The Driving Instructors Association is a private driving instruction association which has not been included in the Transport FC. It has submitted an application and it is recommended that the Association is to be included in this FC.
- 12. Two designated driving schools are currently included in the Transport FC. They are either driving school or driving improvement school designated by the Transport Department. Two other driving school or driving improvement school designated by the Transport Department have submitted applications for inclusion in the FC. We propose to include them in this FC (Annex C).
- 13. In respect of logistics associations, an application has been submitted by the Chamber of Hong Kong Logistics Industry for inclusion into this FC. With over 400 individual and corporate members, the Chamber is representative in the industry and is also a member of the Hong Kong Logistics Development Council. It is recommended that the Chamber is to be included in this FC.
- 14. Two vehicle maintenance associations are currently included in the Transport FC. An application for inclusion in this FC has been received from the Service Managers Association ("SMA"). Members of the SMA are large automobile servicing companies, some of which have joined the Vehicle Maintenance Technical Advisory Committee under the Electrical and Mechanical Services Department. It is recommended that the SMA is to be included in this FC.

Wholesale and Retail FC

15. Regarding the Wholesale and Retail FC, there are 5 959 registered electors in the 2010 final register. The composition of this FC is at Annex D. In recent years, the wholesale and retail sector has been become increasingly important. While the existing wholesale and retail FC already covers associations or companies of various businesses (including some Chinese herbal medicine associations),

some associations for retailers and wholesalers in the Chinese medicine sector which are representative and sizeable are not yet included. In view of the recent development of the Chinese medicine sector in Hong Kong, we propose to include three associations which are more sizeable and representative in the sector so that their eligible members can be registered as electors. These include:

- (a) Hong Kong Chinese Prepared Medicine Traders Association Limited – with over 100 member companies covering nearly 8 000 products;
- (b) Hong Kong Chinese Medicine Industry Association Limited with over 100 members, including retailers and wholesalers of Chinese herbs and Chinese patent medicine manufacturers; and
- (c) Hong Kong Chinese Patent Medicine Manufacturers' Association Ltd. with about 100 members engaged in the wholesaling and distribution of locally manufactured Chinese patent medicine and healthcare products in Hong Kong, the Mainland and overseas.

The above proposal will add around 300 eligible electors into the Wholesale and Retail FC.

Information Technology FC

- 16. For the IT FC, there are 5 749 registered individual and corporate electors in the 2010 final register. The electorate of this FC includes representative bodies from the industry and members of professional bodies. The composition of the IT FC is set out in <u>Annex</u> E.
- 17. The IT sector has been growing rapidly in Hong Kong. According to the World Economic Forum's Networked Readiness Index 2008/09, Hong Kong is among the world's top 15 economies in terms of readiness to participate in and benefit from IT development.
- 18. We have received an application from the Hong Kong Information Technology Joint Council Limited ("ITJC") for inclusion in the IT FC. Members of the ITJC are mainly incumbent and former

presidents and vice-presidents of various professional bodies in the IT sector of Hong Kong. The ITJC aims to provide professional advice on IT issues and policy to the Government and different sectors of the community and to establish the professional position of IT practitioners. It has been actively involved in promoting the development of the sector in the Mainland. Apart from signing co-operation framework agreements with the software industry associations in Guangdong, Shenzhen and Zhuhai, the ITJC has invited representatives from 39 mainland software parks to take part in its "Hong Kong Forum on Technology and Economy". It has also conducted a recent study on the "Role of Hong Kong under the Twelfth National Five Year Strategic Plan" with the support from the Office of the Government Chief Information Officer.

19. In view of the ITJC's involvement in promoting the IT sector and its representativeness, we propose to include members of the ITJC who are entitled to vote at its general meetings as eligible electors. This will add about 100 eligible electors to the IT FC.

Other Amendments

20. The Registration and Electoral Office has recently received requests from certain bodies which are registered as electors in FCs to update their names. We will move CSAs to update the names of the following:

Information Technology FC

(i) Hong Kong Information Technology Federation renamed as Hong Kong Information Technology Federation Limited

Wholesale and Retail FC

(ii) Chinese Merchants (H.K.) Association renamed as Chinese Merchants (H.K.) Association Limited

Education FC

(iii) Hong Chi Association - Hong Chi Pinehill Youth Advanced Centre renamed as Hong Chi Association - Hong Chi Pinehill Integrated Vocational Training Centre

Sports, Performing Arts, Culture and Publication FC

- (iv) Hong Kong Swimming Teachers' Association renamed as Hong Kong Swimming Teachers' Association <u>Limited</u>
- 21. In addition, section 20Z(1)(ii) of the Legislative Council specifies that bodies that are holders Non-exclusive Telecommunications Service ("PNETS") licences are eligible to be registered as electors for the IT FC. PNETS licences were introduced in 1980s to regulate the serviced-based public telecommunications services ². To streamline the licensing regime for service-based telecommunications the public services. Telecommunications Authority ("TA") decided in October 2009 to create a new "Class 3 Service" under the Services-Based Operator ("SBO") licence to replace the PNETS licence. With effect from 30 October 2009, the TA has ceased to issue or renew any PNETS licence. Such licences should be replaced by the SBO licences (Class 3 Service) upon expiry if the licence holders wish to continue operation of the services. In view of this arrangement, all PNETS licences will be replaced by SBO licences (Class 3 Service) by the end of April 2011. At present, a total of 527 SBO licences (Class 3 Service) have been issued. Therefore, we will propose a CSA to amend Section 20Z(1)(ii) to replace PNETS licences by SBO licences (Class 3 Service).

Advice sought

- 22. The draft of the proposed CSAs to the Bill is at Annex F.
- 23. Members' views are sought on the above proposals and the draft proposed CSAs at Annex F.
