## **Committee on Members' Interests**

### **Outcome of further consultation with Members on the handling of anonymous complaints and allegations reported by the media against individual Members**

#### **Purpose**

This paper invites the Committee on Members' Interests ("CMI") to note the outcome of the further consultation with Members on the handling of anonymous complaints and allegations in media reports against individual Members.

#### **Background**

2. Under the Rules of Procedure ("RoP"), CMI is responsible for, among other things, consideration and investigation of complaints made in relation to the registration and declaration of Members' interests as well as complaints concerning Members' claims for operating expenses ("OER claims") or applications for advance of operating funds ("AOF applications") (Rule 73(1)(c) and (ca) of RoP).

3. Since the First Legislative Council ("LegCo"), CMI has adopted the practice that it will not deal with anonymous complaints on the ground that there is no one to come forward to provide evidence. Such complaints are circulated to members for information and any member may decide to take over the complaint and lodge the complaint in his own name if he considers that the complaint contains substantiated information. However, the member who lodges the complaint may not participate, as a member, in the handling of the complaint. In relation to allegations made in media reports, as Rule 73(1)(c) and (ca) of RoP does not empower CMI to act without complaints, CMI may not on its own initiative investigate these allegations unless a specific complaint relating to the allegations is received.

4. Members of the current CMI are of the view that LegCo Members should be answerable to the public on matters of conflict of interests and use of public funds for the performance of their duties. As anonymous complaints may contain serious allegations, some members consider it unsatisfactory for CMI not to take further action on a complaint solely on the ground that the complainant cannot be contacted and identified. Some members consider that if a certain number of members are of the view that an anonymous complaint is of a serious nature and worth pursuing, CMI should act on the complaint and the Clerk to CMI, upon the advice of the Chairman, should make initial enquiries. The findings should then be presented to CMI to decide whether a detailed investigation should be conducted. Some CMI members are of the view that notwithstanding the preliminary enquiries conducted by the Clerk, if no person comes forward to be the complainant, CMI should not consider the complaint further even if a prima facie case has been established as a result of the initial enquiries. Some CMI members also consider that allegations in media reports should be handled in the same manner as anonymous complaints. At its meeting on 21 April 2009, CMI agreed that all Members should be consulted on the above views.

5. A consultation exercise was conducted in June 2009, with 59 Members responding to the questionnaire. The findings in this consultation indicated that the majority of Members did not consider it appropriate for CMI to deal with anonymous complaints and allegations in media reports. However, close to half of all Members were in support of requesting the Secretariat to conduct initial enquiries about anonymous complaints, including contacting the Member concerned for clarification, if a certain number of CMI members had given consent. In addition, some 40% of all Members were of the view that CMI should pursue a complaint further if a prima facie case had been established.

6. When CMI reviewed the findings at its meeting on 16 December 2009, it noted that while Members were strongly against investigating anonymous complaints and allegations made in media reports, Members also found the present arrangement of not dealing with anonymous complaints not entirely satisfactory. It was also noted that half of the Members expressed support for the Secretariat, being a neutral party, to

conduct initial enquiries to help dispel unnecessary misunderstanding about Members and dispose of frivolous or groundless complaints which are made anonymously. As the opinions of Members were divided, CMI decided to consolidate the views of members into a proposal and consult Members further on the arrangements.

## **Second round of consultation**

7. In the second round of consultation conducted in March 2010, Members were asked to give their views on whether anonymous complaints should be dealt with according to the following arrangement:

- (a) the Secretariat will conduct initial enquiries if five or more CMI members have given consent to it;
- (b) during initial enquiries, the Member under complaint or subject of the allegation may be contacted for clarifications or explanations;
- (c) upon completion of initial enquiries, the Secretariat will submit its findings to CMI; and
- (d) CMI will not take further action unless a pertinent non-anonymous complaint is received or a Member lodges the complaint in his own name to CMI.

8. Members were also asked to give their views on whether RoP should be amended to empower CMI to deal with allegations in media reports and whether such allegations should be dealt with in the same manner as anonymous complaints.

## Findings and analysis of consultation

9. With the exception of the President and two other Members, namely Dr Hon Margaret NG and Hon Audrey EU, all the other 52 Members<sup>1</sup> responded to the questionnaire. Dr NG and Ms EU indicated

<sup>1</sup> During the consultation period, there were only 55 Members, as five Members, namely, Hon Alan LEONG, Hon LEUNG Kwok-hung, Hon Tanya CHAN, Hon Albert CHAN and Hon WONG Yuk-man, resigned from their office as LegCo Members on 28 January 2010, and were not re-elected

that the principles and mechanisms for dealing with such complaints or allegations must be discussed in detail and should not be established through the asking of a few questions. A summary of the responses of the 52 Members are given in **Appendices I and II**.

10. According to the findings, about 70% of Members are of the view that CMI should not handle anonymous complaints according to the arrangements set out in paragraph 7 above, while about 80% of Members consider that CMI should not deal with allegations in the media against Members and CMI's terms of reference provided in Rule 73 of RoP should not be amended to empower CMI to do so.

11. Compared to the findings of the first round of consultation, 15% more Members<sup>2</sup> consider that CMI should not handle anonymous complaints in the second round of consultation. Furthermore, while over 50% of Members indicated in the first round of consultation that they were open to the suggestion that the Secretariat should conduct initial enquiries about the anonymous complaints received if there is a majority of members of CMI giving consent to it, only 13% of Members agree to such an arrangement in the second round of consultation. Some Members have explained to the Secretariat that they no longer support the proposed arrangement set out in the second questionnaire because they are concerned that the arrangement may be abused.

12. Comparing the two rounds of consultation, it is also noted that the number of Members who are opposed to the handling of allegations reported by the media has increased from 37 (about 60% of Members) to 46 (about 80% of Members).

13. The findings of the further consultation clearly indicate that the majority of Members do not support CMI changing the practice adopted since the First LegCo of not considering anonymous complaints, although

<sup>2</sup> Sixteen out of the 24 Members who agreed in the first round of consultation that CMI should consider anonymous complaints consider that CMI should not handle such complaints in the second round of consultation. On the other hand, out of the 34 Members who agreed in the first round of consultation that CMI should not consider anonymous complaints, three have changed their stance and four have not responded to the questionnaire in the second round of consultation. As a result, nine (15%) more Members consider that CMI should not handle anonymous complaints in the second round of consultation.

it may do so under its existing terms of reference. The majority of Members also do not support empowering CMI to consider allegations against Members made in media reports. It seems that most Members remain concerned that considering a complaint or an allegation without a complainant coming forward is unfair to the Member under complaint and the arrangement for considering such complaints or allegations may be abused.

### **Advice sought**

14. Members are invited to note the outcome of the further consultation.

**Question 1:**

Whether CMI should handle anonymous complaints against individual Members by the following arrangements?

The Secretariat conducts initial enquiries on an anonymous complaint if five or more CMI members consent to it. During the initial enquiries, the Member under complaint may be contacted for clarifications or explanations. Upon completion of the initial enquiries, the Secretariat submits its findings to CMI. CMI will not take further action on an anonymous complaint unless a pertinent non-anonymous complaint is received or a Member takes over it and lodge a complaint to CMI.

<sup>7</sup> Hon Timothy FOK considers that CMI should not handle allegations reported by the media. This may prevent someone from making use of the media to attack Members. Moreover, in order to produce timely reports, the media tend to publish reports before their contents are verified. In case it is uncovered afterwards that the content of the reports is not true, they will clarify it gradually. As a result, unnecessary harm may be caused to the persons concerned.
