Legal Service Division Report on Supplementary Appropriation (2010-2011) Bill

I. SUMMARY

1. Object of the Bill

To provide for a supplementary appropriation of \$9,638,365,995.02 for the services of the Government in the financial year that ended on 31 March 2011 in addition to the sum appropriated by the Appropriation Ordinance 2010 (8 of 2010).

2. Comments

The Bill is introduced in accordance with the Public Finance Ordinance (Cap. 2) to provide for supplementary appropriation for the specified heads of expenditure approved by the Finance Committee or under the powers delegated by it in the financial year that ended on 31 March 2011. The 16 heads in which there was excess of expenditure over the original appropriation and the amount of excess under each head are specified in the Schedule to the Bill.

II. REPORT

Object of the Bill

To provide for the appropriation of \$9,638,365,995.02 for the services of the Government in the financial year that ended on 31 March 2011 in addition to the sum appropriated by the Appropriation Ordinance 2010 (8 of 2010).

Comments

- 4. The Appropriation Ordinance 2010 (the Ordinance) was enacted in April 2010 to provide for the appropriation of \$285,599,001,000 from the general revenue for the services of the Government in the financial year from 1 April 2010 to 31 March 2011 under section 6 of the Public Finance Ordinance (Cap. 2) (PFO). Upon enactment of the Ordinance, the estimates of expenditure for the 2010-2011 financial year are deemed to be approved to the extent that they are provided for in the Ordinance and shall have effect from the first day of the financial year (section 6(2) of PFO).
- 5. During the 2010-2011 financial year, the Government has made changes to the approved estimates of expenditure with the approval of the Finance Committee or under the powers delegated by it in accordance with section 8 of PFO. Section 9 of PFO requires that if at the close of account for a financial year it is found that expenditure charged to any head is in excess of the sum appropriated for that head by the Appropriation Ordinance for that financial year, the excess shall be included in a Supplementary Appropriation Bill which shall be introduced into the Legislative Council as soon as practicable after the close of that financial year.
- 6. This Bill is introduced in accordance with section 9 of PFO to seek final legislative authority for the supplementary appropriation under the

specified heads of expenditure in the 2010-2011 financial year. The 16 heads in which there was excess of expenditure over the original appropriation and the amount of excess under each head are specified in the Schedule to the Bill.

According to paragraph 3 of the LegCo Brief, the supplementary provisions for the specified heads of expenditure were mainly appropriated for meeting additional expenses for the 2010 civil service pay adjustment, injecting funds into the Arts and Sports Development Fund and the Beat Drugs Fund, implementing the Fifth Matching Grant Scheme and paying two months' rent for occupants of rental units of the Hong Kong Housing Authority and the Hong Kong Housing Society. Members may wish to refer to Annex B of the LegCo Brief for major reasons for the supplementary appropriation under each of the specified heads.
