SECTION 1 MEETING INFORMATION

1. Date and Venue of the Meeting

The APA International Conference on Principles of Friendship and Cooperation in Asia will take place in the **Sunan Hotel, Solo (Surakarta), Central Java - Indonesia** from **Wednesday, 28 September to Thursday, 29 September 2011.**

2. Official Language

The official languages of the APA are English and Arabic, and its working language is English (Article 16 of APA Charter). The host will provide six booths of Simultaneous Interpreting System (SIS). Two booths will be provided for Indonesian-English and English-Arabic.

Four additional simultaneous interpretation channels (booths) will be provided upon request on *the first come first served basis*. Delegations who have requested for simultaneous interpretation facilities are responsible for their own interpreters.

3. Document

All official documents shall be in English. In addition, any delegate who wishes to distribute documents in the meeting is advised to have a prior consultation with the APA Permanent Secretariat.

4. Registration

The participants are kindly requested to send the registration form provided by the host before **28 August 2011** to the following two addresses:

5. Security and Identification Badges

Identification Badges will be provided by APA Host Secretariat and distributed upon registration. For security purposes, all participants will be requested to wear their identification badges throughout the meeting and official function specified in the Working Program.

6. Passport and Visa Regulations

All delegates and accompanying persons must bear valid passport and are strongly advised to contact the Indonesian Embassy or Consulate prior to their departure to obtain visa to enter and stay in Indonesia. Visas may be issued on arrival in Indonesia only in cases where they cannot be obtained beforehand, or for delegates from countries in which Indonesia has no diplomatic or consular representation, provided that a copy of a valid passport and photograph are forwarded to the local authorities or to Host Secretariat prior to arrival. Visa on arrival will be paid by the delegates concerned amounting to US\$ 20.00,-.

In order to facilitate the immigration formalities, delegates are also advised to bring two 4 x 6 centimeters' size colored photographs on arrival. The passport will be assumed valid if it has six months before expiry date.

7. Arrival and Departure

The participants are kindly requested to indicate on the Registration Form the flight itinerary to enable the Host Secretariat to arrange the transportation for the delegates' arrival and departure. Any changes of the flight schedules should immediately be communicated in advance to the APA Host Secretariat, so they could perform their tasks well, effectively and efficiently. The arrival and departure service will only operate from 27 to 30 September 2011 at the Adisumarno International Airport, Surakarta-Indonesia. The host Secretariat will assist the delegates through all formalities at their arrival and departure. According to the national regulations, any person at their departure will pay Rp 150.000,- (one hundred and fifty thousand rupiahs) for airport tax. The airport tax shall be at the delegate's own expense.

8. Currency Exchange

There is no restriction on currency exchange. Although Indonesian banks and money changers deal in almost all currencies, it is advisable to bring notes or traveler's cheques in the major currencies.

The currency in Indonesia is Rupiah (Rp), which consist of notes (1,000; 5,000; 10,000; 20,000; 50,000; 100,000) and coins (100; 200; 500 and 1000). The exchange rate in October 2010 is approximately Rp. 9,100 per US\$ 1.

All major credit cards (Visa, Master Card, American Express, Diners) are widely accepted.

9. Electricity

Electrical power in Indonesia is at 220-230 volts (50 hertz). Plugs are of the European two-pronged variety.

SECTION 2 HOSPITALITY

1. Accommodation

The host parliament will only cover accommodation (standard room, including breakfast) for 2 (two) official delegates from each of APA Member Parliaments attending the APA Conference from Tuesday, 27 September 2011 until Thursday, 29 September 2011 (3 nights).

Delegates who check-in earlier before 27 September 2011 and check-out late after 30 September 2011 shall be at their own expenses.

Delegates wishing to upgrade their hotel's rooms and book more than 2 (two) rooms for additional delegates are kindly advised to inform the APA Host Secretariat in advance. Any

additional charges such as room service, alcoholic beverages, mini-bar items, laundry, telephone calls (local or overseas) will be also at the delegates' own expenses. The additional cost charged for this purpose will be at the delegate's own expenses and the reservation should be guaranteed by credit card and or deposit amounting to US \$ 200.00,-, at the time of check-in. Any charges to the hotel should be paid in Indonesian Currency (IDR).

Hotel's terms:

Any delegate who cannot check-in on the arrival date given (no show) will be charged 1 (one) night of the room rate. Late check-out after 2 p.m. will be charged 50 % of the room rate and late check-out after 6 p.m. will be charged 1 (one) night of the room rate.

Any delegates who need an extra bed will be charged US \$ 40,-/person, including breakfast.

2. Transportation

Local transportation will be provided by the host parliament on the arrival of delegates on 27 September 2011 and on the departure of delegates on 30 September 2011. Transportation will also be provided for all official functions during the meeting.

All changes of the departure schedules should immediately be communicated to the APA host Secretariat. Delegates are responsible for administrative airline regulations and financial aspects caused by the charges of the flights schedule, as well as their transportation other than events specified in the working program.

3. Meals and Functions

Meals will be provided for delegates at venues specified in the Working Program. Delegates wishing to make other meal arrangements will meet the cost themselves. All officially-hosted participants are cordially invited to the official functions indicated in the Working Program. Breakfast and lunch (excluding alcohol beverages) will only be provided during the meeting sessions.

4. Medical Service

First aid services will be provided in the hotel. Other medical care will be at the expense of the participants. The delegates are personally responsible for any personal insurance against risks.

SECTION 3 MEETING FACILITIES

1. Registration and Information Desk

All delegates are kindly requested to register at the registration desk upon their arrival at the Lobby Hotel. Information desk will be set up at the front desk of Ballroom I, the Sunan Hotel, from 27 to 29 September 2011 and will be open from 8 a.m. to 6 p.m.

2. APA Secretariat and Host Secretariat Room

The room of the Host Secretariat will be located at the Ballroom I A and the APA Secretariat will be located at the Ballroom I B of the Sunan Hotel. It will be open from 27 to 29 September 2011 from 8 a.m. to 6 p.m.

SECTION IV ABOUT SOLO



Surakarta, which is known as Solo City, is located in between of slope basin of Lawu Mountain and Merapi Mountain approximately 92 m above sea level (with 44 km² – width). Surakarta lies between 110 45’ 15” 110 45’ 35” east longitude and 70’36” 70’ 56” south latitude. Surakarta is divided flowed by three big rivers, Bengawan Solo, Jenes and Pepe. Bengawan Solo river was known with its gorgeous scenery and trade traffic.

Surakarta border in the north side is Karanganyar Regency and Boyolali Regency, in the east side is Sukoharjo Regency and Karanganyar Regency, while in the south side is Sukoharjo Regency. Surakarta is divided into five sub district: Banjarsari, Laweyan, Serengan, Pasar Kliwon and Jebres.

A maximum temperature in Surakarta is 32, 5 Celcius Degree and minimum temperature is 21, 9 Celcius Degree. An approximate atmospheric pressure is 1010, 9 MBS with humidity up to 75%. An atmospheric velocity is 4 knot with 240 degree. Solo is Tropical zone, while rainy and dry season appear by for 6 month in year.
