- 4. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**) and agreed that the Administration should provide a paper highlighting the following points for further deliberation at the next Subcommittee meeting:
 - (a) measures to be implemented by Buildings Department (BD) to shorten the length of processing time, in view of a likely influx of a large number of applications for registration as registered minor works contractors (RMWCs) by the end of this year. The existing length of 2 months and 6 months for individuals and companies respectively to get registered as RMWCs was not satisfactory;
 - (b) the Administration should specify the exact length of time required for an applicant to get registered as a RMWC after submission of his application;
 - (c) special consideration should be given to issuing "provisional registration" to those workers who had already applied for registration as RMWCs and were waiting for the outcome to continue with their work after 31 December 2010;
 - (d) in view of the small number of applications received so far, effective promotion and publicity measures should be implemented to motivate more minor works practitioners to register as RMWCs. BD should collaborate with the trade unions of the sector to devise tactics to promote the Minor Works Control System (MWCS) so as to boost the number of applications. If possible, prospective applicants should be given some training on completion of forms and be briefed on the list of papers/documents that should be brought by them for registration;
 - (e) as far as application for registration was concerned, BD was requested to consider whether a higher priority could be given to those applicants who had already signed building minor works contracts but had yet not commenced works;
 - (f) measures should be implemented to facilitate those workers who wished to be registered as RMWCs to get registered within reasonable time, such as there should be adequate number of training courses for workers to attend; and

- (g) as a last resort, consideration should be given to postpone the commencement date of full implementation of MWCS on 31 December 2010 to a later date.
- 5. <u>The Subcommittee</u> agreed that the Chairman should move a motion at the Council meeting on 10 November 2010 to extend the scrutiny period of the subsidiary legislation to 1 December 2010. <u>The Subcommittee</u> did not consider it necessary to invite deputations to express their views on the Commencement Notices.
