Follow-up actions required to be taken by the Administration

- 3. <u>The Subcommittee</u> requested the Administration to provide written responses to the following views/concerns expressed at the meeting:
  - (a) in respect of the Black Point Power Station, Castle Peak Power Station, Lamma Power Station and Lamma Power Station Extension, and Penny's Bay Gas Turbine Power Station,
    - (i) the allocation of emission allowances for each of the power stations in 2010;
    - (ii) the actual emission levels of each of the power stations from

### January to September 2010; and

- (iii) the method for ascertaining the quantity of emission allowance as set out in the Second Technical Memorandum (TM) for each of the power stations.
- (b) the estimated percentage of contribution in achieving the emission reduction targets under the Second TM by
  - (i) energy conservation having regard to the forecast Gross Domestic Product from 2011 to 2015;
  - (ii) maximizing the use of existing gas-fired generation units; and
  - (iii) prioritizing the use of coal-fired generation units that have been retrofitted with emission abatement equipment.
- (c) consider amending section 2.1 of the Chinese text of the Second TM from "每種指明污染物獲配" to "每種指明污染物獲<u>分</u>配的排放限額"; and
- (d) consider conducting a review of the Second TM within two years after its coming into operation and reporting the review outcome to the Panel on Environmental Affairs accordingly.

4. <u>The Subcommittee</u> agreed to hold the next meeting on Monday, 15 November 2010 at 5:30 pm. <u>The Subcommittee</u> noted that the Chairman would move a resolution at the Council meeting on 10 November 2010 to extend the scrutiny period of the Second TM to 8 December 2010.

In theory, the Administration could conduct a review of the Second TM in 2011, and made the Third TM for it to commence on 1 January 2012 such that the emission allowances stipulated for each specified pollutant should take effect for each and every emission year from 1 January 2016. However, in view of the extensive retrofit that had been undertaken by both power companies for meeting the 2010 emission caps, the only way to further tighten meaningfully their emission allowances was to change substantially their fuel mix as envisaged in the proposed strategy for tackling climate change. The Administration was conducting a public consultation on the proposed climate change strategy. A decision on whether and, if so, how the proposed fuel mix was to be pursued would be made in the light of the outcome of the public consultation;  (b) emissions reduction requirement was previously stated as one of the conditions in the specified process licences for the power companies to follow. In February 2008, a Bill was introduced to amend the Air Pollution Control Ordinance (Cap. 311) (APCO) to, inter alia, cap the emission of the specified pollutants, and violation of which would lead to fine and imprisonment; and  (c) under the Scheme of Control Agreements (SCAs) signed between the Government and each of the two power companies in January 2008, there was an emission performance linkage mechanism whereby financial incentive or penalty would be provided to or imposed on the power companies for over- or

002441 – 010040	Chairman Administration Mr KAM Nai-wai	Section 2 - Allocation of Emission Allowances  Section 2.1  In response to the concern of Mr KAM Nai-wai, the Administration advised that —  (a) under the First TM, emission allowances to individual power plants was allocated on a pro-rata basis in accordance with their respective share of the total amount of electricity generated for local consumption. Pursuant to section 26(L) of APCO, individual specified process licence holders could arrange emissions trading among themselves to meet the emission caps; and  (b) as the Second TM allocated emission allowances directly for each power station having regard to the types of fuel used by their generation units and the availability of emission abatement equipment therein, the extent of changes in emission allowances for each power plant between the First and Second TM varied. This method would ensure the power plants to adopt the best practicable means for preventing emission of each type of pollutant. 		Addressing Mr KAM's concern that local residents in the vicinity of the Castle Peak Power Station to which additional quantity of emission allowance was transferred might have to endure more severe air pollution, the

		The Administration stressed that the Second TM had not considered the new fuel mix which was proposed for 2020 in the consultation document entitled "Hong Kong's Climate Change Strategy and Action Agenda" issued in September 2010. The proportion of nuclear energy in the fuel mix for the emission years starting from 2015 should remain to be 20% to 23%. According to the electricity demand forecast provided by the two power companies, the annual rate of increase in electricity generation from 2010 to 2015 was about 1% to 2% which was less than the Gross Domestic Product growth rate of about 4% per year as estimated by the Government Economist for the same period.	
		Ms HO requested the Administration to provide information on the estimated percentage of contribution in achieving the emission reduction targets under the Second TM by energy conversation, the use of existing gas-fired generation units and coal-fired generation units.  ALA suggested the Administration consider amending section 2.1 of the Chinese text of the Second TM from "每種指明污染物獲配的排放限額" to "每種指明污染

		In reply to the Chairman, the Administration advised that no emission allowance was allocated to the power stations for electricity generated for non-local consumption. At present, about 8% of electricity

The power company concerned had to meet the emission caps by additional emission reduction efforts, e.g., emissions trading or procuring higher quality fuel such as ultra-low sulphur coal. The Administration also acknowledged the Chairman's understanding that the section aimed at limiting the power of the Authority who should make the allocation of emission allowance in respect of electricity generation for local consumption.

The Administration explained that although it was a standing practice to review the TM not less than once every three years, the Secretary for the Environment had acceded to the request of the Subcommittee formed to study the First TM to conduct a review within two years after its coming into operation. However, as there was not much could be done to retrofit existing coal-fired generation units further and a long lead time would be required to revamp the fuel mix of the power sector, it was deemed appropriate to review the Second TM once every three years. In other words, should the review of the Second TM be conducted in 2013 the latest, the Third TM, if any, could commence operation on 1 January 2014 such that the emission allowances stipulated therein should take effect for each and every emission year from 1 January 2018.  In response to Mr KAM Nai-wai's concern about consultation with Members of the Legislative Council on the review outcome, the Administration undertook to consider including such requirement in section 2.5.
