I. Meeting with the Administration

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. <u>Hon Audrey EU</u> requested putting on record that she did not consider the two pieces of subsidiary legislation under scrutiny entirely satisfactory as the Administration had not fully addressed her concerns, including those regarding the eligibility and sufficiency of the number of approved assessors and the avenues for lodging complaints against approved assessors. However, she had no better choice than to support the two Notices so that the implementation of the special arrangement of productivity assessments for persons with disabilities would not be delayed, given the launching of the statutory minimum wage ("SMW") on 1 May 2011. Therefore, she urged the Administration to review the

productivity assessment mechanism after the implementation of the special arrangement for persons with disabilities under the Minimum Wage Ordinance (Cap. 608) and introduce improvements where necessary in the light of operational experience. She also suggested that the Panel on Manpower should follow up with the Administration on the results of the review scheduled for two years after the implementation of SMW.

- 3. At the request of the Subcommittee, the Administration undertook to -
 - (a) provide the Panel on Manpower with its administrative guidelines for approved assessors and the relevant forms contained therein, including the certificate of assessment; and
 - (b) review the special arrangement for persons with disabilities, including whether there is a need for an appeal mechanism and the impact of SMW on the employment opportunities of persons with disabilities, in the light of operational experience within two years after the implementation of SMW and report the results to the Panel on Manpower.
- 4. <u>The Chairman</u> concluded that the Subcommittee had completed its scrutiny work. <u>Members</u> noted that the Subcommittee would report its deliberations to the House Committee on 18 February 2011, and the deadline for giving notice of a motion to amend the two pieces of subsidiary legislation, if any, at the Council meeting on 2 March 2011 was 23 February 2011.
- 5. There being no other business, the meeting ended at 3:20 pm.
