I. Meeting with deputations and the Administration

The Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. <u>The Chairman</u> reminded members that under section 78B(6) of the Public Health and Municipal Services Ordinance (Cap. 132), an order made under section 78B of Cap. 132 ("the Order") was not subsidiary legislation. Accordingly, the Order was not required to be tabled before the Legislative Council ("LegCo") and was not subject to amendment by LegCo.
- 3. The Subcommittee received views from the following organizations on the impact of the Order -
 - (a) Institution of Dining Art;
 - (b) Hong Kong, Kowloon, New Territories and Overseas Fish Wholesalers Association;
 - (c) The Marine Products Association;
 - (d) Hong Kong Japanese Restaurant Association; and
 - (e) Hong Kong Imported Vegetable Wholesale Merchants Association Ltd.
- 4. The deputations hoped that the Government would provide financial assistance by way of a loan scheme or subsidy on utilities expenses to help them survive the financial difficulties caused by the Daiichi nuclear power plant incident. Some deputations requested the Government to revoke the Order.

- 5. <u>The Subcommittee</u> agreed that the views of deputations and the Subcommittee on the provision of financial assistance to the affected trades should be referred to the Panel on Commerce and Industry for follow-up.
- 6. In response to the deputations' view on revocation of the Order, the Administration advised that it would, among others, make reference to the discussions and recommendations of the International Atomic Energy Agency on the Daiichi nuclear power plant incident at its special meeting to be held in June 2011 in its consideration of whether the Order should be revoked.
- 7. At the request of the Subcommittee, <u>the Administration</u> agreed to inform LegCo of its decision to revoke the Order once it was made.

II. Any other business

- 8. <u>The Subcommittee</u> completed the discussion on the Order. The report on the deliberations of the Subcommittee would be submitted to the House Committee on 10 June 2011.
- 9. There being no other business, the meeting ended at 11:46 am.
