# LegCo Panel on Education Meeting on 8 November 2010 Supplementary Information on

Grant to support the Hong Kong Examinations and Assessment Authority for continual rental of onscreen marking centre on Hong Kong Island, and for conducting the Hong Kong Certificate of Education Examination and the Hong Kong Advanced Level Examination for private candidates in 2011 and 2013 respectively

Site/vacant premises search for the development of the Hong Kong Examinations and Assessment Authority (HKEAA) headquarters and onscreen marking centres in the past few years

### **HKEAA** Headquarters

The original long term accommodation plan for HKEAA was to re-develop the ex-North Kowloon Magistracy Building (ex-NKMB) in Sham Shui Po as the HKEAA headquarters, hence freeing up its existing offices in Southorn Centre of Wan Chai and in San Po Kong for conversion into the permanent Island and Kowloon East onscreen marking (OSM) centres. As the proposed ex-NKMB development plan could not be further pursued, the Government looked for alternative sites or vacant premises, which should satisfy the following criteria in order to meet HKEAA's operational requirements –

- a) it should be served by public transport, with convenient access for teachers, examination personnel, parents and student;
- b) it should have loading/unloading area for examination papers, equipment and material:
- c) it should have a net usable area of at least 7,800 m<sup>2</sup> for development of headquarters or about 9,000 m<sup>2</sup> if the site is in Kowloon East for the development of both headquarters and onscreen marking centre; and
- d) it should preferably be in decent condition to minimize renovation cost
- 2. The following sites/premises have been identified in the past few years but were found unsuitable –

#### Onscreen marking centres

- 3. The current Lai King and Tsuen Wan OSM centres were converted from vacant school premises in 2006. For the Hong Kong Island OSM centre, the long term plan is to convert the existing offices in Southorn Centre as the permanent centre after the establishment of HKEAA headquarters. While a temporary centre has been established by renting commercial premises since 2006, we also looked for alternative suitable premises which meet the following requirements
  - a) it should have a net usable area of about 1,500 m² for housing about 370 onscreen marking workstations and a range of associated facilities;
  - b) it should be served by public transport with convenient access for markers;

and

- c) it should preferably be in decent condition to minimize renovation costs
- 4. The following premises have been identified in the past few years but were found unsuitable -

### Income of rechecking/remarking/appeal review cases received in recent years

5. The statistics on income of rechecking/remarking/appeal review cases for the Hong Kong Certificate of Education Examination (HKCEE) and the Hong Kong Advanced Level Examination (HKALE) from 2008 to 2010 are set out in the table below -

6. Despite the increase in income on rechecking/remarking/appeal cases from 2008 to 2010, it should be noted that the income of the HKCEE and HKALE (including examination fee and supplementary fees on applications for change of

schedule, rechecking, remarking and appeal, etc) cannot cover their respective running costs. The deficit has been absorbed by HKEAA.
