Legislative Council Panel on Home Affairs Private Recreational Facilities

Introduction

We have reviewed the extent to which organisations that operate under Private Recreational Leases (PRLs) could be more open to outside bodies and could contribute more to the development of sport in Hong Kong. This paper outlines the initial conclusions that we have drawn from this review and a possible way forward.

Background

2. The organisations that operate under PRLs include private sports clubs, social and welfare organisations, uniformed groups, sports associations and civil servants' associations. By investing in the development and management of sports and recreational facilities over the years (some for more than a century), these organisations have contributed significantly to meeting the sporting and recreational needs of the community. In this connection, their sports facilities are required to be made available to outside bodies for booking for a certain number of hours per week. As at 1 March 2011, there were 51 different organisations operating facilities at a total of 73 premises. These organisations are listed at **Annex**.

Considerations and Proposals

- 3. The relevant organisations may make their facilities available to the public, either by charging affordable membership fees or by providing venues for regular training or competitions to outside bodies, for example -
 - (a) social and welfare organisations and uniformed groups operate recreational facilities that are widely accessible for use by the general

public at relatively low cost;

- many private sports clubs offer outside bodies, as well as club members access to facilities such as golf courses, lawn bowls greens or cricket pitches that the Government does not commonly provide; and
- "national sports associations" (NSAs) regularly use the facilities at private sports clubs to host local and international matches - indeed, such facilities are essential to the viability of many of these events.
- 4. Although private sports clubs already provide some degree of access to outside bodies, we consider that there is a scope for them to do more in this regard, and in so doing to contribute further to the development of sport in Hong We are therefore considering the extent to which such clubs could allow more access to outside bodies such as schools, NSAs and social welfare groups, in order to serve our three key policy objectives for sports development, namely –
 - promoting sport in the community;
 - (b) promoting elite sports development; and
 - (c) promoting Hong Kong as a centre for international sports events.

I. Promoting sport in the community

5. Under the conditions of PRLs, a lessee when required so to do by a competent authority¹ shall permit outside bodies to book its facilities for no more than three sessions of three hours each per week, provided that the use of the facilities "shall not be on a weekend or public holiday". To allow for more flexibility in the booking of facilities, we consider that there is scope for revising the access requirements, for instance by replacing "no more than three sessions of three hours per week" by "40 hours per month or more, provided that such use would not interfere with the proper care and maintenance of the lot". The revised condition would facilitate all-day training or competitions. we could consider removing the condition that facilities shall not be used on weekends or public holidays, so as to allow for outside bodies to book sports

facilities at such times (whilst recognising that availability of facilities at public holidays and weekends might be limited due to demand from the clubs' own members).

6. To make it easier for outside bodies to book sports facilities run by private sports clubs, we could allow **outside bodies to approach the clubs directly**, rather than having to go through a "competent authority". We could publicise such an arrangement by informing bodies such as NSAs, schools, youth groups and non-governmental organisations of the arrangements and issuing regular reminders of the availability of such sports facilities.

II. Promoting elite sport development

- 7. As well as promoting sport in the community, we consider that there is scope for private sports clubs to contribute more to promoting elite sports development. At present, some clubs charge young people significantly reduced entry fees to join as junior members. This allows young athletes to use the clubs' sports facilities for training, and to gain competition experience through representing the clubs. We are now considering whether in future all clubs should be required to put in place **junior membership schemes** that allow sportsmen and women below a certain age to join at significantly reduced rates of entry.
- 8. Many private sports clubs also host representative players or squads of NSAs who use the clubs' sports facilities for training or for playing in local competitions. We are considering whether we might require operators to allow **NSAs to book their facilities** for squad training or local competitions for a minimum of 10 hours per month, *in addition* to the requirement to allow access to outside bodies for 40 hours per month. This would help meet demand for training and competition venues.

III. Promoting Hong Kong as a centre for international sports events

9. Several private sports clubs have high-quality facilities suitable for hosting major international sports events. Clubs such as the Kowloon Cricket Club, the Kowloon Bowling Green Club and the Hong Kong Golf Club have hosted "M" Mark events or other international events. Where suitable facilities are available, there is scope for us to require such clubs to **allow NSAs to use their facilities for staging recognised international events**. This would

allow the public greater access to the private sports clubs concerned, as spectators at such events.

Removal of obsolete conditions in leases

10. The lease conditions for the current PRLs were drawn up over 15 years ago. Some of the lease conditions may be considered obsolete, such as prohibitions against people from outside bodies using the toiletries provided in the changing-rooms of private clubs. We plan to remove such obsolete conditions from all PRLs.

Better publicity and monitoring

11. Outside bodies such as schools, welfare and non-governmental organisations have been informed about the requirement for PRL lessees to make their sports facilities available to outside bodies, and some of them have indeed been making use of such facilities. However, we agree that publicity could be stepped up to make more outside bodies aware of the availability of such facilities. To improve publicity on the availability of sports facilities at premises operated under PRLs, we could require the operators of the premises to publish information about their facilities on their websites and also regularly to remind the competent authorities to bring such information to the attention of bodies under their respective purviews. Relevant information will also be uploaded to the website of the Home Affairs Bureau. In addition, to improve our capacity for monitoring the booking of sports facilities operated under PRLs, we could require that operators provide a quarterly report on the use of their sports facilities by outside bodies. We would conduct random checks and act on complaints, and if we detect irregularities and consider that lease enforcement action is necessary, we would take follow-up action.

Consultation

12. Relevant organisations operating premises under PRLs are aware of our proposal for them to further open up their facilities to outside bodies. These organisations are in general positive about accommodating the new arrangements to make it easier to book their facilities.

Presentation

13. Members are invited to comment on the issues presented in this paper, in particular the proposals described in paragraphs 5 to 11 above.
