## Land Registry statistics for November 2010

The Land Registry today (December 2) released its statistics for November 2010.

#### Land Registration

- The number of sale and purchase agreements for all building units received for registration in November 2010 was 15,967 (+31.5% compared with October 2010 and +42.7% compared with November 2009)
- The 12-month moving average for November 2010 was 13,505 (this was 3.0% above the 12-month moving average for October 2010 and 26.3% above that for November 2009)
- The total consideration of sale & purchase agreements in November 2010 was \$74.0 billion (+30.2% compared with October 2010 and +54.5% compared with November 2009)
- Among the sale & purchase agreements, 13,189 were for residential units (+38.1% compared with October 2010 and +43.2% compared with November 2009)
- The total consideration for sale & purchase agreements in respect of residential units was \$58.8 billion (+30.9% compared with October 2010 and +54.2% compared with November 2009)

Sales of residential units refer to the sale and purchase agreements with payment of stamp duty. These statistics do not include sales of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme except those after payment of premium.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales are also released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

## Land Search

• The number of searches of land registers made by members of the public in November 2010 was 537,807 (+3.8% compared with October 2010 and +21.0% compared with November 2009)

The statistics cover searches made at the counter, through the self-service terminals and the IRIS Online Services.



# The Land Registry Chart showing the number of Sale and Purchase Agreements of building units from November 2009 to November 2010


