The systematic review process helps ascertain each hospital to have a thorough examination on the many different aspects of service delivery process, stakeholders' engagement and continuous quality improvement. It is the way for developing and establishing an effective and good quality healthcare service in line with the world class standard.

For the implementation of the hospital accreditation, it is unavoidable that additional and sufficient resources such as manpower and recurrent expenses are required and should be provided. Nevertheless, the benefit that it brings will definitely outweigh the cost, both tangible and intangible, involved. Moreover, the schedule of such an implementation should also be planned meticulously in order not to worsen the current manpower problems encountered by health care practitioners including doctors, nurses and allied health professionals.
