#### Panel on Public Service Meeting on 16 March 2011

At the Public Service Panel meeting held on 16 March 2011, the Administration was requested to provide a breakdown by reimbursement items in respect of the reimbursement expenditure of medical expenses incurred by civil service eligible persons for the period from 1 April 2010 to 31 December 2010, as well as the respective numbers of applications received, approved and rejected, and the reasons for rejection.

Further to the Panel meeting, we have obtained the latest updated figures from the Department of Health (DH). From 1 April 2010 to 28 February 2011, DH has received 36 403 applications for payment and reimbursement of medical fees and hospital charges. Among them, 36 245 (or 99.6%) applications with a total claims value of \$241.6 million were approved, and 158 applications (or 0.4%) with a total claim value of \$0.5 million were rejected. A breakdown of both approved and rejected cases by reimbursement items and the reasons for rejection are provided at **Annex** for Members' information.
