Action

I Election of Chairman and Deputy Chairman (if required)

Ms Miriam LAU sought members' views on whether re-election of the Chairman for the 2010-2011 session was necessary. Members agreed that there was no need for re-election. Members also agreed that there was no need to elect a deputy chairman.

Special meeting on 10 December 2010

- 3. The Subcommittee agreed to hold a special meeting on Friday, 10 December 2010, at 3:00 pm (or immediately after the House Committee meeting scheduled for the same day) to discuss the following items -
 - (a) Shatin to Central Link Remaining Protection Works and Advance Works:
 - (b) Kwun Tong Line Extension;
 - (c) South Island Line (East); and
 - (d) retrofitting of platform screen doors.

Regarding the item referred to (d) above, Mr Ronny TONG requested that the Administration should be asked to provide updates on the collection of \$0.1 per Octopus MTR journey from passengers as a contribution to the capital cost of the platform screen doors retrofitting programme.

5. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

- 6. <u>Mr Abraham SHEK</u> declared that he was an independent non-executive Director of the MTR Corporation Limited (MTRCL).
- 7. With the aid of Powerpoint, <u>MTRCL</u> briefed members on the causes of the Tsuen Wan Line train service disruption on 21 October 2010 and the contingency measures taken.
- 8. Members were gravely concerned about the delayed notification to the Transport Department (TD) and the contingency measures taken during the incident. In particular, members expressed deep dissatisfaction with the confusion in the dissemination of information to passengers regarding the service suspension and train service available, emergency bus arrangements, lack of crowd control at the emergency bus pick-up points, and the ad hoc changes made to the locations of those points. The Administration advised that given the prolonged delay caused by the incident during the morning peak period and the scale of impact on rail passengers, it considered the incident a major and serious one. The Administration informed members that it had written to MTRCL urging it to make necessary improvements, and was awaiting the final report on the incident to be submitted by MTRCL. The Administration would consider necessary follow-up action after studying the final report.
- 9. In response to members' concerns, <u>MTRCL</u> undertook to take various improvement measures including the following
 - (a) strengthening internal operating procedures of the Operations

Control Centre to ensure timely notification to TD of any incidents according to the established mechanism;

- (b) enhancing communication with passengers with the aid of equipment such as digital stanchions and giant information displays to advise passengers of alternative transport routes/modes when railway incidents occurred;
- (c) conducting a comprehensive review with TD and the Police on the deployment of emergency buses and relevant arrangements; and
- (d) effecting full manning of the Communication Control Centre throughout the traffic day.
- 10. In response to members' request for facilities enabling radio reception on train compartments and at MTR stations, MTRCL explained that there was difficulty to accede to the request as previous feasibility study conducted by the Corporation had shown that the provision of a system enabling radio reception within the large, underground MTR network was technically complicated and would involve large costs for the works. MTRCL advised that centralized public announcements were made at present to inform passengers already within the MTR network of service suspension and contingency arrangements and progress.
- 11. <u>Mr WONG Sing-chi</u> moved the following motion which was seconded by Mr KAM Nai-wai and Mr LEE Wing-tat –

"That, as quite a number of serious incidents and disruptions have occurred on the railway systems of MTRCL over the past several years and there has been no improvement in the measures it has adopted in response to these incidents and the way it has handled them; its performance in handling the recent incidents has been more than disappointing and has aroused concern about and dissatisfaction

with its railway operations among members of the public; this Subcommittee demands that MTRCL withholds the bonus payments for this year to its Chief Executive Officer and other management staff concerned as a punishment."

12. <u>The Chairman</u> put the motion to vote. After voting, <u>the Chairman</u> declared that ten members voted for and no members voted against the motion. <u>The Chairman</u> declared that the motion was carried.

Admin/ 13. <u>The Administration/MTRCL</u> were requested to take the following MTRCL actions –

- (a) to conduct a comprehensive review of MTRCL's contingency plans in collaboration with relevant government departments to identify room for improvements, and report the review outcome to the Subcommittee in three months' time. In particular, the following areas should be looked at -
 - (i) emergency bus deployment plans;
 - (ii) prior agreement should be reached with the Police on the locations of the emergency bus pick-up points to avoid ad hoc changes to these locations;
 - (iii) any impact on action taken by TD as a result of MTRCL's delayed notification to TD on 21 October morning;
 - (iv) contingency measures of various levels should be introduced to cope with incidents occurring during busy and non-busy hours;
- (b) consider publishing MTRCL's guidelines on handling of railway incidents on its website for the information of the public;
- (c) provide information on the cost implications of the provision of a system enabling radio reception on MTR train compartments and at MTR stations;
- (d) consider members' suggestion that statistical information of railway incidents should be compiled and used as an indicator for reference to facilitate Government's consideration of the need to impose penalties on MTRCL (e.g. issue of warning letters and withholding bonus payments); and

(e) provide a written response to the motion.

14. <u>The Chairman</u> said that this issue would be included in the list of outstanding items for discussion and revisited at a future meeting after receipt of the requisite information from the Administration and MTRCL.

V Progress of the Shatin to Central Link

- 15. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 16. <u>Ms Starry LEE</u> declared that she owned properties along the alignment of the Shatin to Central Link (SCL).
- 17. With the aid of Powerpoint, <u>MTRCL</u> briefed members on the latest progress of SCL.
- 18. <u>Members</u> in general were gravely concerned about the upsurge in the project estimate from \$38.17 billion (in April 2007 prices) to over 60 billion according to the latest estimate. <u>The Administration</u> and <u>MTRCL</u> explained the reasons for the rise as detailed in paragraphs 25 to 27 of the Administration's paper. <u>Members</u> urged the Administration to expedite the implementation of the project as the new railway had long been awaited by residents concerned and to take measures to avoid large increase in project costs.
- 19. With regard to members' concern on the replacement of 12-car trains with nine-car trains for the East Rail Line (ERL) which might aggravate the overcrowding condition, <u>MTRCL</u> advised that the impact of which would be offset by an enhanced signalling system to be installed with train frequency shortened from approximately every three to two minutes. The six interchange stations under SCL would also serve the diverging purpose and share the patronage of ERL.

Admin/ 20. <u>The Administration/MTRCL</u> were requested to take the following MTRCL actions –

- (a) to provide a detailed breakdown of the project cost estimate for members' consideration;
- (b) to provide supplementary information on the projected service demands to support MTRCL's claim that the replacement of 12-car trains with nine-car trains for the ERL would be able to cope service demands of SCL;
- (c) to consider the Chairman's view that leisure and recreational facilities should be provided in the vicinity of Ma Chai Hang Recreational Ground to compensate local residents for occupation of the Recreational Ground for provision of a ventilation building and emergency access; and
- (d) to consider requests for provision of additional station entrances at Tai Shui Hang Station and pedestrian connection facilities between Hin Keng Station and the shopping malls in the residential housing estate nearby.
- VI Review and update of the Railway Development Strategy 2000
 (LC Paper No. CB(1)256/10-11(03) Administration's paper on review and update of the Railway Development Strategy 2000)
- 21. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- Admin 22. <u>Members</u> supported submission of the current proposal to the Finance Committee for funding approval, and expressed the following views and suggestions -
 - (a) the review should explore means to enhance the railways' role as the backbone of public transport through better coordination with other transport modes, including the provision of park-and-ride facilities at major MTR stations to ease traffic congestion of harbour crossing;

- (b) the outcome of the review should be published from time to time without waiting for completion of the whole review exercise; and
- (c) the review should also cover the Northern Link and North Island Line, which were proposals identified in the Railway Development Strategy 2000 but not yet implemented.
