### Summary of The Link's works on BFA Provision

#### 1. Referral Cases of Equal Opportunities Commission (EOC)

Equal Opportunities Commission (EOC) recommended some BFA upgrading works to be done in eight of the Link's retail outlets which are connecting to estate premises under Housing Authority in Tai Wo, Tai Hing, Fu Tung, Tsz Wan Shan, Siu Sai Wan, Oi Man, Kwai Hing (car park) and Tsz Lok (car park). The Link subsequently conducted feasibility studies and carried out the upgrading works in these areas. With the exception of large scale structural changes / installation of lift facilities and Oi Man Shopping Centre which is now undergoing asset enhancement, more than 90% of the recommended works have already been completed by March 2011. A meeting was held on 28 March 2011 with EOC who was satisfied with the work progress.

#### 2. The Link's Commitment and its BFA Works Schedule

The Link made an announcement on its commitment in and proposal for the provision of BFA at its retail properties on 19 January 2011. Press releases issued by The Link on the proposal and its update are attached in Appendix 1A / 1B.

#### 3. Formation of the Access Advisory Group

An Access Advisory Group (AAG) was formed by The Link in March this year. Over ten major rehabilitation organizations have joined as members of the AAG. Two meetings have already been held so far. Mr Joseph Kwan, an international BFA expert, was appointed by The Link as our Access Advisor. The membership list of the AAG is attached in Appendix 2.

### 4. Continuous Co-ordination with Housing Authority

Housing Authority and The Link have been organizing regular meetings since March this year for better coordination and interface on the provision of BFA facilities at the premises owned by both parties.

## HK\$200M Earmarked by The Link for Total Upgrading of Facilities to Meet New Standards of Barrier Free Access

(19 January 2011 • Hong Kong) The Link Management Limited (The Link) will upgrade all of its facilities under the Best Practicable Principle, at a budget of HK\$200M, to comply with the standards set out in the Buildings Department: "Design Manual: Barrier Free Access 2008" and other associated requirements. To be commenced soon this year, the programme will be rolled out in 3 phases with anticipated completion of the last phase in 2016<sup>1</sup>.

The total upgrading of the BFA facilities will particularly benefit persons with disabilities, the elderly, people with other physical limitations, pregnant women and families with young, through the provision of accessible lifts, vertical platforms, tactile guide paths, accessible customer service counters, ramps, Braille layout plans and accessible toilets etc.

All the 8 properties recommended by the Equal Opportunities Commission for improvements of BFA facilities, including 6 shopping centres (Tai Wo, Tai Hing, Fu Tung, Tsz Wan Shan, Siu Sai Wan, Oi Man)<sup>2</sup> and 2 car parks (Kwai Hing, Tsz Lok), most of the works will have been completed in March 2011.

KT Poon, Director (Corporate Communications) of The Link, said, "The 180 properties owned and managed by The Link were built many years ago with some of them being over 30

years old. Since acquiring these properties and taking over the management in 2005, we have been progressively improving the BFA facilities at these locations through large-scale Asset Enhancement Initiatives and regular maintenance works.

"We have appointed BFA expert Mr Joseph Kwan<sup>3</sup> as our Access Advisor. Mr Kwan will review the characteristics of each of the properties and advise us of the best practicable solutions. That will ensure the improvement works will be done much more comprehensively and efficiently. Before the works start and in the course of implementation, we will keep close liaison with the Equal Opportunities Commission and Housing Department etc., and consult relevant bodies including organizations for the disabled to better understand their actual needs."

KT Poon added, "We will inform the public regularly our programme progress, respond to their enquiries and, through periodic communication, build consensus in providing the best practicable facilities and services for the community at large.

"For properties with intrinsic limitations or physical difficulties which cannot be upgraded to the latest barrier free standards, we will do our best to help those in need by means of operational measures.

"The Link will also revamp its website with widely-used web accessibility software tools to facilitate browsing by people who are visually impaired or physically disabled (such as neuromuscular impaired). It will also be our pleasure to sponsor venues for hosting of activities to promote social integration. We are planning to organize "The Link Social Integration Day" to facilitate more interaction between the disabled and the community, hoping to build a friendlier and more socially integrated society."

The Link will adopt the Best Practicable Principle which will enable it to comply with the standards set out in the Buildings Department: "Design Manual: Barrier Free Access 2008" and other associated requirements.

The upgrading works of the BFA facilities will, after taking into consideration on the onsite situation and environment factors, provide meet-the-needs facilities particularly for people with disabilities, the elderly, people with physical limitations, pregnant women and families with young children. Such provisions include tactile guide paths, accessible customer service counters, accessible toilets, visual fire alarm systems, disabled car parks, ramps, Braille layout plans and accessible lifts.

From now on and at three months' intervals, The Link will announce a new list of retail properties for BFA upgrading works to be started in the coming six months, and will at the same time report or conclude the works that have been done in the past three months.

Regarding the eight properties recommended for BFA upgrading works by Equal Opportunities Commission (EOC), with the exception of large scale structural changes or installation of lift facilities, more than 90% of the works have been completed by March 2011 in five shopping centres (Tai Wo, Tai Hing, Fu Tung, Tsz Wan Shan, Siu Sai Wan) and two car parks (Kwai Hing and Tsz Lok). The remaining property – Oi Man shopping centre which is currently undergoing overall Asset Enhancement works, will have the BFA facilities upgraded in 2012 as part of the enhancement works. EOC was satisfied with the progress of the BFA works at these eight properties under The Link.

The Link had appointed BFA expert Mr Joseph Kwan as its Access Advisor. An Access Advisory Group was formed subsequently with over ten major rehabilitation organizations being invited as members. Through regular meetings and onsite inspections, members can share their views and opinions on the best practicable solutions for the BFA upgrading works to be done at the Link's properties.
