### I. Election of Chairman and Deputy Chairman (if required)

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

2. <u>Members</u> agreed that there was no need to re-elect a Chairman for the 2010-2011 session. <u>Members</u> also agreed that election of a deputy chairman was not required.

#### II. Provision of support services for demented elders

[LC Paper Nos. CB(2)2369/09-10(02), CB(2)188/10-11(01) to (03), CB(2)261/10-11(01) and CB(2)270/10-11(01)]

- 3. The Subcommittee received views from eight deputations on the provision of support services for demented elders. Major views of the deputations are summarised as follows -
  - (a) given that there was an increasing number of elders suffering from dementia, the Administration should step up publicity to arouse public awareness and enhance early identification of dementia;
  - (b) the Administration should consider introducing a carer allowance to family carers of demented elders so as to relieve their burden and stress in taking care of the demented elders;
  - (c) the Administration should consider setting up dedicated service units in residential care homes for the elderly ("RCHEs") and day care centres for elderly to provide specialised services for demented elders;
  - (d) the Administration should enhance the training for carers of demented elders so as to improve their caring skills and alleviate their stress in taking care of demented elders;
  - (e) the Administration should consider adopting the concept of "money following users" such that demented elders and their family carers could make their own choice of services that would better suit their needs; and
  - (f) the Administration should formulate a long-term policy on the provision of support services for demented elders.
- 4. While appreciating that support services for demented elders and their carers were being provided by the Social Welfare Department ("SWD"), the Department of Health ("DH") and the Hospital Authority ("HA"), members generally shared the views of deputations that the provision of such services was limited and inadequate to meet the demand in the light of the ageing population. Members considered that more resources should be allocated to strengthen the services at day care centres/units for the elderly and to provide relevant training programmes for staff of elderly service units and family carers. Consideration should also be given to setting specific targets and

formulating a long-term plan for the support services for demented elders. This apart, the Administration should consider introducing a carer allowance so as to relieve the burden and stress of family carers. It was also suggested that the Administration should provide funding under the Community Care Fund to subsidise the patronage of support services for demented elders provided by non-subvented organisations.

- Assistant Secretary for Labour and Welfare (Welfare) 3 ("PAS(W)3") advised that in the light of great demand for suitable premises for setting up various types of welfare facilities, it might not be feasible to identify suitable venues for setting up new dedicated service units for demented elders in every district in the short run. Members' attention was drawn to the fact that SWD had been continuously allocating resources to improve the facilities of RCHEs and day care centres/units for the elderly, including over \$30 million from the Lotteries Fund in 2009 for subsidised elderly service units to purchase bed monitoring systems, anti-wandering systems, facilities for multi-sensory therapy, etc. To facilitate easy accessibility of service users, it was considered appropriate to make use of the existing day care centres/units for the elderly to provide an integrated and continuum of services for demented elders in order to meet their care needs at different stages.
- 6. Assistant Director of Social Welfare (Elderly) ("ADSW(E)") supplemented that SWD had commissioned a 3-year consultancy study in 1999-2002 to evaluate the pilot projects of setting up dedicated service units for demented elderly. It was considered more desirable for demented elders to be served in an integrated manner in one care facility, in the same environment where the elders were familiar with, to meet their needs at different stages of care level and conditions. ADSW(E) said that SWD had been providing regular training programmes on care for demented elders for staff of elderly service units so as to enhance their knowledge of dementia and strengthen their relevant skills. Carers of demented elders were welcome to attend those training programmes. This apart, SWD had been providing a Dementia Supplement ("DS") to subvented RCHEs since 1999 and it had further extended the coverage of DS to include all private RCHEs participating in the Enhanced Bought Place Scheme since the 2009-2010 financial year. The annual allocation for DS had been increased from \$7 million in 1998-1999 to \$42.5 million in 2009-2010 and the number of demented elders benefited had been increased from 400 to about 4 200 in the corresponding period. As announced in the 2010-2011 Policy Address, for the first time, DS would be provided to day care centres/units for the elderly.

- 7. PAS(W)3 said that the Administration was fully aware of the stress of carers of demented elders. To this end, the Administration had implemented measures to support the carers, for example, the District-based Scheme on Carer Training was launched in 2007 to teach participants basic knowledge of elderly care, including the skills in caring for demented elders. To date, over 2 400 carers had been trained and some 4 000 carers were now receiving training under the Scheme. Moreover, all subvented RCHEs, contract RCHEs and day care centres/units for the elderly provided residential respite or day respite services, so that carers could take a break or attend to other businesses, thereby relieving their stress.
- 8. Assistant Director of Health (Family and Elderly Health Services) said that according to a study conducted jointly by DH and the Chinese University of Hong Kong in 2006, 10% of elders aged 70 or above were suffering from different levels of dementia. If adequate support services were provided to demented elders, premature institutionalisation could be avoided and those elders would be able to remain in the community and age in place. The implementation of the three-year Elderly Health Care Voucher Pilot Scheme would enable elders including demented elders and their carers to choose their own private primary health care services in their local communities that best suit their needs. In addition, the Elderly Health Service of DH had all along been promoting public awareness of dementia and teaching skills in taking care of demented elders through various channels.
- 9. <u>Chief Manager (Primary and Community Services)/HA</u> said that the community geriatric assessment teams and psychogeriatric outreach teams of the seven clusters under HA had been providing elders in need (including patients with dementia) with timely healthcare services and support. Some patients with dementia would be referred to the psychiatric departments or the memory clinics of the medical departments of public hospitals for assessment, treatment and monitoring of disease progress.

- 10. Owing to time constraint, the Chairman requested the Administration to provide a written response to the following after the meeting as far as practicable -
  - (a) the plan and timetable for extending memory clinics to all the 18 districts over the territory;
  - (b) the feasibility of providing services for demented elders at both dedicated service units and day care centres/units for the elderly;

- (c) whether the Administration would spearhead the collaboration between the medical and welfare sectors in providing support services for demented elders;
- (d) whether the Administration would allocate more resources to the District Elderly Community Centres and expand their membership with a view to enhancing early identification of dementia;
- (e) in addition to studying the proposal of providing a cash allowance for family carers of demented elders, whether the Administration would enhance other support services for carers to provide relief for carers;
- (f) provision of training programmes on caring for demented elders specifically for domestic helpers who were taking care of demented elders; and
- (g) provision of DS to all demented elders living in RCHEs.

#### III. Any other business

- 11. <u>The Chairman</u> suggested that the Subcommittee would discuss and receive views on the regulation of residential care homes for the elderly at the next meeting to be held on 10 December 2010 at 10:45 am. <u>Members</u> agreed.
