LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES DESIGNATION OF PUBLIC SWIMMING POOLS

INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance Cap.132 ("the Ordinance"), manages the public swimming pools listed in the Fourteenth Schedule to the Ordinance. Under Section 42A of the Ordinance, the Authority may, from time to time, by order designate public swimming pools, and may by order amend, or add to, or delete from the Fourteenth Schedule.

2. We propose to introduce the amendments through the Public Health and Municipal Services (Designation of Public Swimming Pools) Order 2010 (Order) at Annex A and the Public Health and Municipal Services Ordinance (Amendment of Fourteenth Schedule) Order 2010 (Amendment Order) at Annex B to this Brief to designate the venues specified in the Schedule at the Order for use as public swimming pools.

JUSTIFICATIONS

3. The proposal to designate three new venues as public swimming pools will enable the Authority to enforce the regulations relating to these public swimming pools for proper management.

Designation of public swimming pool

- 4. The following three new venues are required to be designated as public swimming pools and are to be included in the Fourteenth Schedule
 - (a) Siu Sai Wan Swimming Pool
 - (b) Sun Yat Sen Memorial Park Swimming Pool
 - (c) Tung Chung Swimming Pool

AMENDMENT OF FOURTEENTH SCHEDULE

6. The Amendment Order at <u>Annex B</u> amends the Fourteenth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to update the list of public swimming pools.
