DIRECTOR OF INTELLECTUAL PROPERTY (ESTABLISHMENT) ORDINANCE (AMENDMENT OF SCHEDULE 1) ORDER 2011

INTRODUCTION

Α

At the meeting of the Executive Council on 17 May 2011, the Council ADVISED and the Chief Executive ORDERED that the Director of Intellectual Property (Establishment) Ordinance (Amendment of Schedule 1) Order 2011 at Annex A (the "Amendment Order") should be made, pursuant to section 6 of the Director of Intellectual Property (Establishment) Ordinance (the "Ordinance") for the purpose of empowering the holders of the new Assistant Principal Solicitor office to assist the Director of Intellectual Property in performing his duties.

JUSTIFICATIONS

- 2. We have earlier obtained approval from the Legislative Council for upgrading two permanent Senior Solicitor ("SS") posts in the Hearings Team in the Intellectual Property Department ("IPD") to Assistant Principal Solicitor ("APS") posts at the DL1 rank. The office of APS is a new legal officer rank in IPD.
- 3. Section 3(1) of the Ordinance empowers the Chief Executive to appoint a Director of Intellectual Property (the "Director") and such other officers to hold any of the offices specified in Schedule 1 as may be required to assist the Director in the performance of his duties. Section 5 of the Ordinance further provides that a holder of an office specified in Part 1 of Schedule 1 may, subject to any instructions of the Director, exercise the powers or perform the duties of the office of the Director. Part 1 of Schedule 1 sets out the offices which must be held by legally qualified officers, including the offices of the Deputy Director of

Intellectual Property, Assistant Director of Intellectual Property, SS and Solicitor. Section 6 of the Ordinance empowers the Chief Executive to amend this Schedule by order published in the Gazette.

4. The holders of the new office of APS are to be appointed in accordance with section 3 of the Ordinance. Before doing so, we need to name the new APS office as an office specified in Part 1 of Schedule 1 to the Ordinance.

THE AMENDMENT ORDER

- 5. The Amendment Order aims at adding a new office of "Assistant Principal Solicitor" ranked between "Assistant Director of Intellectual Property" and "Senior Solicitor" in Part 1 of Schedule 1 to the Ordinance.
- 6. Copies of the relevant empowering provisions in the Ordinance and the relevant schedule being amended are at Annex B.

PUBLIC CONSULTATION

9. This amendment exercise arises from a proposal to upgrade two SS posts in IPD to APS posts. That proposal has the support of the LegCo Panel on Commerce and Industry; the Establishment Subcommittee of the LegCo Finance Committee; and the Finance Committee.

10. The proposed amendment is technical in nature. Separate consultation is not considered necessary.
