### 2012年5月2日的立法會會議

#### 《2012年立法會(修訂)條例草案》

#### 全體委員會審議階段修正案

秘書處已於2012年4月23日發出立法會CB(3)676/11-12號文件通知議員，立法會主席已批准政制及內地事務局局長於2012年5月2日的立法會會議上，就上述條例草案動議其擬議修正案。謹請議員注意，立法會主席亦已批准，陳偉業議員及黃毓民議員各自就條例草案動議修正案。在條例草案的全體委員會審議階段，陳偉業議員會動議共1 232項修正案，而黃毓民議員會動議共74項修正案。

2. 由於修正案數目龐大，為節省用紙，秘書處**只會透過電郵**發放各項修正案給各位議員。此外，各項修正案及本通告已上載立法會網站，供議員參閱。如議員希望索取印文本自用，請致電3919 3310與議會事務部3聯絡。在立法會會議舉行期間，該等修正案連同本通告的印文本會分別放置在會議廳前廳內面向主要入口的長木桌上，以及會議廳內何秀蘭議員及王國興議員座位後的桌上。

## 會議安排

Copies of the amendments together with this circular will be placed on the long wooden table facing the main entrance of the Ante Chamber, as well as the desks behind Hon Cyd HO Sau-lan's and Hon WONG Kwok-hing's seats in the Chamber throughout the Council meeting.

### Meeting arrangement

In view of the large number of amendments to be dealt with at the meeting of 2 May 2012, Members are invited to note that if the President is of the opinion that it is unlikely that the business on the Agenda of the meeting can be finished by about midnight on Wednesday 2 May 2012, he will suspend the meeting at **about 10:00 pm** and order that it resume on Thursday 3 May 2012 at **9:00 am sharp** for the continuation of the unfinished business on the Agenda. If the business on the Agenda cannot be finished by about midnight on Thursday 3 May 2012, the meeting will be suspended at about 10:00 pm and continue on Friday 4 May 2012 at 9:00 am sharp.
