**Re : Panel on Administration of Justice and Legal Services (“Panel”)
– Use of Chinese in Court Proceedings**

Thank you for your letters of 22 December 2011 and 20 January 2012 with enclosures.

The Panel seeks the views of the Law Society (“Society”) on:

- (i) The work which needs to be done on various fronts for further development in the use of Chinese in court proceedings;
- (ii) The work of the Society in promoting the use of Chinese in court proceedings.

We will put the 2 matters before the relevant Committees of the Society for their consideration and endeavour to provide you with a response prior to the meeting of the Panel on 26 March 2012.

Meanwhile, I can advise that the following efforts were made by the Society in the past to assist practitioners in meeting the growing demand for legal practice in Chinese:

1. **Bilingualism Committee**

1.1 In anticipation of Hong Kong's return to Chinese sovereignty in 1997, the Society established a Working Party on Bilingualism in the Law in 1996. This Working Party was subsequently converted into a permanent Committee, the Bilingualism Committee ("Committee") whose principal term of reference was to explore ways to promote and assist towards a bilingual legal system. Throughout the years, the Committee contributed to fostering a bilingual environment, raising the bilingual skills of practitioners and liaised with the Government and the Judiciary to do so. Details of its work are documented in the Society's Annual Reports, the extracts of which are attached in **Appendix 1**.

1.2 Noteworthy are the following developments:

- (i) As early as 1998, the Committee took the initiative to approach the Judiciary to ask for the monthly lists of Court cases to be conducted in Chinese for circulation to the Society's members.
- (ii) Starting from 1998, the Committee arranged for various publications of the Society to be translated into Chinese, including The Hong Kong Solicitors' Guide to Professional Conduct, the Hong Kong Lawyer, conveyancing forms and documents to be used in Consent and Non-Consent Schemes. The Committee also recommended other law publishers to translate their standard English reference books into Chinese.
- (iii) The Committee participated in the Government's centralized policy body, the Committee on a Bilingual Legal System to represent the views of the solicitors' profession.
- (iv) In 2000, the Committee made a recommendation to the Judiciary for the Court Translation Office to release its Glossary of Legal Terms in Chinese to the legal profession for its benefit. The recommendation was adopted by the Judiciary.
- (v) In 2002, the Committee made recommendations to the Judiciary to make available all judgments in English and Chinese and if there were insufficient resources, to ensure at least judgments from the High Court and Court of Final Appeal were translated. The recommendation was subsequently adopted by the Judiciary in 2006 when the Judiciary established a Screening Committee to systematically identify Chinese judgments of jurisprudential value for translation into English.
- (vi) The Committee initiated a series of Chinese language courses tailor-made for the legal profession, including advocacy courses in Chinese aiming at developing the Chinese advocacy skills of practitioners in different types of legal proceedings. Judges experienced in Chinese legal proceedings were invited to conduct

courses in civil litigation, Lands Tribunal cases, matrimonial and criminal litigation.

- (vii) The Committee compiled an English-Chinese Glossary of Terms which was made available to the Society's members in 2004.
- (viii) The Committee created a site "Bilingual Legal Reference Material" on the Society's website to centralize all reference materials as an on-line bilingual legal reference library.

2. Provision of Legal Education and Training in Chinese

- 2.1 The initiative of the Committee to provide legal education and training in Chinese to practitioners was taken over by the Standards and Development Department of the Secretariat and by the Academy of Law ("Academy") established by the Society in 2008. About 192 courses in Chinese have been provided by the Society and the Academy on their own, or jointly with other professional bodies since 2005 under the Continuing Professional Development ("CPD") Scheme and Risk Management Education ("RME") Programme, including courses on Chinese advocacy. A list of these courses is attached in **Appendix 2**.
- 2.2 The Society and the Academy also accredit courses conducted by third parties such as law firms, professional bodies, educational institutions and commercial providers under the CPD Scheme and the RME Programme to broaden the means by which practitioners could develop their legal skills and knowledge. The Society and the Academy had accredited about 1532 courses conducted in Chinese since 2005. A list of these accredited courses is attached in **Appendix 3**.

3. Provision of Legal Materials in Chinese

- 3.1 The Society established the Working Party on Law Library in 2010. This Working Party is tasked with the responsibility of transforming the law library of the Society into a specialist precedents law library for the benefits of the legal profession. Collections will include forms and precedents both on line and off-line in English and Chinese. In conjunction with the establishment of the Working Party on Law Library, the Society also set up the Working Party on Historical Archive which is tasked with the establishment and maintenance of an archive of materials and information (whether in English or Chinese) of historical value and to ensure such information is preserved and made accessible to the legal profession in the future.

4. Monitoring of Legal Education Provided in Chinese by Other Institutions

- 4.1 The Society monitors legal education and training through its participation in the Standing Committee on Legal Education and Training ("SCLET"), the statutory body established under S74A of the Legal Practitioners Ordinance Cap. 159 to keep under review, evaluate and assess the academic

requirements and standards for admission to the Postgraduate Certificate in Laws (“PCLL”) Programme. In the light of the increasing demand in the use of Chinese in the practice of law, both in drafting as well as advocacy, and the concerns on how equipped the legal practitioners are to meet the demand and how the LLB and PCLL providers in Hong Kong, namely, City University of Hong Kong, The Chinese University of Hong Kong, and The University of Hong Kong have addressed the deficiency in their curricula, SCLET enlisted the assistance of the Department of Justice to conduct a research on how the legal education system in other bilingual jurisdictions like Canada, Singapore and India dealt with the demand for bilingual proficiency. SCLET considered two particular aspects of the language requirement; as an entry requirement to universities and as a medium of instruction. After its investigation, it was reported in the 2010 Annual Report that SCLET was satisfied the 3 LLB and PCLL providers in Hong Kong were aware of the importance of Chinese in legal practice. SCLET noted efforts had been made by the providers to design the relevant curricula to improve the standard of Chinese and to teach students transferable skills in Chinese to meet the changes in the demand in the legal market.

- 4.2 In addition to its representation on SCLET, the Council of the Society appoints members to serve as representatives on the Academic Boards and Advisory Boards of various universities providing legal education in Hong Kong. The Council also appoints members to act as External Examiners to the universities. The Standing Committee on Standards & Development and the Legal Education Committee (“LEC”) conduct regular meetings with the universities to make suggestions and raise concerns over any issues on the provision of their LLB and PCLL programmes. In particular, LEC has made enquiry with the 3 PCLL providers to ascertain the number of courses conducted in Chinese, and whether students are required to provide their assignments and answers in examinations in simplified or traditional Chinese in those subjects. LEC noted some courses in Chinese on offer were cancelled due to the low number of registrants. LEC has suggested to the universities to impress upon their students the importance of being bilingual and the demand for bilingual skills in the legal market.
- 4.3 LEC had also in the past suggested for the 3 PCLL providers to conduct a course on Criminal Advocacy or Criminal Litigation in Chinese. It is noted the current practice in the Magistrates’ Courts is that the Magistrates would approach Chinese-speaking solicitors to ask if they can conduct for example, applications for bail and mitigation in Cantonese. Some of the legal jargons in criminal litigation are unique and LEC suggested there should be at least one lesson teaching the PCLL students procedures in criminal litigation in Cantonese in view of the demand in the market.
- 4.4 In response, the PCLL providers expressed difficulties in recruiting practitioners who would be proficient in conducting lectures and tutorials in Chinese. The Society considers the following interim measures may be implemented:

- (i) To provide Chinese translations for the English legal terminology in the course materials and handouts;
- (ii) To cater for teaching a particular subject e.g. bail application or plea bargaining instead of a course in Cantonese;
- (iii) To produce a video on Criminal Advocacy to show how to conduct for example, a bail application, plea bargaining in Cantonese. The Society would be happy to provide practitioners to assist in the production of the video. The Society has already assisted one of the 3 PCLL providers in producing an instructional DVD on advocacy in English and it is suggested subtitles could be provided to the DVD.

The above is an overview of the work conducted by the Society. Once the relevant Committees of the Society have had a chance to deliberate on the matters raised in your letter of 22 December 2011, I will advise the Panel on any suggestions on the way forward.

~~The Committee reviewed the judgment in the case of R v. Robert Eli Low and discussed whether, in light of the decision, statutory declarations should be declared orally. The Committee recommended a general review should take place of all the practice rules and the CLE rules to ascertain whether an oral declaration is absolutely necessary, and if not, then the requirement for such declaration to be deleted from the form.~~

BILINGUALISM COMMITTEE

The Committee was initially established in October 1996 as a Working Party and its principle terms of reference was to explore ways to promote and assist members towards a bilingual legal system. The Standing Committee recognised that the working party's task would, in fact, be long term and thus its status was changed to that of a Committee. Membership of this Committee covers a wide spectrum of practitioners, and includes those in private practice, in-house members, members from the Administration as well as academics. The following are the main areas which the Committee has focused on during the year:

Identification of Areas of Concern

To enable the Committee to be kept abreast of problems faced by different sectors of the profession, the Chief Judge of the High Court and the Law Draftsman of the Department of Justice were invited as guest speakers at the Committee's meetings. The Law Draftsman has also agreed to be a member of the Committee.

Members attended a trial conducted in Chinese and had the benefit of a post-trial session with the presiding judge to discuss the area of difficulty.

Chinese Reference Materials

The Committee has identified the establish a set of precedents of legal documents in common usage and sent a selection of conveyancing documents to the Department of Chinese, Translation & Linguistics, of the City University for translation into Chinese. Subject to the quality and accuracy of the translation, the Committee intends to circulate these translated documents to members.

The committee had also considered providing precedents of other commonly used documents, for example in litigation. Unfortunately, it became clear that the human resources and the financial costs of such an exercise would be outside the Committee's control. It was therefore decided that a recommendation should be made to the publishers of legal text to make their publications available in Chinese.

The committee has recommended to the House Committee that certain Chinese works should be made available in the Chinese section of the Society's library.

Judiciary's Glossary

A Subcommittee was formed to study the Judiciary's Glossary published by the Judiciary. The Subcommittee planned to meet with members of the Judiciary to exchange views on the Glossary.

Legislation

The following Bills were considered:

- Jury (Amendment) Bill 1997; and
- Supreme Court Civil Procedure (Use of Language) Rules

External Bodies

Representative of the Committee attended several meetings the following external bodies to exchange view on issues of common concern:

LegCo Panel on Administration of Justice and Legal Services

Steering Committee on the Use of Chinese in Courts

Committee on Bilingual Legal System in Hong Kong

The Committee has also nominated a representative to sit on this Committee which is a centralized policy body to be set up by the Government.

Chinese courses organised by the Society

Members reviewed the existing Chinese courses organised by the Society and recommended increasing the number of courses to be conducted in Chinese in the future.

Hong Kong Lawyer

Articles, in bilingual format, were written by members in alternative issues of the *Hong Kong Lawyer* the Society's official publication.

~~CIVIL LITIGATION COMMITTEE~~

~~Despite one or two bumps encountered over the Handover, 1997 has been a quiet year for civil litigation. That in itself is a success. The commitment in the Basic Law to continuation of Hong Kong's legal system after the Handover has been met and, apart from changes of nomenclature, civil litigation continues as if nothing had changed.~~

~~A number of issues have been covered by the Committee over the year which are set out below:~~

~~Personal Injury Proposals~~

~~The Committee's representative have continued to contribute substantially to reforms in the personal injury field. With representatives of the Bar and the personal injuries Judge, they have monitored the operation of the practice direction for personal injury cases. In addition, they have been considering and commenting on proposals for mediation in personal injury cases which may well bear fruit in the near future.~~

Service of Judicial Documents/Reciprocal Enforcement of Judgment

The Committee maintained its oversight of the progress of the negotiations to reach an agreement on the service of judicial documents between the HKSAR and the Mainland, and on the reciprocal enforcement of arbitration awards. The Administration, in late December, announced that an agreement has been reached in respect of the service of judicial documents between the HKSAR and Mainland and it is anticipated that the necessary amendments to the High Court Rules will be gazetted in early 1999. In respect of the reciprocal enforcement of arbitration awards, the Administration reported that substantial progress has now taken place and that it hopes, sometime in 1999, that an agreement will be signed between the HKSAR and the Mainland to enable reciprocal enforcement of arbitration awards to take place on the basis of the pre-1997 practice.

Circulars were also issued in relation to certain countries indicating their current arrangements with regard to reciprocity of enforcement of foreign judgments.

Sub-Committees

New Territories Conveyancing

The Committee agreed that a new committee should be convened.

Working Party on Estate Agents

It was converted into a committee given the Law Society's statutory role under the Estate Agents Ordinance.

Committee Membership

There was a relatively large turnover of membership in the following committees:-

- Property Committee
- New Territories Conveyancing Committee
- Retirement Schemes Committee
- Company and Financial Law Committee
- Securities Law Committee

The Evidence (Amendment) Bill 1998: Admissibility of Electronic Documents

The Administration advised the Society that it proposed to amend the Evidence Ordinance by the Evidence (Amendment) 1998 and that it would push for priority of this Bill. In fact, the Administration conceded that the Evidence Ordinance required amending in order to permit the admissibility of documents stored electronically in civil proceedings. The Bill did not receive its 3rd reading in 1998 because of discussions on the proposals to abolish hearsay notices. As a result of the passage of this Bill, the possibility of members storing their old files electronically becomes much more attractive as these documents will now be admissible in civil court proceedings. In order to assist members' use of the latest technology, the Committee recommended the adoption of a regulatory framework to enable commercial providers to provide scanning services. As a result of that decision, a set of Guidelines was prepared on the handling of old files together with consequential amendments to the cessation of practice circular.

BILINGUALISM COMMITTEE

The Committee continues to discuss ways to promote and assist members in implementing a bilingual legal system. The major tasks of the Committee during the year included:

Use of Chinese in Court

To assist members in familiarising themselves with the use of Chinese in Court, arrangements were made with the Judiciary for the monthly lists of cases to be conducted in Chinese, to be provided to the Society on an ongoing basis. A Circular was issued on the arrangements. By making such information more accessible, the Committee hopes to encourage members to learn through the experience of their fellow practitioners.

Chinese Conveyancing Reference Materials

The Committee has received from the City University of Hong Kong the preliminary draft Chinese translations of targeted standard conveyancing documents and are now reviewing the Chinese translations in detail. It is hoped that after completion of the review, the documents will be circulated for general reference.

The Hong Kong Solicitors' Guide to Professional Conduct

The Committee arranged for the second edition of *The Hong Kong Solicitors' Guide to Professional Conduct* to be translated by the City University of Hong Kong.

Publications of Standard Legal Reference Books into Chinese

The Committee recommended to publishers, such as *Butterworths Asia (Hong Kong)* and *Sweet and Maxwell* that standard reference books be translated into Chinese. A meeting was held with one of the publishers to exchange views of mutual concern. A survey was also conducted to identify members' interest but the response was poor.

Hong Kong Lawyer

To enhance members' interest, bilingual articles are being published in alternative issues of the Society's official magazine, *The Hong Kong Lawyer*.

External Work:

The Chairman attends meetings of the Committee on a Bilingual Legal System, a centralised policy body established by the Government.

CIVIL LITIGATION COMMITTEE

This has been a relatively quiet year for the Civil Litigation Committee. Much of the improvement over the past year being that the Civil Court Users' Committee had been revamped under the chairmanship of Rogers J.A. The Committee has representatives from the Judiciary, the Law Society, the Bar, the Official Receiver's Office, the Legal Aid Department and the Department of Justice, addresses and tries to resolve problems experienced with the operation of the courts. The Chairman sits as the Law Society's representative on this Committee which is a useful vehicle to ventilate issues which have been raised by members.

The recession has inevitably increased the workload of the High Court Registry which is operating under Government budgetary constraints imposed when times were better and the amount of litigation less. Delays in the hearing of summonses and the listing of trial dates perceptibly increased and is detrimental to the interests of our clients. The Judiciary did try to juggle its resources and practitioners can assist by ensuring proper compliance with the rules and

BILINGUALISM COMMITTEE

With the view of helping to promote a bilingual legal system in Hong Kong the Committee's work during the year included:

Use of Chinese in the Courts

The Committee continues to arrange for the monthly list of court cases conducted in Chinese to be made available to members.

Chinese Conveyancing Reference Material

The Committee completed a preliminary review of the draft Chinese translation of eleven commonly used conveyancing documents and appointed a solicitor, who is experienced in Chinese translation, to conduct an overall editing exercise to ensure consistency in the translation. After completion of this exercise the Committee intends to circulate the completed work to members for reference.

Courses held in Chinese

To enhance members' interest in bilingualism, members of the Committee have conducted various CPD courses in Chinese.

Bilingualism within the Universities

The Committee investigated the number of law courses in Chinese being offered by the Universities and the popularity of such courses among students. It would seem that very few courses are being offered.

The Hong Kong Solicitors' Guide to Professional Conduct

The Committee sent the second edition of *The Hong Kong Solicitors' Guide to Professional Conduct* to the City University of Hong Kong for translation into Chinese. The work is not yet completed.

Publication of Standard legal reference books in Chinese

The Committee issued a questionnaire to members in order to gauge interest in Chinese legal reference books and has sent the results to *Butterworths Asia (Hong Kong)* for analysis.

External Work:**Committee on Bilingual Legal System**

The Chairman regularly attends meetings of the Committee on Bilingual Legal System which was set up by the Government and is chaired by the Secretary for Justice.

~~Most of the work of the Civil Litigation Committee in 1999 has been taken up with addressing practical problems arising from the explosion of litigation as part of the fall-out of the Asian economic crisis. This explosion has severely strained the resources of the courts which are having to deal with two or three times the number of cases than before with only a modest increase in staff and other resources. However, relief is on the horizon. The raising of the jurisdiction in the~~

ADR COMMITTEE

The Committee met on a number of occasions to consider the position of solicitors in the mediation process. The Committee prepared a proposal for the Council in relation to the creation of a Panel of Solicitor Mediators, which is under review. Member of the Committee also met with the Hong Kong Mediation Council to discuss the manner in which solicitor mediators should be accredited and placed on a Panel.

The Committee responded on behalf of the Society in relation to arbitration legislation, contributed to Law Week which had a mediation aspect, and met to review the operation of the Pilot Mediation Scheme which is being undertaken in the Family Court.

BILINGUALISM COMMITTEE

The Bilingualism Committee continues with its mission to promote the implementation of a bilingual legal system in Hong Kong. During the last year its work included:

Chinese Conveyancing Reference Material

The Committee completed its review of the Chinese translation of a selected set of conveyancing documents including forms and documents used in the Consent and Non-Consent Schemes. These translated documents were made available to members with the hope that they would

serve as useful reference material. The Committee is actively considering the translation of other legal documents into Chinese.

Courses held in Chinese

Members of the Committee conducted various CPD courses in Chinese in order to enhance members' interest in bilingualism.

The Committee also plans to organise a series of courses to improve members' general writing skills and ability to draft legal documents in Chinese. The assistance of the Chinese Language Centre of the Hong Kong Polytechnic University was secured. Members of the Committee have been attending the pilot course in order to assess whether it would suit the needs of the profession. By participating, Committee members can monitor the course and make recommendations on modification so that if and when the course is made available to the membership, it will suit their needs.

Use of Chinese in Court

The Committee continues to arrange for publication of the monthly lists of court cases conducted in Chinese.

Publication of standard legal reference books in Chinese

Due to the lack of members' response to a survey conducted last year to gauge members' interest in Chinese legal reference books, *Butterworths Asia (Hong Kong)* does not appear to be receptive to the recommendation that more Chinese legal reference books be published. However, the Committee will continue to liaise with *Butterworths* in this regard.

External Work:

Committee on Bilingual Legal System

The Chairman continues to represent the Society at meetings of the Committee on Bilingual Legal System, which was set up by the Government and is chaired by the Secretary for Justice.

CIVIL LITIGATION COMMITTEE

The most significant event in civil litigation was the long-awaited extension of the jurisdiction of the District Court. The District Court Rules have also been amended to bring them more in line with the High Court Rules.

As solicitors have a right of audience in all proceedings in the District Court, it is important this extension of jurisdiction is fully utilised. Experience gained in advocacy in the District Court will be invaluable to members who may wish to use their advocacy skills in the High Court if the Society is successful in its bid that higher rights of audience be extended to solicitors in the High Court.

We have as always been fortunate in the breadth of knowledge and experience of members of the Committee. The following items have been the subject of consideration:—

Debt Collection

A committee member represented the Society and sat as a member of the Law Reform Commission looking into debt collection. We have had the benefit of sight of draft papers prepared culminating in the final report.

Personal Injury

Much of the year was taken up in the gestation of the new Practice Direction on personal injury litigation. Our two representatives again showed sterling stuff in representing the interests of members. In tandem with the Bar and the Legal Aid Department, representations have been made to the Personal Injuries Judge as to the operation of the Personal injury list. There has also been valuable input from members who have monitored the working of personal injury litigation.

Higher Rights of Audience

This has been the subject of a separate working party chaired by a Council member. Encouraging progress has been made throughout the year, not least in Margaret Ng's endorsement in her election campaign of the wisdom of the general principle of extending rights of audience to solicitors in the High Court. We hope to build upon this foundation and work towards an extension of rights of audience which will provide greater competition for consumers without threatening the independence of the Bar or the integrity of the Rule of Law in Hong Kong.

Taxations

Through the medium of the Civil Court Users' Committee, the new Registrar of the High Court has accepted there may be a case for reform of the taxation system. However, a number of parties have an interest in this subject and their views need to be solicited before wholesale reform is embraced. It is one of the Chairman's personal reforms for 2001 to see the taxation process become quicker and more efficient.

The Personal Data (Privacy) Ordinance

This Ordinance seems to have created a wealth of problems since its enactment, not least because most laymen, as well as many practitioners, seem to misunderstand the purpose of the Ordinance and what it actually says. The Committee has been engaged in a dialogue with the Police as to the circumstances in which information will be released for the prosecution of civil actions and it is hoped that a consistent policy will be applied by the Police in the future.

BILINGUALISM COMMITTEE

The Bilingualism Committee continues to monitor and facilitate the implementation of a bilingual legal system in Hong Kong. Following the resignation of a member in August, 3 members were co-opted to join the Committee. Its work this year includes:

Courses Held in Chinese

The Committee planned to organise a series of Chinese language courses tailor-made for the legal profession. To ensure that the proposed courses would suit the needs of the profession, arrangements were made with the Chinese Language Centre of the Hong Kong Polytechnic University ("*PolyU*") for a pilot course to be conducted for members of the Committee. The pilot course was successfully completed in April and the Committee held several discussion sessions with representatives of the PolyU to review its structure and content. It is expected that the course will be made available to members in the near future.

In addition, members of the Committee have conducted various CPD courses in Chinese for the membership at large.

Translation of Commonly Used Legal Documents

As part of its ongoing project to provide members with commonly used legal documents in Chinese, the Committee held numerous discussions to identify the appropriate legal documents to be translated into Chinese. The main hurdle is a general lack of useful standard legal forms. In the course of deliberation, the Committee believed that it would be useful if standard bilingual conveyancing forms could be published. Recommendations were accordingly made for the Standing Committee on Practitioners Affairs to consider whether, as a matter of policy, the Society should settle and promote the use of standardised forms for conveyancing transactions.

Chinese Reference Material

On the recommendations of the Committee, the Society has acquired a series of Chinese reference texts and publications, and issued a Circular advising on these acquisitions.

Use of Chinese in Court

The Committee continues to make available to members a monthly list of court cases to be conducted in Chinese.

On-line Bilingual Corpus

The Committee considered an invitation by the PolyU to sponsor a research project to improve the comprehension of the translated Hong Kong statutes. Members attended a demonstration by representatives of the PolyU on the on-line bilingual corpus. It was noted that the proposed research project would enhance the use of the Bilingual Laws Information System ("*BLIS*"). Instead of switching between the bilingual versions, the product would enable users to access and compare bilingual versions of the law simultaneously. Members however believed that the proposed project would only be relevant to users of the BLIS if the linked up laws would be kept up-to-date. Given the need for constant updating, the Committee recommended inviting the Department of Justice, which supervised the BLIS, to support the project.

Judiciary Glossary of Legal Terms in Chinese

The Committee noted that there is a Glossary of Legal Terms in Chinese prepared by the Court Translation Office for internal reference and invited the Judiciary to consider releasing the Glossary for the benefit of the profession.

External Work:**Committee on Bilingual Legal System**

Although the shortage of matters to discuss led to the cancellation of a number of meetings this year, the Committee has not been entirely idle. Minor aspects of law reform, such as bills to facilitate Leapfrog Appeals to the Court of Final Appeal, to limit awards of costs in appeals from the Small Claims Tribunal, to amend the Landlord and Tenant Ordinance and to open up chambers hearings to the public have all been considered and commented upon by the Committee.

There have also been reforms in awards of costs, not least the adoption by the Masters of gross sum assessments in certain standard proceedings. However, the oft-repeated wish for a dramatic overhaul of Order 62 R.H.C. remains in the pending tray although the Committee is determined to ensure the rules on costs and taxations are dramatically simplified. On that front, a useful dialogue has been established with the recently created Hong Kong Law Costs Draftsmen Association.

Statistics show a welcome increase in the use of the District Court now its jurisdiction has been enlarged. The further extension of jurisdiction to be implemented in the future should give solicitors an opportunity to hone their advocacy skills and create a pool of qualified solicitor advocates who will be able to practise in the High Court when higher rights of audience are finally bestowed on solicitors.

CIVIL LITIGATION COMMITTEE

2001 has been a very quiet year for reform of civil litigation, primarily because there seemed little purpose in piecemeal reform if the whole system is to be subject to a radical overhaul.

The long awaited paper on Civil Justice Reform by the Chief Justice's Working Party was published in November. The Law Society's Working Party on the subject is preparing its own report which will comprehensively deal with the proposals for reform in the Chief Justice's Paper.

The Law Society and the Civil Litigation Committee support any proposal which will make the practice of civil litigation simpler, more efficient and more cost-effective. However, radical reforms should not be introduced simply because they have been adopted in other jurisdictions. Hong Kong's unique characteristics recognised by the Basic Law, such as the preservation of the common law system and the use of two official languages, make it important to preserve the integrity of the existing system whilst striving to improve its quality and efficiency of that system.

COMPANY AND FINANCIAL LAW COMMITTEE

BILINGUALISM COMMITTEE

The Bilingualism Committee continued to monitor and facilitate the implementation of a bilingual legal system in Hong Kong. The major areas of work it undertook this year include:

Judgments in Chinese and English

The Committee reviewed the concerns of a non-Chinese member on the lack of English translations of judgments in Chinese and sought clarification from the Judiciary on its policy on translating judgments. The Judiciary indicated it had insufficient resources to ensure all judgments would be available in both languages and dismissed the Committee's recommendation for at least those from the High Court and CFA be translated. They considered the present practice, whereby only judgments having "reference" value would be translated, has worked well.

Courses held in Chinese

The Committee continued to liaise with representatives of the Hong Kong Polytechnic University on conducting a series of Chinese language courses tailor-made for

the legal profession. In addition, members of the Committee conducted CPD courses in Chinese for the general membership.

Glossary of terms extracted from the Bilingual Standard Conveyancing Forms

The Committee is compiling an English-Chinese Glossary of the terms extracted from the bilingual standard conveyancing forms used in the Consent and Non-Consent Scheme, which have been previously published. It is hoped that the Glossary, when completed, would serve as one more useful reference tool.

Other Standard Conveyancing Forms

The Committee recommended the Society should produce its own bilingual standard conveyancing forms, and at the request of the Property Committee, conducted a survey to ascertain members' interest. A Working Party on Standard Conveyancing Forms comprising members of both the Property Committee and this Committee was set up for this purpose.

Publication on Legal Translation

The Committee noted a Chinese publication on Legal Translation, as edited by one of its members. The publication was co-authored by legal and translation professionals, members of the Judiciary, and the Department of Justice. As it is to be used as a working manual and legal translation textbook for the legal profession, a circular was issued in September drawing members' attention to the publication.

Use of Chinese in Court

The Committee continues to publish information on the monthly list of court cases to be conducted in Chinese.

Judiciary Glossary of Legal Terms in Chinese

The Committee has approached and secured the Judiciary's consent to release a Glossary of Legal Terms in Chinese prepared by the Court Translation Office. A circular with the Glossary was issued in June and members were invited to provide feedback.

Putonghua as an Official Court Language

The Committee considered a court case in which the status of Putonghua as an official language in Hong Kong was raised. Doubt was expressed on the scope of the word "Chinese" in Section 3 of the Official Languages Ordinance and whether it would also include all other Chinese dialects. Members noted the Judiciary's intention to maintain flexibility in the system and did not think the case raised any profound concern given that cases in which lawyers would insist on the use of Putonghua would be rare in practice.

CIVIL LITIGATION COMMITTEE

The Civil Litigation Committee met only once during the year as there was very little for the Committee to deal with given the on-going review of Civil Justice Reform by the Judiciary.

Reciprocal Enforcement of Foreign Judgments in Commercial Matters between the HKSAR and the Mainland

Members reviewed the Consultation Paper prepared by the Department of Justice and discussed the difficulties on Reciprocal Enforcement. A response was sent to the Department of Justice agreeing with the proposals in principle, and supporting enhanced enforcement of judgments between the HKSAR and the Mainland. However, the Department of Justice should take note of problems encountered in the enforcement of arbitral awards as the Foreign Judgment Reciprocal Enforcement Ordinance appears to be inadequate legislation to deal with this problem.

The Committee felt the Department of Justice should also deal with the lack of reciprocity on enforcement of judgments with the United Kingdom.

COMPANY AND FINANCIAL LAW COMMITTEE

During the year 2002 the Company and Financial Law Committee has been involved in considering, and setting forth their views on the following matters:-

- Draft Companies (Amendment) Bill 2002;
- Proposed Reform of the Registration System for Oversea Companies;
- Corporate Directors;

various ADR services which members, with the assistance of the Law Society, could offer to clients who do not wish to litigate. It is anticipated that a package of proposals will be sent to the Council for approval in 2004. The Committee discussed and made recommendations on the following issues:

HKIAC Panel of Arbitrators

The Committee had been concerned with the appointment procedures adopted by the HKIAC and after discussion put forward proposals to revise the procedures. The Committee is pleased to report that HKIAC has revised its procedures and welcomes the reforms.

Joint Consultative Council ("JCC")

HKIAC invited the Law Society to nominate representatives to sit on the JCC in order to improve communication between the HKIAC and the various stakeholders active in promoting ADR services. The Society representatives attended two meetings of the JCC.

Arbitration Ordinance

The Committee reviewed draft proposals to amend the Ordinance and sent submissions to the HKIAC.

Accreditation of Mediators by the Law Society

After lengthy in-house discussion involving several committees and two Standing Committees, Council endorsed a recommendation for the Law Society to implement its own scheme to accredit mediators.

In anticipation of promoting the use of mediation by members, the Committee has drafted the Law Society's own Mediation Rules.

Law Society's Panel of Arbitrators

Discussion has taken place on the feasibility of the Law Society establishing its own Panel of Arbitrators. This will continue throughout 2004 as there is a significant amount of work involved.

Law Society's Mediation/Arbitration Scheme

The Committee has put forward proposals for the Law Society to offer a Mediation/Arbitration Scheme in relation to disputed legal costs between solicitors and their clients without the need to proceed to taxation. An agreement together with rules of procedure have been drafted. The proposal will be considered by Council in 2004 together with other recommendations by the Committee.

Early Neutral Evaluation ("ENE")

ENE is a process which enables parties to obtain a non-binding reasoned evaluation of their case from an experienced neutral third party. Discussion is on-going and the issues in relation to accreditation and the establishment of a Panel of Evaluators will continue.

BILINGUALISM COMMITTEE

The Bilingualism Committee continued its efforts to facilitate the implementation of a bilingual legal system in Hong Kong. Its work this year included:

Course in Chinese

To supplement the Chinese CPD courses offered by the Society, the Committee explored the

prospect of offering a series of regular courses to improve members' skill in writing and drafting correspondence and legal documents in Chinese. The assistance of the Chinese Language Centre of the Hong Kong Polytechnic University ("PolyU") was secured to organise a Chinese language course tailor-made for the legal profession. The Committee expressed concerns over the proposed course structure and the insufficient legal elements and invited PolyU to review the proposed course outline. Members of the Committee also conducted CPD courses in Chinese for the general membership.

Glossary of terms extracted from the Bilingual Standard Conveyancing Forms

The Committee continued to compile an English-Chinese Glossary of terms extracted from certain bilingual conveyancing forms it published in 2000.

Judiciary's Glossary of Legal Terms in Chinese

The Committee liaised with the Judiciary Administrator's Office ("JAO") on the need to regularly update the Judiciary's Glossary of Legal Terms in Chinese. The JAO indicated it will introduce an electronic data reference system, and would make a context-based glossary of legal terms available on the web.

Proposed Research on Bilingual Legal Communication

The Committee considered a request by two Associate Professors of the Hong Kong Baptist University for assistance in a research project on bilingual legal communication. The Committee was concerned with the practical difficulties as disclosure of solicitor-client communication would breach the duty of confidentiality. The Committee invited the Associate Professors to elaborate on their research project and suggested approaching the Duty Lawyer Service and the Legal Aid Department.

Publication on Legal Translation

The Committee noted the various publications by the Department of Justice ("DOJ") on topics relating to legal bilingualism. Whilst these are intended by the DOJ for internal circulation, the Committee asked DOJ to make them available to the profession. The Committee also recommended as a useful reference tool a bilingual publication on criminal case law co-edited by a Committee member.

ADR COMMITTEE

The ADR Committee has worked on a comprehensive approach designed to further solicitors' involvement in future areas of work in ADR. Last year saw the implementation of the Panel of Mediator/Solicitors by the Society. The Committee made proposals to the Council for consideration of establishing a Law Society Panel of Solicitor/Mediators for claims under the Professional Indemnity Scheme which has been adopted.

An innovative approach was taken in light of possible changes to the civil litigation forum. Draft agreements and rules were also prepared for solicitor/mediators to conduct Early Neutral Evaluation under a possible Law Society Panel arrangement. The Committee discussed the preparation of a Law Society Arbitration Scheme to offer solicitor arbitrators' services. A paper on a mediation scheme for legal costs was prepared for consideration by the Council.

In order to enhance the Society's profile in ADR and in view of the possible range of services to be offered in the future, it was agreed to prepare a Law Society Brochure on ADR services. A first draft has been reviewed and a budget has been requested for production.

Bilingual Conveyancing Documents - Glossary of terms

The Committee compiled an English-Chinese Glossary of terms extracted from bilingual conveyancing forms it published in 2000 and issued a circular in August making the Glossary available to members.

Bilingual Conveyancing Documents – Updating of the Documents

The Committee noted the Lands Department completed its comprehensive review of the Consent Scheme and that the relevant forms had been revised. It decided to update these bilingual forms and issued a circular in November to clarify the fact that the latest revisions by the Lands Department had not been included in the published forms.

Bilingual Legal Resources

The Committee believed it would be helpful if bilingual legal resources could be identified and highlighted. It considered 3 separate draft lists compiled of: (a) Bilingual Legal Websites; (b) Chinese/Bilingual Legal Publications; and (c) reference material in the Law Society library.

Consultation with members

The Committee posted a discussion topic "*Bilingualism in Legal Practice*" on the Bulletin Board of the Society's website in order to publicize the Committee's work and to facilitate an exchange of views in order to understand members' needs.

Seminar on "Selected Bilingual Legal Websites – Search Tips"

In reviewing the draft list of bilingual legal websites, the Committee considered a seminar on the use of selected websites would be helpful. To ensure the seminar would be of practical benefit to the profession, a trial demonstration was conducted in October when representatives from the DOJ, the Judiciary and the Hong Kong Legal Information Institute were invited to provide a demonstration to Committee members on their respective websites.

Specialist Accreditation Scheme

CIVIL LITIGATION COMMITTEE

The highlight of the year was the publication of the Final Report on Civil Justice Reform by the Chief Justice's Working Party on Civil Justice Reform. The Report was welcomed by the Society because it endorsed the Society's view that the introduction of a whole new system of civil procedure analogous to that in England was not the best way forward for Hong Kong. Instead, the Report agreed with the Society's submission that the existing Rules of the High Court could, with modification and more vigorous enforcement, remedy many of the defects presently existing in the system of civil litigation.

The reforms envisaged in the Report now await implementation. Drafting is underway to amend both legislation and the Rules of the High Court and it is expected in 2005 that these amendments will be forthcoming notwithstanding on a piecemeal basis.

The Committee can therefore look forward to an increased workload over the next year or so which will make up for the fact that 2004 has probably been the quietest year for the Committee for many years. There is understandably no enthusiasm on the part of the Judiciary or practitioners for minor changes in procedure before the overhaul envisaged by the Report. Certain administrative matters have been raised with

Bilingual Conveyancing Documents - Updating of the Documents

The Committee embarked on an updating exercise on the bilingual conveyancing documents it published in 2000. The Chinese translations of the Consent Scheme and Non-Consent Scheme documents are being updated to take account of the changes made to the original English text since 2000; the Glossary of terms extracted from the documents has to be reviewed as well. The Committee hopes to complete this task and circulate the updated documents in 2006.

Bilingual Legislation

The Committee considered and supported the DOJ's proposal to standardize the Chinese translations of the terms "bailment", "bailor" and "bailee" in the Laws of Hong Kong.

Chinese Judgments

The Committee discussed the concern raised by some members on the lack of English versions of Chinese judgments. The issue was raised in 2002 when the Judiciary cited that insufficient resources meant that only Chinese judgments having "reference" value would be translated

into English. Given the increase of Chinese judgments and the importance for legal precedents to be comprehensible to both the legal profession and the Judiciary, the Committee has reiterated its concern to the Judiciary Administrator.

Proposed Course on the Use of Chinese in Legal Practice

The Committee reviewed the Law Society courses offered in Chinese and members' feedback. A small group was appointed to study a proposal to organize structured Chinese courses.

Standard Sale and Purchase Agreement

The Committee noted the work of the Working Party on Standard Conveyancing Forms on the collation of a standard Sale and Purchase Agreement form ("standard SPA form") for use in the secondary property market. It emphasised to the Standing Committee on Practitioners Affairs the need for the Law Society to publish standardized terms and clauses in conveyancing practice in bilingual format when considering the policy to adopt on the publication of the standard SPA form.

The English-Chinese Glossary of Legal Terms (4th edition)

The Committee issued a circular to inform members of the publication of the 4th edition of "*The English-Chinese Glossary of Legal Terms*" by the DOJ.

Webpage for "Bilingual Legal Reference Material"

The Committee has published bilingual legal reference material, including: a set of bilingual conveyancing documents published in 2000, the Judiciary's *Glossary of Legal Terms* circulated with the consent of the Judiciary in 2002, a series of Chinese reference texts and legal publications it acquired for members' reference, etc. A separate webpage has been created on the Law Society's website for "*Bilingualism Legal Reference Material*" in order to centralize all reference material as a useful on-line bilingual legal reference library. A circular was issued on the launch of the webpage.

CIVIL LITIGATION COMMITTEE

The Civil Litigation Committee met five times during the year.

Civil Justice Reform

The Committee was advised of the Judiciary's proposal to introduce an electronic filing system and representatives attended a briefing at the High Court in May. The Judiciary indicated it wished to receive feedback from the Law Society on additional procedures which could be introduced on a test basis but which would not require any changes to the existing *High Court Rules*.

Members noted the Judiciary does not provide any regular progress report on the implementation of the proposed reforms, and it was agreed the Committee will make a proposal for the matter to be placed as a standard item on the agenda of the Civil Court Users Committee.

Review of Judiciary's Practice Directions

The Judiciary circulated copies of draft Practice Directions 25.1 and 25.2 which were based on the recommendations contained in the report published by the Working Party on Civil Proceedings Conducted in Private. Members noted the draft referred to High Court Rules 100 and 103 concerning Trade Marks and Patents and queries were raised on the failure to introduce amendments as the law had changed in 1997. The Judiciary indicated the draft rules were being circulated and it is hoped they can be introduced in 2006. Members also noted a new Practice Direction 11.3 on Vexatious Litigants.

Lands Tribunal Review

Members reviewed the paper setting out the background to the Judiciary's review of the operation of the Lands Tribunal which made recommendations to improve the efficiency of the processing of claims in the Tribunal and proposed a rationalisation of the division of the work in respect of land and tenancy-related claims, and the practising procedure of the Court of First Instance, the District Court and the Lands Tribunal. The Committee endorsed the recommendations but indicated adequate resources should be allocated to the Bailiff's Office.

Gross Sum Assessment ("GSA")

The Registrar and the Taxing Masters had prepared a draft pro forma for GSA pursuant to HCR Order 62(9)(4)(b). Members noted the proposal required practitioners to conduct a mini taxation exercise in order to extract the relevant information to complete the proposed form. The purpose of GSA is to avoid a mini taxation and provide an expeditious assessment of costs for interlocutory applications. A meeting took place between the Registrar and several Taxing Masters on 29 November and consensus was reached that a chronological approach was practical as firms break their days into hourly charging unit. The Registrar provided a revised form which the Committee subsequently endorsed and the new procedures will be implemented in January 2006.

BILINGUALISM COMMITTEE

The Bilingualism Committee has taken the following steps this year to assist the profession to meet the challenges of a developing bilingual legal system:

Bilingual Conveyancing Documents - Updating exercise

The Committee continued the updating exercise on the bilingual conveyancing documents it published in 2000, including a thorough review of the proposed amendments to the Chinese translations of the Consent Scheme and Non-Consent Scheme documents, taking into account the changes made to the English version since 2000. It sought clarification from the Property Committee on the appropriate interpretation on some of the clauses in the forms.

Proposed Courses on “Use of Chinese in Legal Practice”

The Committee reviewed the CPD courses offered by The Law Society in Chinese and members’ feedback. A Subcommittee was convened and recommended The Law Society should conduct a series of courses to promote

Chinese language advocacy skills of members in different types of legal proceedings. Judges experienced in Chinese legal proceedings were invited to conduct courses in Civil Litigation, Lands Tribunal, Matrimonial and Criminal Litigation.

Proposed Structured Advocacy Courses in Chinese

The Committee was consulted by the CPD Committee on the proposed outline of a Structured Advocacy Course, which included “*Chinese Advocacy*” as one of its modules. Given the wider use of Chinese in court proceedings, the Committee recommended developing a separate series of Structured Advocacy Courses in Chinese and enlisting the support of the Judiciary.

Translation of Chinese Judgments into English

The Committee continued its discussion with the Judiciary on English translations of all Chinese judgments. This was raised with the Judiciary in 2002 when the Judiciary indicated that Chinese judgments having a “*reference*” value would be translated into English. The Committee sought a change in this policy and in response, the Judiciary established a Screening Committee to systematically identify Chinese judgments of jurisprudential value for translation into English. As only some Chinese judgments have been translated into English, the Judiciary has issued a Practice Direction on “*Citation of judgments written in Chinese at hearings conducted in English*”.
