佩戴安全帶的法例要求：
   
 Some legal requirements for wearing seat belts:

私家車 Private Cars

<div>1. 司機和所有乘客 (包括小童)</div> <div>Drivers and all passengers (including children)</div>	<div>如座位裝有安全帶，則必須佩戴。 Seat belts must be worn if fitted.</div> <div></div>									
<div>2. 小童 Children</div>	<div>如前座乘客不足3歲，司機須讓該小童使用合符規格的兒童安全座椅；如車內備有兒童安全座椅，司機也必須讓坐在後座不足3歲的小童使用該設備。 If front seat passengers aged less than 3, the drivers must provide approved child restraint devices for their use; the drivers must also use child restraint devices for children, aged less than 3, sitting in the rear seats if such devices are available for use.</div> <div>使用合符規格的兒童安全座椅時，要緊記遵照座椅生產商的安裝指引，確保將安全座椅穩固地安裝於汽車座位上。以下是一些安全座椅使用範例。 When using approved child restraint device, the manufacturer's instructions should be strictly followed to ensure the child restraint device is securely fastened onto the passenger seat. 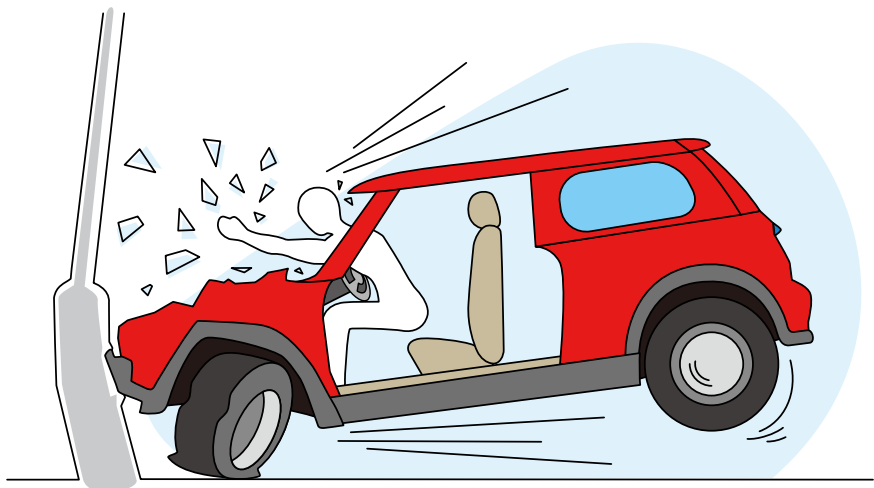
任何人違反佩戴安全帶相關規定，可被判處罰款\$5,000及監禁三個月。

Offenders contravening regulations on wearing seat belts are liable to a fine of \$5,000 and 3 months' imprisonment.

# 為何佩戴安全帶？ Why buckle up?

如你沒有佩戴安全帶，當發生交通事故時，你可能會因高速撞向標板或車廂內其他設備而受到嚴重傷害，甚至被拋出車外。佩戴安全帶可保平安。

Without a seat belt, you may be seriously injured in the event of traffic incident. Your body may hit the dash board or other equipment inside vehicle compartment, or even be thrown out of the car. Wearing seat belt may save your life!



## 溫馨提示 Smart Tips

1. 如的士或公共小巴乘客拒絕佩戴安全帶，司機可以拒絕駕駛。乘客亦可會被要求繳付車費及離開車輛。

A taxi or public light bus driver may refuse to drive if a passenger refuses to wear seat belt. The passenger may be required to pay the fare and leave the vehicle.

2. 除獲運輸署署長的書面豁免外，所有乘客（包括孕婦）都必須按照相關規定佩戴安全帶。

All passengers (including pregnant woman) should wear seat belts according to relevant regulations, unless they have obtained exemption in writing by the Commissioner for Transport.

3. 乘客切勿手抱嬰兒或與嬰兒共用一條安全帶，應盡量使用符合嬰兒年齡的認可兒童安全座椅。

Passengers should not hold the baby in their arms or share a seat belt with the baby. It is advised to use the approved child restraint device that suits the age of the baby.
