The Administration responded that the display of bills and posters was regulated by the Public Health and Municipal Services Ordinance (Cap. 132) ("PHMSO"), which stipulated that no bill or poster could be displayed or affixed in public or private places except with written permission. The existing provisions under the electoral legislation served only to reflect such requirement by requiring a candidate to provide the Returning Officer with a copy of any such written permission obtained for the display or exhibition of an EA. Having regard to members' concern, the Registration and Electoral Office had forwarded members' suggestion to simplify the existing procedural requirement for seeking permission to the Food and Environmental Hygiene Department for consideration.
