Bills Committee on Electoral Legislation (Miscellaneous Amendments) Bill 2012

Proposed Committee Stage Amendments

This paper sets out the Administration's proposed Committee Stage Amendments ("CSAs") to the Electoral Legislation (Miscellaneous Amendments) Bill 2012 ("the Bill").

- 2. At the meeting on 29 March 2012, we explained our proposals to introduce CSAs to amend various pieces of electoral legislation to clarify the provisions in the District Council (second) function constituency ("DC (second) FC"), to provide for the refined arrangement of mixing ballot papers to speed up the counting process, to amend the format of voter register, to update the names of constituents of function constituencies and to fine-tune the voting arrangement for an agency or an office of overseas governments. For details of the proposals, please refer to the Bills Committee paper issued for the meeting on 29 March 2012.
- 3. In light of the discussion at the Bills Committee and Members' views in addition to the amendments covered in the earlier paper, we further propose to amend the numbering of the lists of candidates for the DC (second) FC, to take forward the amendment to the voter register format and to propose some other textual amendments. The draft CSAs proposed by the Government are set out at the **Annex**.

Numbering system for the lists of candidates for the DC (second) FC

4. Under the existing legislation, a code is assigned to each FC including the DC (second) FC and such a code will be printed in conjunction with the number assigned to each candidate or list of candidates¹ on the ballot paper of the concerned constituency; and for the geographical constituencies ("GCs"), a list of candidates is assigned a number and the number will be printed on the ballot paper of the concerned constituency. As most of the GC electors are expected to be registered as electors for the DC (second) FC, it may be confusing to them when they cast their vote if the lists of candidates for both GCs and the DC (second) FC are referred to by the same numbering system starting from 1 and followed by 2, 3, 4, and so on. To avoid such confusion, a new numbering

system for the lists of candidates for the DC (second) FC is proposed, with the number for the lists of candidates starting from 101 and followed by 102, 103, 104 and so on. CSAs will be introduced to effect this proposal.

Voter register format

5. As regards the format of voter register, to facilitate the public to identify irregularities in respect of residential addresses, we propose to introduce CSAs to amend sections 13 and 20 of the Electoral Affairs Commission (Registration of Electors) (Legislative Council Geographical Constituencies) (District Council Constituencies) Regulation (Cap. 541A) to empower the Electoral Registration Officer to make available an additional copy of the voter register in a format which he considers appropriate for public inspection. With the amendment, the voter register can set out the names of the electors in accordance with their principal residential addresses apart from the original format which sets out electors in accordance with their names, so as to facilitate electors to identify any irregularities when they inspect the registers.

Other textual amendments

6. In response to the suggestions made by the Assistant Legal Adviser, we propose to introduce CSAs to make several textual amendments to the Bill.

Advice sought

7. Members' views are sought on the above proposals and the proposed draft CSAs at the Annex.


