The Chief Secretary for Administration, the Secretary for Education, the Secretary for Food and Health, the Secretary for Labour and Welfare and the Secretary for Commerce and Economic Development spoke on the motion.

The Financial Secretary replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

### Committee stage

The Council went into committee and considered the Appropriation Bill 2012.

In accordance with Rule 68 of the Rules of Procedure, the committee first considered the Schedule to the Bill.

Hon Albert CHAN moved that head 21 be reduced by \$93,069,000 in respect of subhead 000 and spoke on the amendment.

While Hon Albert CHAN was speaking, the Chairman left the chair at 1:06 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Three Members spoke on the amendment.

The Secretary for Constitutional and Mainland Affairs spoke on the amendment.

Hon Albert CHAN spoke again.

Question on the amendment put.

Hon Albert CHAN claimed a division. The Chairman's Deputy then ordered the committee to proceed to a division.

At 1:53 pm, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 19 were present and 19 were against the amendment; while among the Members returned by geographical constituencies through direct elections, 23 were present, three were in favour of the amendment and 19 against it (voting record in **Appendix 1**).
