Bills

Hon LEUNG Kwok-hung drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting. A quorum was then present.

First Reading

Supplementary Appropriation (2011-2012) Bill

The Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure.

Second Reading

Supplementary Appropriation (2011-2012) Bill

The Secretary for Financial Services and the Treasury moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Competition Bill

Committee stage

The Council went into committee and continued to consider original clauses 1 and 35 of the Bill and the amendments thereto.

Hon Albert CHAN spoke on the amendments.

While Hon Albert CHAN was speaking, the Chairman left the chair at 1:34 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Two other Members spoke on the amendments.

Hon Albert CHAN spoke on the amendments for the second time.

At 2:48 pm, while Hon Albert CHAN was speaking, the Chairman resumed the chair.

Eight more Members spoke on the amendments.

The Secretary for Commerce and Economic Development spoke again.

Question that amendments to clauses 1 and 35(4A), (4B) and (5) moved by Hon Mrs Regina IP put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, five were in favour of the amendments, 13 against them and two abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, five were in favour of the amendments, 19 against them and two abstained (voting record in **Appendix 1**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 1 stand part of the Bill proposed and put.

Hon Albert CHAN claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 47 Members were present, 38 were in favour of the motion, two against it and six abstained (voting record in **Appendix 2**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Hon Mrs Regina IP moved an amendment to clause 35(1).

Question on the amendment put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, 10 were in favour of the amendment, seven against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 17 were in favour of the amendment, six against it and two abstained (voting record in **Appendix 3**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Secretary for Commerce and Economic Development moved amendments to clause 35.

Question on the amendments put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 46 Members were present, 39 were in favour of the amendments and six abstained (voting record in **Appendix 4**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 35 as amended stand part of the Bill proposed and put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 43 Members were present, 37 were in favour of the motion and five abstained (voting record in **Appendix 5**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Question that clauses 3, 4, 5, 9, 24 and Schedule 7 stand part of the Bill proposed.

New clause 5A read the first time.

The Chairman stated that Hon Ronny TONG had given notice to move the deletion of clauses 3, 4 and 5, and amendments to clauses 2, 9, 24 and Schedule 7. Hon Mrs Regina IP had given notice to move amendments to clauses 3 and 5. Hon Albert HO had given notice to move the addition of new clause 5A. The Chairman further stated that the Secretary for Commerce and Economic Development had also given notice to move amendments to Schedule 7.

The Chairman added that if Hon Ronny TONG's amendments to clauses 2, 3, 4, 5, 9, 24 and Schedule 7 were passed, Hon Mrs Regina IP might not move her amendments to clauses 3 and 5, and Hon Albert HO might not move the addition of new clause 5A. Irrespective of whether or not the amendments moved by Hon Ronny TONG were passed, the Secretary for Commerce and Economic Development might move his amendments to Schedule 7. In addition, irrespective of whether or not the amendments to clauses 3 and 5 moved by Hon Regina IP were passed, Hon Albert HO might move the addition of new clause 5A.

The Chairman ordered that clauses 3, 4, 5, 9, 24 and Schedule 7 and the amendments thereto be debated together in a joint debate.

Hon Albert HO declared that he was a member of the Board of the Airport Authority, which was a statutory body.

Hon James TO declared that he was a non-executive director of the Urban Renewal Authority.

Hon Ronny TONG moved the deletion of clauses 3, 4 and 5 and amendments to clauses 2, 9, 24 and Schedule 7 and spoke on the amendments.

Two Members and the Secretary for Commerce and Economic Development spoke on the amendments.

A Member spoke on the amendments.

Before Hon Andrew LEUNG spoke on the amendments, he declared that he was a member of the Legislative Council Commission, a non-executive Director of the Mandatory Provident Fund Schemes Authority, Chairman of the Advisory Board of the International Cuisine College and Design Institute under the Vocational Training Council, a Council Member of the Trade Development Council, a non-executive Director of the Hong Kong Mortgage Corporation

Limited, as well as the Honorary President and a General Committee Member of the Federation of Hong Kong Industries. He then spoke on the amendments.

A Member spoke on the amendments.

Before Hon Jeffrey LAM spoke on the amendments, he declared that he was a Council Member of the Hong Kong Trade Development Council, a Board Member of the Airport Authority, a Board Member of the West Kowloon Cultural District Authority, and a General Committee Member of the Federation of Hong Kong Industries. He then spoke on the amendments.

Two Members spoke on the amendments

Hon WONG Yuk-man spoke on the amendments and declared that Hon Albert CHAN, a member of People Power, had set up a Commune Populaire recently.

Hon Albert CHAN spoke on the amendments for the second time.

While Hon Albert CHAN was speaking, the Chairman left the chair at 7:32 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

A Member spoke on the amendments.

Dr Hon Margaret NG spoke on the amendments for the second time.

Hon Albert CHAN spoke on the amendments for the third time.

Dr Hon Margaret NG spoke on the amendments for the third time.

At 8:29 pm, while Dr Hon Margaret NG was speaking, the Chairman resumed the chair.

Before Hon Abraham SHEK spoke on the amendments, he declared that he was a member of the Board of the MTR Corporation Limited, a member of the Court of the University of Hong Kong, a member of the Council of The Hong Kong University of Science and Technology and a director of several companies.

Four more Members spoke on the amendments.

Hon LEUNG Kwok-hung spoke on the amendments for the second time.

By the time the meeting was suspended, the Chairman and the Chairman's Deputy had directed the Clerk to summon Members to the meeting for eight times as Members had drawn their attention to the absence of a quorum. Each time a quorum was then present.

The Chairman suspended the meeting at 9:53 pm.

* * * * * *

The committee resumed at 9:00 am on 14 June 2012.

The Chairman stated that the committee continued to examine the original provisions of clauses 3, 4, 5, 9 and 24, Schedule 7 and the new clause 5A, as well as the amendments thereto.

Hon Albert CHAN drew the attention of the Chairman to the absence of a quorum. The Chairman directed the Clerk to summon Members to the meeting. A quorum was then present.

The Chairman reminded Members that in order not to while away the meeting time owing to the need to ring the quorum bell to summon Members back to the Chamber, Members should try to hurry back to the Chamber whenever the quorum bell rang.

The Chairman further stated that he would consult Members on the need to take measures to make up for the time lost in waiting for a quorum, such as postponing the ending time of the meeting at night so that the various business items originally scheduled to be completed within the limited meeting time would not be affected.

Fifteen Members spoke on the amendments.

The Secretary for Commerce and Economic Development and Hon Ronny TONG spoke on the amendments.

Question on the amendments moved by Hon Ronny TONG put.

Hon Ronny TONG claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, two were in favour of the amendments, 13 against them and five abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 14 were in favour of the amendments, seven against them and four abstained (voting record in **Appendix 6**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 2 as amended stand part of the Bill proposed, put and agreed to.

Question that clauses 4, 9 and 24 stand part of the Bill proposed, put and agreed to.

Hon Mrs Regina IP moved amendments to clauses 3 and 5.

Question on the amendments put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, three were in favour of the amendments, 13 against them and six abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, five were in favour of the amendments, six against them and 15 abstained (voting record in **Appendix 7**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clauses 3 and 5 stand part of the Bill proposed, put and agreed to.

Hon Albert HO moved the Second Reading of new clause 5A.

Question on the Second Reading of new clause 5A proposed and put.

Hon Albert HO claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, three were in favour of the motion, 13 against

it and six abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, 14 were in favour of the motion, seven against it and five abstained (voting record in **Appendix 8**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

The Secretary for Commerce and Economic Development moved amendments to Schedule 7.

Question on the amendments put and agreed to.

Question that Schedule 7 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 129 stand part of the Bill proposed.

The Chairman stated that Hon LEUNG Kwok-hung had given notice to move an amendment to clause 129.

Hon LEUNG Kwok-hung moved an amendment to clause 129 and spoke on the amendment.

The Chairman ordered that clause 129 and the amendment thereto be debated together in a joint debate.

Three Members and Dr Hon LAM Tai-fai spoke on the amendment.

While Dr Hon LAM Tai-fai was speaking, the Chairman left the chair at 12:51 pm temporarily and the Chairman's Deputy, Hon Fred LI, took the chair.

Another Member spoke on the amendment.

The Secretary for Commerce and Economic Development and Hon LEUNG Kwok-hung spoke again.

Question on the amendment moved by Hon LEUNG Kwok-hung put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

At 1:36 pm, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 18 were present, three were in favour of the amendment, 13 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 14 were in favour of the amendment, four against it and two abstained (voting record in **Appendix 9**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 129 stand part of the Bill put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 36 Members were present, 31 were in favour of the motion and four abstained (voting record in **Appendix 10**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

New clauses 57A, new heading before new clause 80A, new clause 80A and new clause 153A read the first time.

The Secretary for Commerce and Economic Development moved the Second Reading of the aforesaid clauses and heading, and spoke on the new clauses and heading.

Question on the Second Reading of the aforesaid clauses and heading proposed, put and agreed to.

New clause 57A, new heading before new clause 80A, new clause 80A and new clause 153A read the second time.

The Secretary for Commerce and Economic Development moved the addition of the aforesaid clauses and heading to the Bill.

Question on the addition proposed, put and agreed to.

New clause 162A read the first time.

Question that Schedule 1 stand part of the Bill proposed.

The Chairman stated that the Secretary for Commerce and Economic Development had given notice to move the addition of new clause 162A and amendments to Schedule 1. In addition, Hon Ronny TONG had given notice to move an amendment to Schedule 1.

The Chairman further stated that if the Second Reading or the addition of new clause 162A moved by the Secretary for Commerce and Economic Development was negatived, the Secretary for Commerce and Economic Development and Hon Ronny TONG might not move their amendments to Schedule 1. If the motion on the addition of new clause 162A was passed, the Secretary for Commerce and Economic Development might move his amendments to Schedule 1. In addition, if the amendments to Schedule 1 moved by the Secretary for Commerce and Economic Development was passed, Hon Ronny TONG might not move his amendment to Schedule 1. However, if the amendments to Schedule 1 moved by the Secretary for Commerce and Economic Development was negatived, Hon Ronny TONG might move his amendment to Schedule 1.

The Chairman ordered that the addition of new clause 162A, the original provisions of Schedule 1, and the amendments thereto be debated together in a joint debate.

The Secretary for Commerce and Economic Development moved the Second Reading of new clause 162A and spoke on the new clause.

Question on the Second Reading of new clause 162A proposed.

Six Members spoke on the new clause and the amendments.

By the time the meeting was suspended, the Chairman and the Chairman's Deputy had directed the Clerk to summon Members to the meeting for three times (in addition to the one time when Hon Albert CHAN drew the attention of the Chairman to the absence of a quorum immediately after the committee resumed at 9:00 am) as Members had drawn their attention to the absence of a quorum. Each time a quorum was then present.

The Chairman suspended the meeting at 2:37 pm.

The committee resumed at 4:50 pm.

A Member spoke on the new clause and the amendments.

The Secretary for Commerce and Economic Development spoke again.

The Chairman reminded that if the Second Reading of new clause 162A moved by the Secretary for Commerce and Economic Development was negatived, the Secretary and Hon Ronny TONG might not move their amendments to Schedule 1.

Question on the Second Reading of new clause 162A put.

Dr Hon Margaret NG claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 43 Members were present, 39 were in favour of the motion and three against it (voting record in **Appendix 11**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

New clause 162A read the second time.

The Secretary for Commerce and Economic Development moved the addition of new clause 162A to the Bill.

Question on the addition proposed, put and agreed to.

The Secretary for Commerce and Economic Development moved amendments to Schedule 1.

Question on the amendments put.

Hon Albert CHAN claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 47 Members were present, 33 were in favour of the amendments, 12 against them and one abstained (voting record in **Appendix 12**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that Schedule 1 as amended stand part of the Bill proposed, put and agreed to.

Question that Schedule 4 stand part of the Bill proposed, put and agreed to.

Question that Schedules 2, 3, 6, 8 and 9 stand part of the Bill proposed.

The Secretary for Commerce and Economic Development moved amendments to Schedules 2, 3, 6, 8 and 9 and spoke on the amendments.

Question on the amendments to Schedule 2 put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 41 Members were present, 39 were in favour of the amendments and one abstained (voting record in **Appendix 13**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that Schedule 2 as amended stand part of the Bill proposed and put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 40 Members were present, 38 were in favour of the motion and one abstained (voting record in **Appendix 14**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Question on the amendments to Schedules 3, 6, 8 and 9 put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 42 Members were present, 39 were in favour of the amendments, one against them and one abstained (voting record in **Appendix 15**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that Schedules 3, 6, 8 and 9 as amended stand part of the Bill proposed and put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 38 Members were present, 34 were in favour of the motion, one against it and two abstained (voting record in **Appendix 16**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Question on Schedule 5 stand part of the Bill proposed.

The Chairman stated that the Secretary for Commerce and Economic Development had given notice to move amendments to Schedule 5. In addition, Hon LEUNG Kwok-hung had also given notice to move an amendment to Schedule 5.

The Chairman further stated that irrespective of whether or not the amendments moved by the Secretary for Commerce and Economic Development were passed, Hon LEUNG Kwok-hung might move his amendment to Schedule 5.

The Chairman ordered that the original provisions of Schedule 5 and the amendments thereto be debated together in a joint debate.

The Secretary for Commerce and Economic Development moved amendments to Schedule 5 and spoke on the amendments.

Another Member and Hon LEUNG Kwok-hung spoke on the amendments.

While Hon LEUNG Kwok-hung was speaking, the Chairman left the chair at 6:27 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Hon Albert CHAN spoke on the amendments.

At 7:35 pm, while Hon Albert CHAN was speaking, the Chairman resumed the chair.

Hon WONG Yuk-man, Hon LEUNG Kwok-hung and 5 other Members spoke on the amendments. While Hon WONG Yuk-man and Hon LEUNG Kwokhung were speaking, the Chairman repeatedly reminded them that their speech should be relevant to the amendments and should not be repetitive.

The Secretary for Commerce and Economic Development spoke again.

Question on the amendments moved by the Secretary for Commerce and Economic Development put and agreed to.

Hon LEUNG Kwok-hung moved his amendment to Schedule 5.

Question on the amendment put.

Hon LEUNG Kwok-hung claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 18 were present, four were in favour of the amendments and 14 against them; while among the Members returned by geographical constituencies through direct elections, 20 were present, 14 were in favour of the amendments and five against them (voting record in **Appendix 17**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that Schedule 5 as amended stand part of the Bill proposed, put and agreed to.

By the time the Council resumed, the Chairman and the Chairman's Deputy had directed the Clerk to summon Members to the meeting for eight times as Members had drawn their attention to the absence of a quorum. Each time a quorum was then present.

The Council then resumed.

Third Reading

The Secretary for Commerce and Economic Development reported that

the Competition Bill

had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure.

The Secretary for Commerce and Economic Development moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

Five Members spoke on the Bill.

Question on the Third Reading put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division.

The President announced that 37 Members were present, 31 were in favour of the motion and five abstained (voting record in **Appendix 18**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.

The President suspended the meeting at 10:04 pm.

Resumption of Second Reading debate

The President's Deputy announced that 37 Members were present and 36 were in favour of the motion (voting record in **Appendix 19**). Since the question was agreed by a majority of the Members present, she declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

Question that clause 8 as amended stand part of the Bill proposed, put and agreed to.

Question that Schedule 2 stand part of the Bill proposed, put and agreed to.

Question that Schedule 1 stand part of the Bill proposed.

The Secretary for Justice moved an amendment to Schedule 1 and spoke on the amendment.

Question on the amendment put.

Hon WONG Yuk-man claimed a division. The Chairman's Deputy then ordered the committee to proceed to a division.

The Chairman's Deputy announced that 37 Members were present and 36 were in favour of the amendments (voting record in **Appendix 21**). Since the question was agreed by a majority of the Members present, she declared that the amendment was passed.

Question that Schedule 1 as amended stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Justice reported that

the Mediation Bill

had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure.

The Secretary for Justice moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

Two Members spoke on the Bill.

Question on the Third Reading put and agreed to.

Bill read the third time and passed.

Mandatory Provident Fund Schemes (Amendment) (No. 2) Bill 2011
