The President suspended the meeting at 1:22 pm.

* * * * * * *

The Council resumed at 2:20 pm.

The President stated that the Chief Secretary for Administration had made a request to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 18 of the Rules of Procedure, so that the Council could deal with the resolution to be proposed by the Secretary for Constitutional and Mainland Affairs on the reorganization of the Government Secretariat before dealing with other Government Bills.

In deciding whether or not the request made by the Chief Secretary for Administration for moving the aforesaid motion was allowed, the President considered the grounds put forward by the Chief Secretary for Administration and the question of whether the amount of time given to Members was sufficient for them to prepare for the resolution proposed by the Secretary for Constitutional and Mainland Affairs if this resolution was to be dealt with at today's meeting.

The President stated that he noted that Members had been informed by writing on 10 May 2012 that the Secretary for Constitutional and Mainland Affairs would propose the relevant resolution at today's meeting, and the deliberations made in the relevant subcommittee as well as the handling of many amendments from Members were based on the date of today's Council meeting at which this resolution was to be dealt with. As the Agenda for today's meeting had clearly set out the resolution as part of the Agenda, the President said that he was convinced that Members were aware of the fact that this resolution proposed by the Secretary for Constitutional and Mainland Affairs would be dealt with at today's meeting.

The President further stated that as a number of items remained outstanding from the several meetings held recently, which included a number of Government bills, this state of affairs had led to a need to suspend Rule 18 of the Rules of Procedure to enable the Council to deal with the resolution from the Secretary for Constitutional and Mainland Affairs at today's meeting as scheduled. Because of the above considerations, the President gave consent to the Chief Secretary for Administration to move the aforesaid motion under Rule 91 of the Rules of Procedure.

Hon KAM Nai-wai drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting. A quorum was then present.

Motions

Motion under Rule 91 of the Rules of Procedure

The Chief Secretary for Administration moved the following motion and spoke on the motion:

That Rule 18(1) of the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region be suspended at the Council meeting of 20 June 2012.

Question on the motion proposed.

Hon Albert HO spoke on the motion.

After Hon Albert HO had spoken, the President reiterated the grounds on which he gave his consent to the Chief Secretary for Administration to move the aforesaid motion.

Two other Members and Hon Frederick FUNG spoke on the motion.

While Hon Frederick FUNG was speaking, the President had directed the Clerk to summon Members to the meeting for two times as his attention was drawn to the absence of a quorum. Each time a quorum was then present.

Hon Frederick FUNG continued to speak on the motion.

After Hon Frederick FUNG had spoken, the President stated that he would not debate his ruling with Members in the Chamber. Yet, as it seemed that Hon Frederick FUNG was not clear about the contents of the motion, the President restated the grounds on which he gave consent to the Chief Secretary for Administration to move this motion.

With the President's permission, Hon Frederick FUNG elucidated a point he had made earlier which he considered to be misunderstood by the President.

Hon Ronny TONG spoke on the motion.

While Hon Ronny TONG was speaking, the President reminded Members that since he had made his ruling, Members should not raise objection to his ruling in their speech at the meeting.

Seven Members spoke on the motion.

By the time the meeting was suspended for a break, the President had directed the Clerk to summon Members to the meeting for five times as Members had drawn his attention to the absence of a quorum. Each time a quorum was then present.

The President suspended the meeting at 6:36 pm.

* * * * * *

The Council resumed at 7:40 pm.

Hon Cyd HO spoke on the motion.

While Hon Cyd HO was speaking, Hon Albert CHAN drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting. A quorum was then present.

Three Members and Dr Hon PAN Pey-chyou spoke on the motion.

While Dr Hon PAN Pey-chyou was speaking, Hon Audrey EU raised a point of order on whether Dr Hon PAN Pey-chyou's speech had deviated from the question under debate.

The President reminded Dr Hon PAN Pey-chyou that his speech should be relevant to the motion.

Dr Hon PAN Pey-chyou continued to speak on the motion.

A Member and Hon LEUNG Kwok-hung spoke on the motion.

While Hon LEUNG Kwok-hung was speaking, the President said that Mr LEUNG should not debate his ruling at the meeting and repeatedly reminded him that his speech should be relevant to the motion.

Hon LEUNG Kwok-hung continued to speak on the motion.

Three Members spoke on the motion.

The President suspended the meeting at 10:04 pm.

The Council resumed at 9:00 am on 21 June 2012.

Nine Members spoke on the motion.

The Chief Secretary for Administration replied.

Question on the motion put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division.

The President announced that 54 Members were present, 27 were in favour of the motion, 25 against it and one abstained (voting record in **Appendix I**). Since the question was not agreed by a majority of the Members present, he declared that the motion was negatived.

By the time the Council went into committee, the President had directed the Clerk to summon Members to the meeting for four times as Members had drawn his attention to the absence of a quorum. Each time a quorum was then present.

Bills

Mandatory Provident Fund Schemes (Amendment) (No. 2) Bill 2011

Committee stage

The Council went into committee and continued to consider the original provisions of clauses 7 to 12, 15, 16, 19, 22 and 27 of the Mandatory Provident Fund Schemes (Amendment) (No. 2) Bill 2011, as well as the amendments thereto.

The Chairman suspended the meeting at 11:50 am.

* * * * * *

The committee resumed at 1:30 pm.

The Secretary for Financial Services and the Treasury spoke on the amendments.

Question on the amendments put.

Hon Albert CHAN claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 40 Members were present, 37 were in favour of the amendments and two abstained (voting record in **Appendix II**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clauses 7 to 12, 15, 16, 19, 22 and 27 as amended stand part of the Bill proposed, put and agreed to.

Question that clauses 13 and 21 stand part of the Bill proposed.

The Chairman stated that the Secretary for Financial Services and the Treasury had given notice to move amendments to clauses 13 and 21. Hon WONG Singchi had also given notice to move amendments to clause 13.

The Chairman further stated that irrespective of whether or not the amendments moved by the Secretary for Financial Services and the Treasury were passed, Hon WONG Sing-chi might move his amendments to clause 13.

The Chairman ordered that clauses 13 and 21 and the amendments thereto be debated together in a joint debate.

The Secretary for Financial Services and the Treasury moved amendments to clauses 13 and 21, and spoke on the amendments.

Four Members spoke on the amendments.

The Secretary for Financial Services and the Treasury spoke again.

Question on the amendments put.

Hon WONG Sing-chi claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 41 Members were present, 37 were in favour of the amendments and three abstained (voting record in **Appendix III**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 21 as amended stand part of the Bill proposed.

Hon Albert CHAN claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 42 Members were present, 38 were in favour of the motion and three abstained (voting record in **Appendix IV**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Hon WONG Sing-chi moved a further amendment to clause 13.

Question on the amendment put.

Hon WONG Sing-chi claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 21 were present, five were in favour of the amendments, 15 against them and one abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 10 were in favour of the amendments, four against them and five abstained (voting record in **Appendix V**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 13 as amended stand part of the Bill proposed and put.

Hon Albert CHAN claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that 40 Members were present, 35 were in favour of the motion, one against it and three abstained (voting record in **Appendix VI**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Question that clause 20 stand part of the Bill proposed.

The Chairman stated that Hon KAM Nai-wai had given notice to move two amendments to clause 20. The Committee would first put to vote Hon KAM Nai-wai's first amendment. If that amendment was passed, Hon KAM Nai-wai might not move his second amendment. The Chairman ordered that the original provisions of clause 20, as well as the two amendments moved by Hon KAM Nai-wai, be debated together in a joint debate.

Hon KAM Nai-wai moved his first amendment to clause 20 and spoke on the two amendments.

A Member and the Secretary for Financial Services and the Treasury spoke on the amendments.

The Secretary for Financial Services and the Treasury spoke again.

Hon KAM Nai-wai spoke again.

Question on Hon KAM Nai-wai's first amendment put.

Hon KAM Nai-wai claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 18 were present, two were in favour of the amendment, 14 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 18 were present, nine were in favour of the amendment, two against it and six abstained (voting record in **Appendix VII**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon KAM Nai-wai moved his second amendment to clause 20.

Question on Hon KAM Nai-wai's second amendment put.

Hon KAM Nai-wai claimed a division. The Chairman then ordered the committee to proceed to a division.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, four were in favour of the amendments, 14 against them and two abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 13 were in favour of the amendments, four against them and two abstained (voting record in **Appendix VIII**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 20 stand part of the Bill put and agreed to.

New clause 23A read the first time.

The Secretary for Financial Services and the Treasury moved the Second Reading of new clause 23A and spoke on the new clause.

Question on the Second Reading of new clause 23A proposed, put and agreed to.

New clause 23A read the second time.

The Secretary for Financial Services and the Treasury moved the addition of new clause 23A to the Bill.

Question on the addition proposed, put and agreed to.

By the time the Council resumed, the Chairman had directed the Clerk to summon Members to the meeting for two times as Members had drawn his attention to the absence of a quorum. Each time a quorum was then present.

The Council then resumed.

Third Reading

The Secretary for Financial Services and the Treasury reported that

the Mandatory Provident Fund Schemes (Amendment) (No. 2) Bill 2011

had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure.

The Secretary for Financial Services and the Treasury moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

Three Members and Hon WONG Kwok-hing spoke on the motion.

While Hon WONG Kwok-hing was speaking, the President repeatedly reminded Mr WONG that his speech should not deviate from the contents of the Bill and if he continued to do so, the President would stop him from speaking.

Despite the President's reminders, Hon WONG Kwok-hing continued to speak on the subject which the President considered to be deviated from the contents of the Bill. The President then ordered him to stop speaking.

Another Member and Hon LEE Cheuk-yan spoke on the motion.

While Hon LEE Cheuk-yan was speaking, the President reminded Mr LEE that his speech should not deviate from the contents of the Bill.

Three Members and Hon LEUNG Kwok-hing spoke on the motion.

While Hon LEUNG Kwok-hung was speaking, the President repeatedly reminded Mr LEUNG that his speech should not deviate from the contents of the Bill.

A Member, Hon Albert CHAN and Hon WONG Yuk-man spoke on the motion. While Hon Albert CHAN and Hon WONG Yuk-man were speaking, the President repeatedly reminded them that their speeches should not deviate from the contents of the Bill.

Question on the Third Reading put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division.

The President announced that 39 Members were present, 35 were in favour of the motion and three abstained (voting record in **Appendix IX**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.

By the time the meeting was suspended for a break, the President had directed the Clerk to summon Members to the meeting for four times as Members had drawn his attention to the absence of a quorum. Each time a quorum was then present.

The President suspended the meeting at 6:58 pm.

Construction Industry Legislation (Miscellaneous Amendments) Bill 2012

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 29 February 2012 resumed.

Ir Dr Hon Raymond HO, Chairman of the Bills Committee on Construction Industry Legislation (Miscellaneous Amendments) Bill 2012, addressed the Council on the Committee's Report. After the address, he spoke on the Bill in his personal capacity as a Member.

Twelve Members spoke on the Bill.

The President suspended the meeting at 9:59 pm.

The Council resumed at 9:00 am on 22 June 2012.

Two Members spoke on the Bill.

The Secretary for Development replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into committee and considered the Construction Industry Legislation (Miscellaneous Amendments) Bill 2012.

Question that clauses 2 to 7, 9 to 17, 20 to 26, 30 to 41, 43 to 57, 59 to 63 and 65 stand part of the Bill proposed, put and agreed to.

Question that clauses 1, 8, 18, 19, 27, 28, 29, 42, 58 and 64 stand part of the Bill proposed.

The Secretary for Development moved amendments to the aforesaid clauses and spoke on the amendments.

Question on the amendments put and agreed to.

Question that clauses 1, 8, 18, 19, 27, 28, 29, 42, 58 and 64 as amended stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Development reported that

the Construction Industry Legislation (Miscellaneous Amendments) Bill 2012

had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure.

The Secretary for Development moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Personal Data (Privacy) (Amendment) Bill 2011

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 13 July 2011 resumed.

Dr Hon Philip WONG, Chairman of the Bills Committee on Personal Data (Privacy) (Amendment) Bill 2011, addressed the Council on the Committee's Report.

Eight Members spoke on the Bill.

By the time the meeting was suspended, the President had directed the Clerk to summon Members to the meeting for four times as Members had drawn his attention to the absence of a quorum. Each time a quorum was then present.

The President suspended the meeting at 12:48 pm.

The Secretary for Constitutional and Mainland Affairs moved amendments to the aforesaid clauses and spoke on the amendments. While the Secretary for Constitutional and Mainland Affairs was speaking, Hon James TO drew the attention of the Chairman to the absence of a quorum. The Chairman directed the Clerk to summon Members to the meeting.

Next meeting

The Council resumed. As a quorum was not present 15 minutes after Members had been summoned, the President adjourned the Council in accordance with Rule 17(3) of the Rules of Procedure until 11:00 am on 27 June 2012.
