Council meeting of 20 June 2012

Proposed resolution under section 54A of the Interpretation and General Clauses Ordinance

I forward for Members' consideration a proposed resolution which the Secretary for Constitutional and Mainland Affairs will move at the Council meeting of 20 June 2012 under section 54A of the Interpretation and General Clauses Ordinance (Cap. 1). The objective of the proposed resolution is to effect transfer of statutory functions from 1 July 2012 pursuant to the proposals to re-organise the Government Secretariat as announced by the Chief Executive-elect on 4 May 2012. The President has directed that "it be printed in the terms in which it was handed in" on the Agenda of the Council.

2. The speech, in both Chinese and English, which the Secretary will deliver when moving the proposed resolution is also attached.

Interpretation and General Clauses Ordinance

Resolution

(Under section 54A of the Interpretation and General Clauses Ordinance (Cap. 1))

Resolved that—

- (1) with effect from 1 July 2012—
 - (a) the functions exercisable by the Secretary for Commerce and Economic Development under each enactment specified in column 2 of Part 1 of Schedule 1 be transferred to the public officer specified opposite to that enactment in column 3 of that Part, and to give full effect to the transfer, the enactments specified in Part 2 of Schedule 1 be amended as set out in that Part;
 - the functions exercisable by the Permanent Secretary for Commerce and Economic Development (Communications and Technology) under the Electronic Transactions Ordinance (Cap. 553) be transferred to the Technology for Permanent Secretary Communications, and to give full effect to the transfer, that Ordinance be amended in the definition of **Permanent Secretary** in section 2(1) by repealing "Permanent Secretary for Commerce and Economic Development (Communications and Technology)" and substituting "Permanent Secretary for Technology and Communications";
 - (c) the functions exercisable by the Secretary for Development under each enactment specified in column 2 of Part 1 of Schedule 2 be transferred to the public

- officer specified opposite to that enactment in column 3 of that Part, and to give full effect to the transfer, the enactments specified in Part 2 of Schedule 2 be amended as set out in that Part;
- (d) the functions exercisable by the Secretary for Home Affairs under each enactment specified in column 2 of Part 1 of Schedule 3 be transferred to the public officer specified opposite to that enactment in column 3 of that Part, and to give full effect to the transfer, the enactments specified in Part 2 of Schedule 3 be amended as set out in that Part;
- (e) the functions exercisable by the Deputy Secretary for Home Affairs (Culture and Sport) under the Lord Wilson Heritage Trust Ordinance (Cap. 425) be transferred to the Secretary for Culture, and to give full effect to the transfer, that Ordinance be amended in section 7(2)(b) by repealing "Deputy Secretary for Home Affairs (Culture and Sport)" and substituting "Secretary for Culture":
- (f) the functions exercisable by the Secretary for Transport and Housing under each enactment specified in column 2 of Part 1 of Schedule 4 be transferred to the public officer specified opposite to that enactment in column 3 of that Part, and to give full effect to the transfer, the enactments specified in Part 2 of Schedule 4 be amended as set out in that Part;
- (g) the functions exercisable by the Secretary for Transport under the Peak Tramway Ordinance (Cap. 265) be transferred to the Secretary for Transport and Works, and to give full effect to the transfer, that Ordinance be amended in section 2A(5) by repealing "Secretary for Transport" and substituting "Secretary for Transport and Works"; and
- (2) in addition to and without derogating from section 23 of the Interpretation and General Clauses Ordinance (Cap. 1)—

- anything lawfully done before 1 July 2012 by or in relation to a public officer from whom any function is transferred under this Resolution (former officer) pursuant to or in connection with that function is to on and from that date be regarded, in so far as necessary for the purpose or in consequence of that transfer, as done by or in relation to, as the case may be, the public officer to whom that function is transferred (new officer);
- anything that, immediately before 1 July 2012, may be done and is in the process of being done by or in relation to a former officer pursuant to or in connection with any function transferred under this Resolution may on and from that date be continued by or in relation to, as the case may be, the new officer;
- anything that, immediately before 1 July 2012, is required to be done and is in the process of being done by or in relation to a former officer pursuant to or in connection with any function transferred under this Resolution is to on and from that date be continued by or in relation to, as the case may be, the new officer;
- (d) without limiting subparagraphs (a), (b) and (c)—
 - (i) any document, agreement or arrangement creating or giving rise to legal rights or obligations that-
 - (A) refers to a former officer, or was prepared, made or entered into by a former officer on behalf of the Government; and
 - (B) is in force immediately before, or is to come into force on or after, 1 July 2012,

is to on and from that date be construed, in so far as necessary for the purpose or in consequence of the transfer of function under this Resolution from the former officer to the new officer, as if the references to the former officer included references to the new officer:

- in any legal proceedings—
 - (A) in which a former officer is a party; and
 - (B) that are subsisting immediately before 1 July 2012,

the new officer is to on and from that date substitute for the former officer as that party;

- (iii) any—
 - (A) right of appeal against a decision of a former
 - (B) right to have the decision reviewed, that is subsisting immediately before 1 July 2012 may on and from that date be exercised as if the decision were a decision of the new officer:
- (iv) any right of appeal to a former officer that is subsisting immediately before 1 July 2012 is to be treated on and from that date as being a right of appeal to the new officer;
- (v) any right to have anything reviewed by a former officer that is subsisting immediately before 1 July 2012 is to be treated on and from that date as being a right to have that thing reviewed by the new officer;
- (vi) any form that is specified or prescribed before 1 July 2012 for use in connection with any function of a former officer that is transferred under this Resolution may on and from that date be used despite the fact that it contains references to the former officer, and those references are to be construed as references to the new officer:
- (e) without limiting subparagraphs (a), (b) and (c), any document, agreement or arrangement that-
 - (i) contains any reference to a public officer or a policy bureau specified in column 1 of Schedule 5;

- (ii) was prepared, made or entered into by any public officer on behalf of the Government;
- (iii) does not create or give rise to any legal right or obligation; and
- (iv) is in force immediately before, or is to come into force on or after, 1 July 2012,

is to on and from that date have effect as if the reference is substituted by a reference to the public officer or policy bureau specified opposite to that officer or bureau in column 2 of Schedule 5 in so far as the substitution is necessary for or conducive to the attainment of the purposes of the document, agreement or arrangement.

Legislative Council Sitting on 20 June 2012: Proposed Resolution under the Interpretation and General Clauses Ordinance

Draft Speech of the Secretary for Constitutional and Mainland Affairs

President,

I move that the resolution proposed under section 54A of the Interpretation and General Clauses Ordinance (Cap. 1), as set out on the Agenda, be passed. The objective of the resolution is to effect transfer of statutory functions from 1 July 2012 pursuant to the proposals to re-organise the Government Secretariat as announced by the Chief Executive-elect (CE-elect) on 4 May 2012.

- 2. To facilitate the CE-elect to re-organise the Government Secretariat, the Chief Executive (CE) has agreed to provide full support to the exercise in the interest of ensuring a smooth transition to the fourth-term Government.
- 3. The re-organisation proposals include the creation of two Deputy Secretary of Department (DSoD) posts; the setting-up of a new Culture Bureau; the re-structuring of the existing Commerce and Economic Development Bureau into two bureaux, namely, the Commerce and Industries Bureau, and the Technology and Communications Bureau; as well as the re-structuring of the existing Development Bureau, and the Transport and Housing Bureau into a Housing, Planning and Lands Bureau, and a Transport and Works Bureau. Details of the re-organisation proposals are set out in the paper for the Legislative Council (LegCo) Panel on Constitutional Affairs on "Re-organisation of the Government Secretariat" issued on 4 May.
- 4. To implement the new organisation structure with effect from 1 July 2012, the current term Government needs to move a resolution to effect the transfer of statutory functions. Pursuant to section 54A of Cap. 1, the LegCo may by resolution provide for the transfer of statutory functions vested in one public officer to another public officer. The proposed resolution provides that, with effect from 1 July 2012, the functions currently exercisable by a certain public officer by virtue of the ordinances

set out in the resolution will be transferred to another public officer who will take charge of the relevant policy responsibilities following the reorganisation of the Government Secretariat.

- 5. The resolution will not involve substantive amendments to the statutory functions (including powers and duties) provided for in the relevant ordinances. Instead, it will provide for the simple substitution of the current title of the public officer by the new title of the public officer in whom policy responsibility for the provision in question will be vested with effect from 1 July 2012.
- 6. After the resolution has been passed, the CE-in-Council will make an order to include the post titles of the two DSoDs and reflect the changes to the post titles of the various public officers. The order will also come into force on 1 July 2012.
- 7. The CE-elect consulted the public and different sectors of the community on the re-organisation proposals during his election campaign. The Office of the CE-elect sought views and advice from the current term Government through the CE's Office, and has met with the bureaux concerned to hear their views. The present proposals have taken into account the views expressed. I would like to appeal to Members to vote in favour of the Government's resolution, so that the re-organisation of the Government Secretariat can take effect from 1 July 2012 in conjunction with the commencement of the fourth-term HKSAR Government.
