The Administration is requested to provide all information in its possession, custody or control relating to the allegations of conflict of interests in the West Kowloon Reclamation Concept Plan Competition ("Competition"), including but not limited to the following:

(a) Entries for the Competition

- (i) entry requirements and eligibility;
- (ii) a full list of the participants of the 161 entries;
- (iii) details of the entry submitted by Dr Kenneth Yeang of T.R. Hamzah & Yeang, including, among others, details of the participants of the entry and the completed official Registration Form submitted by Dr Kenneth Yeang to the then Planning and Lands Bureau, the organizer of the Competition ("Organizer");

(b) The Technical Panel and the Jury

- (i) the appointment, composition and membership of the Technical Panel and the Jury;
- (ii) the terms of reference of the Technical Panel and the Jury;

(c) <u>Declaration of interests</u>

- (i) the requirements for declaration of interests by members of the Technical Panel and the Jury, including the procedure for making the declaration and the specified dates for making such declarations;
- (ii) copy of the declaration of interests forms (if any) provided to the members of the Technical Panel and the Jury;
- (iii) details concerning declarations of interests made by Mr LEUNG Chun-ying both orally and in written form, including the date(s) and the context in which such declarations were made:
- (iv) whether members of the Technical Panel and the Jury had been provided with any information about the list of participants of the entries before the date they were required to make their declarations of interests, and the date on which the list was made available to the Technical Panel and the Jury;

(d) Adjudication

- (i) the assessment criteria;
- (ii) how decisions were made by the Technical Panel and the Jury;
- (iii) the adjudication process, including the information on individual entries that was made available to the Technical Panel and the Jury at the time of adjudication, the relevant dates and minutes of the meetings of the Technical Panel and the Jury, voting records of each member of the Technical Panel and the Jury on each entry, the preliminary list and final list of winning entries;
- (iv) the assessment of the Technical Panel and the Jury on the entry submitted by Dr Kenneth Yeang;
- (v) details concerning the disqualification of Dr Kenneth Yeang's entry, including how the alleged association between Mr LEUNG Chun-ying and the companies pertaining to Dr Kenneth Yeang's entry came to the notice or knowledge of the Organizer, the Technical Panel and/or the Jury, the date on which the disqualification decision was made, who made the disqualification decision and all records of discussions or deliberations (if any) leading to the making of the disqualification decision;
- (vi) details of follow-up actions (if any) taken by the Administration on the alleged association found between Mr LEUNG Chun-ying and the companies pertaining to Dr Kenneth Yeang's entry; and

(e) <u>Chronology of events</u>

(i) a chronology of events detailing the Competition from launch of the Competition to the announcement of results.
