List of outstanding items for discussion (position as at 17 October 2011)

#### Proposed timing for discussion

#### **1.** Development of the exhibition industry in Hong Kong

At the Panel meeting on 21 December 2010, the Panel 15 November 2011 discussed the development of the exhibition industry in Hong Kong, in particular the promotion of the Meetings, Incentive travels, Conventions and Exhibitions (MICE) industry, measures to encourage the utilization of the existing convention and exhibition facilities, as well as the Hong Kong Trade Development Council's assistance for local small and medium enterprises and new exhibitors. Members urged the Administration to provide a more level playing field for AsiaWorld-Expo to compete with the Hong Kong Convention and Exhibition Centre on an equal footing, and help sort out their differences which posed barriers to co-operation. The Administration will update the Panel on the latest development of the exhibition industry in Hong Kong.

# 2. Progress report of the Hong Kong Council for Testing and Certification

The Administration will update members on the work 15 November 2011 progress of the Hong Kong Council for Testing and Certification (HKCTC) in implementing its development plan for the industry and seek members' support to extend a supernumerary Administrative Officer Staff Grade C post created to support the work of HKCTC. The post will lapse on 15 March 2012.

# **3.** Report on the comprehensive review of the Research and Development Centres

The Administration will brief members on the results of the 20 December 2011 comprehensive review of the Research and Development Centres.

# 4. Update on Review of Industrial Estates

The Administration will update members on the latest 20 December 2011 developments of Industrial Estates (IEs) and considerations to be taken into account in examining whether or not to develop a fourth IE.

## 5. Review of the governance of the Hong Kong Export Credit Insurance Corporation

The Public Accounts Committee (PAC) Report No. 56 was 20 December 2011 tabled in the Council on 6 July 2011. One of the chapters in the Report is on the Hong Kong Export Credit Insurance Corporation (ECIC). As the ECIC was established in 1966, PAC is concerned that the governance structure of ECIC as prescribed by the ECIC Ordinance may not be in line with modern-day practices and requirements. Noting that the Commerce and Economic Development Bureau does not micro-manage the daily operations of the ECIC, PAC considers it all the more important for the Advisory Board to play the role of a governing board to monitor the work and performance of the ECIC as well as to oversee its In this connection, the Secretary for Commerce governance. and Economic Development undertook to conduct a review of the governance of the ECIC and report the outcome to the Panel before the end of 2011.

# 6. **Promotion of inward investment**

The Administration will update the Panel on the work of 17 January 2012 Invest Hong Kong in promoting inward investment.

## 7. Development and promotion of Chinese medicine

At the Panel meeting on 13 October 2011, members noted the 17 January 2012 concern raised by Dr Priscilla LEUNG about the disbandment (tentative) of the Hong Kong Jockey Club Institute of Chinese Medicine Members agreed that the Administration (HKJCICM). should brief the Panel on the follow-up arrangements regarding the disbandment of HKJCICM. including termination of employment of HKJCICM staff, disposal of intellectual properties, and the progress of the setting up of the new Government-led committee in the promotion of research and development of Chinese medicine.
