Response to Follow-up Item for the Special Meeting of the Panel on Development on 15 March 2012

Prosecutions Instigated by the Buildings Department Pursuant to Sections 40(1AA) and 40(2A)(c) of the Buildings Ordinance

At the special meeting of the Panel on Development on 15 March 2012, a Member requested the Administration to provide the number of prosecutions instigated by the Buildings Department ("BD") pursuant to section 40(1AA) (i.e. knowingly contravenes section 14(1) of the Buildings Ordinance (Cap. 123) ("BO")) and section 40(2A)(c) of the BO (i.e. knowingly misrepresents a material fact in any plan, certificate, form or notice given to the Building Authority). authorised to provide the following additional information.

From 2001 to 2011, the BD had instigated a total of 100 prosecutions under Section 40(1AA) of the BO, of which the defendants of 76 cases were found guilty. Among these 100 cases, the defendants of 54 were the owners of the concerned properties, and the number of convicted cases is 18. As for Section 40(2A)(c) of

Note Section 14(1) of the Buildings Ordinance provides that "no person shall commence or carry out any building works or street works without having first obtained from the Building Authority - (a) his approval in writing of documents submitted to him in accordance with the regulations; and (b) his consent in writing for the commencement of the building works or street works shown in the approved plan."

the BO, the BD had not instigated any prosecution in the past decade.
