## Background brief prepared by the Legislative Council Secretariat for the meeting on 11 June 2012

#### Applied Learning in new senior secondary curriculum

#### **Purpose**

This paper provides background information on Applied Learning ("ApL") in the new senior secondary ("NSS") curriculum and summarizes the deliberations of the Panel on Education ("the Panel") on issues relating to ApL.

#### **Background**

- 2. Under the NSS curriculum, Secondary ("S") 5 and S6 students may choose ApL courses as elective subjects. ApL complements senior secondary subjects by offering studies with stronger elements of practical learning linked to broad professional and vocational fields. There are six areas of studies in ApL, namely Creative Studies; Media and Communication; Business, Management and Law; Services; Applied Science; and Engineering and Production.
- 3. According to the Administration, schools are encouraged to adopt different modes of implementation by allowing students to enrol in a wide spectrum of ApL courses according to their own interests and learning needs at the venue of course providers, and/or working collaboratively with course providers to offer selected courses to students at school.
- 4. The first cohort of NSS ApL courses was launched in September 2010 with 30 courses under six areas of studies being offered by 11 course providers. As at the end of September 2010, there were about 7 000 student enrolments from about 300 schools, as compared with about 6 000 student enrolments from

about 200 schools in the 2008-2010 cohort of piloting. In the second cohort launched in September 2011, five additional new courses were developed and a total of 35 ApL courses were offered by 12 course providers to NSS students. The number of schools offering ApL courses in the 16 course clusters and the respective number of student applications in the first (i.e. 2010-2012) and second (i.e. 2011-2013) cohorts are in **Appendix I**.

#### **Deliberations of the Panel**

5. The Panel discussed issues relating to ApL in the context of the progress of implementation of the new academic structure and promotion of the Hong Kong Diploma of Secondary Education ("HKDSE") qualification. The major concerns raised by members are summarized in the following paragraphs.

#### Pilot ApL

- Members noted that ApL Courses (formerly known as Career-oriented Curriculum) for S4 and S5 in the old academic structure were first introduced in 2003 as a pilot of alternative curricula to suit different aptitudes of students. was intended to pitch at the Hong Kong Certificate of Education Examination ("HKCEE") level and to pave the way for migrating to NSS education. Students could select ApL courses by joining the programmes at the Hong Kong Institute of Vocational Education ("IVE") or Caritas. Alternatively, schools could invite tutors from IVE or Caritas to run the programmes at school. Administration also advised that it had been working in collaboration with the Hong Kong Council for Accreditation of Academic and Vocational Qualifications and the Hong Kong Examinations and Assessment Authority ("HKEAA") to develop the quality assurance mechanism and assessment framework so that the recognition of pilot ApL qualifications by different stakeholders could be pursued.
- 7. Members stressed the importance of the breadth and depth of ApL courses in enhancing students' ability to find employment or pursue continuing education. Members considered it necessary to attract the professionals in the relevant trades to contribute and participate in the delivery of ApL courses. They suggested that the Administration should make reference to the experience gained from the operation of Project Yi Jin ("PYJ").
- 8. The Administration responded that a number of teachers had indicated interest to be engaged in teaching ApL courses alongside and in collaboration with other professionals delivering the courses. The Administration had made reference to the experiences gained from PYJ and involved the professionals in the relevant trades who had indicated an intention to contribute or participate in

the development and delivery of ApL courses. Professional development programmes for teachers who wished to be engaged in ApL courses were in progress.

#### Recognition of ApL courses

- 9. At the Panel meeting on 10 November 2008, members expressed concern about the recognition of pilot ApL courses for admission under the Joint University Programmes Admissions System ("JUPAS"). It was reported that a student who had completed a pilot ApL course on tourism had been informed of the non-recognition of the course under JUPAS.
- 10. The Administration advised that under the old academic structure, one ApL subject pass was treated as a subject pass in the HKCEE (excluding Chinese Language and English Language) for admission to Pre-Associate Degree/3-year Higher Diploma programmes or equivalent by the Federation for Continuing Education in Tertiary Institutions. The same treatment applied for civil service appointments, subject to the counting of a maximum of two courses. In addition, if students who enrolled in PYJ had successfully completed one or two quality-assured ApL course(s) in a related study area, it would be equivalent to the successful completion of two electives under PYJ. In other words, students would be required to study seven core modules plus one elective (instead of three electives) under PYJ.
- 11. The Administration further advised that as ApL was a new concept in Hong Kong, it took time to evaluate the design, implementation, student performance and to explain progressively the details to different stakeholders. The Education Bureau ("EDB") had been communicating with tertiary institutions regularly on the development of ApL.
- 12. At the meeting in June 2011, the Administration reported to the Panel on the latest progress of the recognition of ApL courses under the new academic structure as follows:
  - (a) students' results would be recorded in the HKDSE certificate as "Attained" and "Attained with Distinction", which were accepted as attaining the competencies required at HKDSE Level 2 and Level 3 or above respectively for the purposes of further studies and/or work;
  - (b) for further studies in sub-degree programmes, a maximum of two ApL subjects would be counted for consideration of admission;

- (c) for undergraduate programmes, University Grants Committee-funded institutions had made announcements in September 2010 on using ApL subjects as specified/unspecified elective subjects, for award of extra bonus or additional information, to suit the needs of different programmes and faculties of different institutions; and
- (d) the Civil Service Bureau would take into account the two levels of attainment in the ApL courses when considering the acceptance of results in HKDSE for civil service appointment.

#### Students submitting results of pilot ApL courses to JUPAS

13. Regarding members' concern about how students submitted their results of pilot ApL courses to JUPAS for application for university admission under the old academic structure, the Administration informed the Panel in November 2008 that it had liaised with the JUPAS Office, which had advised that if the JUPAS Board of Management agreed to the submission of pilot ApL results to the institutions through JUPAS, HKEAA would send the results to JUPAS direct. Otherwise, EDB would attempt to approach individual interested institutions and discuss the possibility for HKEAA to send students' pilot ApL results direct to them.

#### **Latest developments**

14. The Administration will report to the Panel the progress in implementing ApL in NSS at the meeting on 11 June 2012.
