# Land Registry statistics for December

The Land Registry today (January 4) released its statistics for December 2011.

#### Land registration

- The number of sale and purchase agreements for all building units received for registration in December was 5,597 (-6.4% compared with November and -52.5% compared with December 2010)
- The 12-month moving average for December was 9,068 (5.4% below the 12-month moving average for November and 33.1% below that for December 2010)
- The total consideration for sale and purchase agreements in December was \$32.6 billion (-24.4% compared with November and -38.9% compared with December 2010)
- Among the sale and purchase agreements, 4,301 were for residential units (-10.3% compared with November and -53.9% compared with December 2010)
- The total consideration for sale and purchase agreements in respect of residential units was \$25.7 billion (-28.2% compared with November and -35.7% compared with December 2010)

The sale of residential units refers to sale and purchase agreements with payment of stamp duty. These statistics do not include the sale of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme except those after payment of premium.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales have also been released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

#### Land search

• The number of searches of land registers made by the public in December was 337,740 (-6.3% compared with November and -25.7% compared with December 2010)

The statistics cover searches made at the counter, through the self-service terminals and via the Integrated Registration Information System Online Services.



# The Land Registry Chart showing the number of Sale and Purchase Agreements of building units from December 2010 to December 2011


