### I. Meeting with deputations and the Administration

The Joint Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. The Joint Subcommittee received oral representations from 18 deputations.
- 3. <u>The Joint Subcommittee</u> expressed regret and dissatisfaction that the Hospital Authority ("HA") had not sent representative to attend the meeting. <u>The Chairman</u> asked the Clerk to write to HA requesting attendance of its representatives at future meetings of the Joint Subcommittee.

(*Post-meeting note*: The Secretariat had issued a letter on 30 November 2011 inviting representatives of HA to future meetings of the Joint Subcommittee.)

- 4. Mr CHAN Kin-por expressed appreciation to the Hong Kong Police Force for its positive response as set out in LC Paper No. CB(2)379/11-12(01) to his suggestion of providing insurance companies and members of the public with a channel to lodge complaints about and report suspected cases of insurance fraud.
- 5. At the suggestion of Mr Ronny TONG, the Joint Subcommittee requested the Financial Services and the Treasury Bureau and the Office of the Commissioner of Insurance to provide a paper on the applicable licensing requirements if a mutual insurance association akin to a Protection and Indemnity Club for the shipping sector is to write taxi and public light bus insurance business in Hong Kong.
- 6. <u>The Joint Subcommittee</u> requested the Social Welfare Department to provide statistics and analysis of fraudulent claims of assistance under the Traffic Accident Victims Assistance Scheme (including the prosecution figures, successful convictions and their penalties, and the amount of money involved in such cases, etc.).
