I. Meeting with the Administration

The Joint Subcommittee deliberated (index of proceedings attached at **Annex**).

- 2. <u>The Joint Subcommittee</u> noted and drew the Administration's attention to the update on the list of issues to be studied (LC Paper No. CB(2)1001/11-12(01)).
- 3. The Joint Subcommittee was advised by Principle Assistant Secretary for Transport and Housing (Transport) 1 (Acting) ("PAS(T)1(Atg)") that The Kowloon Motor Bus Company (1933) Limited ("KMB") deposited \$2,000,000 with the Director of Accounting Services in accordance with section 4(4)(c) of the Motor Vehicles Insurance (Third Party Risks) Ordinance and appropriated a Contingency Fund for meeting potential liability up to a limit ("excess limit"). KMB had also taken out an external insurance policy to cover potential liability beyond the excess limit. It was not completely self-insured. According to PAS(T)1(Atg), the taxi and public light bus trades consulted did not consider the self-insured option applicable to them. In view of this, members agreed that further discussion on this issue was not needed.
- 4. <u>The Joint Subcommittee</u> was advised by Mr Harry WONG of the Hong Kong Federation of Insurers ("HKFI") that the Governing Committee of HKFI would discuss the feasibility of establishing a central database for insurance claims and might form a task force to study the issue of concern.
- 5. In studying possible measures to tackle the problems of exaggeration of injuries and abuse issuance of sick leave certificate, <u>Mr CHAN Kin-por</u> suggested that -
 - (a) an independent medical review system be jointly established by the Hospital Authority and the insurance sector;
 - (b) a central reporting mechanism be provided by the Hospital Authority to receive complaints relating to exaggeration of injuries from insurance companies; and
 - (c) consideration should be given to the introduction of "a fit note system" (i.e. replacement of the conventional sickness certificate with a new medical certificate called "the fit note") as implemented in the United Kingdom.

- 6. <u>Chief Manager (Cluster Performance)</u>, <u>Hospital Authority</u> said that he raised no objection to Mr CHAN Kin-por's suggestion on the joint establishment of an independent medical review system. However, he pointed out the operational difficulties, for example, privacy concern and impact on physician-patient relationship, in implementing a central reporting mechanism to handle cases suspected of exaggerating injuries. He would seek the advice of the Medical Council of Hong Kong on how a doctor should handle information received from a third party alleging that a patient had been exaggerating his/her injury.
- 7. The Joint Subcommittee noted that the Hong Kong Police Force had conducted a seminar in February 2012 for the insurance sector on the implementation and operation of its reporting mechanism for referral of suspected cases of insurance fraud. At the request of the Chairman, Superintendent (Fraud Division)(Commercial Crime Bureau), Hong Kong Police Force agreed to conduct another seminar specifically for the transport sector.
- 8. In considering whether it would be feasible for Hong Kong to make reference to a recommendation made in the United Kingdom to introduce an Independent Assessment Service for individuals with persistent sickness absence, members agreed that the Secretary for Food and Health, the Secretary for Labour and Welfare and representatives of HKFI be invited to the next meeting for discussion.

(*Post-meeting note*: In response to the Joint Subcommittee's invitation, the Food and Health Bureau and the Labour and Welfare Bureau had indicated that they would not send representatives to attend the next meeting. Their replies were circulated for members' reference on 27 February 2012.)

II. Any other business

- 9. <u>The Chairman</u> reminded members that the next meeting of the Joint Subcommittee originally scheduled for 1 March 2012 had been rescheduled to 2 March 2012 at 3:00 pm or immediately after the House Committee meeting, whichever was later.
- 10. There being no other business, the meeting ended at 4:00 pm.
