# I. Meeting with the Administration

The Joint Subcommittee deliberated (index of proceedings attached at **Annex**).

Traffic Accident Victims Assistance ("TAVA")

2. <u>The Joint Subcommittee</u> requested the Social Welfare Department ("SWD") to provide the following statistical information in respect of TAVA for the past five years with a breakdown by year -

- (a) the amount of various TAVA grants disbursed under the Traffic Accident Victims (Assistance Fund) Ordinance (Cap. 229);
- (b) the number of cases in which the recipients were prosecuted for allegedly making fraudulent claims of TAVA and the number of successful prosecutions;
- (c) the number of suspected cases of fraud referred to the Police for investigation and follow-up action; and
- (d) the number of people who made repeated applications for TAVA and the number of repeated applications made by each such applicant.

(*Post-meeting note*: SWD had provided the requisite information vide LC Paper No. CB(2)2084/11-12(02) issued on 21 May 2012.)

- 3. Noting that SWD was developing a new information system to store essential data of TAVA applicants, <u>members</u> suggested that additional information on traffic accidents relating to TAVA applications, such as the name of owner and driver and registration mark of the vehicle concerned, should be kept by the system to facilitate fraud detection and investigation.
- 4. <u>Members</u> suggested that the insurance sector could make reference to the privacy policy and practice of the Commercial Credit Reference Agency when exploring the feasibility of setting up an insurance fraud detection mechanism. <u>Members</u> were of the view that relevant data sharing between SWD and the Hong Kong Federation of Insurers ("HKFI") could help deter and prevent the making of fraudulent claims.
- 5. Noting that insurance companies had not kept figures on suspected fraud cases identified by them, <u>members</u> urged HKFI to make such data available to SWD and the Police for detection and investigation purposes. <u>Senior Social Security Officer (Accident Compensation)</u> supplemented that at present, a representative of HKFI was appointed as member of TAVA Advisory Committee of SWD to discuss issues relating to the TAVA Scheme.

## Making of false oaths

6. <u>Assistant Solicitor General (Acting)/General Legal Policy</u> agreed to explain to HKFI members the prosecution procedure against those making false statements, if necessary. He also indicated that the insurance sector could coordinate and refer suspected cases of making false statements in legal proceedings of civil claims to the Department of Justice for follow-up actions.

#### Reporting system for suspected fraud cases

- 7. The Joint Subcommittee noted that the Police maintained close communication with HKFI on matters relating to insurance fraud. So far, the Police had not received from the insurance sector any referral of suspected fraud cases since the implementation of its crime reporting system for insurance fraud in February 2012. Chief Inspector (Fraud Division) (Commercial Crime Bureau) ("CIP(F Div)(CCB)") pointed out that the preliminary screening of suspected fraud cases performed by HKFI before referral would facilitate the Police's investigation.
- 8. <u>CIP(F Div)(CCB)</u> said that the Police conducted a seminar on 28 February 2012 for the transport sector on motor insurance fraud. To facilitate the Police's follow-up actions, he recommended the transport sector to lodge complaints relating to motor insurance fraud with the district report rooms in writing with a copy to the Commercial Crime Bureau.
- 9. <u>CIP(F Div)(CCB)</u> further said that the Police was delighted to conduct seminars to share with the insurance sector its knowledge and techniques for investigating motor insurance fraud. He stressed that there was a series of promotion and education programmes on fraud prevention throughout the year. A television series on fraud cases, including insurance fraud, would be broadcasted through the "Police Magazine" in mid-July 2012.
