I. Development of cultural software in preparation for the commissioning of the first batch of facilities

[LC Paper Nos. CB(2)2369/11-12(01) and (02)]

The Joint Subcommittee deliberated (index of proceedings at **Annex**).

2. <u>Members</u> were briefed by the Administration and the West Kowloon Cultural District Authority ("WKCDA") on the progress of development of cultural software in preparation for the commissioning of the first batch of performing arts ("PA") facilities to be commissioned in 2015-2016 in the West Kowloon Cultural District ("WKCD"). Noting that the Xiqu Centre was the only PA facility scheduled for completion in 2015-2016, <u>members</u> raised concern about the attractiveness of WKCD to the public and whether the events held in the Freespace could draw large audiences.

3. WKCDA responded that -

- (a) WKCDA endeavoured to raise the public's awareness of WKCD, bring people to the site and gradually make it a habit for them to go there to enjoy different arts and cultural activities;
- the Xiqu Centre, located at the eastern entrance of WKCD, was (b) one of the WKCD's iconic buildings in WKCD and would serve to preserve and promote the valuable traditional Chinese art form in Hong Kong. WKCDA had organized the West Kowloon Bamboo Theatre event at the site of the Xiqu Centre around Lunar New This event presented a combination of traditional Year 2012. performances, contemporary Cantonese opera installations and film shows in collaboration with the Chinese Artists Association of Hong Kong and various renowned visual artists, and attracted around 12 000 participants in seven days In the light of positive response, (18 to 24 January 2012). WKCDA planned to make the Bamboo Theatre an annual festival featuring Cantonese Opera and other art forms, and establish strategic partnership with local arts communities;
- (c) aside from providing public space for arts education activities delivered by arts organizations, Freespace would also provide a venue for music and other events; and
- (d) WKCDA had obtained Short Term Tenancies from the Lands

Department to accommodate temporary structures at the WKCD site for organizing a range of arts and cultural activities to build audiences. WKCDA would organize a balanced mix of events, including performances, music festivals, carnivals and exhibitions, to suit different needs of the community.

- 4. On members' enquiry about whether WKCDA would work in collaboration with schools and universities to promote students' interest in arts and enhance their ability to appreciate different arts performances, WKCDA advised that WKCDA had maintained liaison and discussion with the Education Bureau and universities on the organization of events to bring The Administration also pointed out that the WKCD to the community. Leisure and Cultural Services Department ("LCSD"), the Hong Kong Arts Development Council ("HKADC"), Hong Kong Academy for Performing Arts and nine major PA groups had been playing a key role in building audience in the community and promoting arts education in Hong Kong. In 2011, some 40 000 activities/programmes on arts education and broadening audience base had been held. These activities/programmes included PA and visual arts activities, guided tours specially designed for students and workshops.
- 5. <u>Members</u> were informed that M+ had received a donation of 1 463 Chinese contemporary artworks, conservatively valued at HK\$1.3 billion, by Dr Uli Sigg, the world's leading collector of Chinese contemporary art. Under a part gift/ part purchase agreement, M+ acquired a further 47 works from Dr Sigg's collection. WKCDA and M+ would strive to build relationship with the local arts community and build the capacity of the local visual arts community in particular. In this respect, M+ had collaborated with HKADC for the first time in presenting the works of Mr LEE Kit, a Hong Kong artist, at the 55th International Art Exhibition of the Venice Biennale.
- 6. On members' concern about the shortage of PA venues (i.e. black box theatres) in Hong Kong to meet the needs of local small and medium sized arts groups and the commissioning date for the black box theatres in WKCD, WKCDA responded that the timetable of the black box theatres had to allow for the progress of the Express Rail Link ("XRL") project as the black box theatres were positioned at the central part of WKCD. WKCDA had constant communication and discussion with the MTR Corporation regarding the progress of XRL project. WKCDA hoped that spaces on the temporary sites could provide performance venues for small and medium sized PA groups prior to the commissioning of the black box theatres in WKCD.

II. Progress update on design competitions

[LC Paper Nos. CB(2)2369/11-12(03) and (04)]

- 7. <u>Members</u> noted the progress on the design competitions for the implementation of the WKCD project as detailed in the information paper provided by WKCDA. <u>Members</u> pointed out the importance of conducting the competitions in a fair and open manner and avoiding conflict of interest.
- On members' enquiries, WKCDA advised that the winning designs of the 8. design competitions would be adopted for implementation. WKCDA had engaged a Procurement Strategy Consultant ("Consultant") to analyze, select and recommend a procurement strategy for delivery of the Core Arts and Cultural Facilities ("CACF"), Other Arts and Cultural Facilities and Retail, Dining and Entertainment ("RDE") facilities to be provided in WKCD. Having considered the recommendations made by the Consultant, WKCDA had selected the Xiqu Centre as the first CACF for design competition and the competition would serve as a useful reference for subsequent competitions. WKCDA was still considering alternative funding sources for the development of three venues with commercial contents (namely, the Mega Performance Venue, Exhibition Centre and Musical Theatre). Subject to alternative funding options, WKCDA had yet to decide whether design competitions would be conducted for these CACF.
- 9. <u>Members</u> were concerned about the consistency of the winning designs with the City Park conceptual plan ("CP") designed by Foster+Partners ("F+P"). <u>WKCDA</u> assured members that all the facilities in WKCD would be built within the context of the Development Plan ("DP") of WKCD and the urban design guidelines under the F+P scheme. The main purpose of DP was to lay out WKCD area and set apart the land for various arts and cultural facilities; for other land uses such as commercial, hotel, retail and public open spaces; and for internal infrastructural projects. DP, which was formulated on the basis of F+P's CP, took into account the development parameters that had been set out in the relevant draft Outline Zoning Plan ("OZP"). Hence, while each individual facility could preserve its distinctiveness, consistency of all facilities in WKCD could be maintained.
- 10. As regards the statutory planning process, <u>WKCDA</u> informed members that WKCDA had submitted DP to the Town Planning Board ("TPB") for consideration in December 2011. TPB announced the publication of the draft WKCD DP on 30 March 2012, and the public was invited to make representation to this DP before 30 May 2012. WKCDA was currently making responses to the public representations and would submit its responses to TPB

by end June 2012. Another hearing by TPB would follow. WKCDA envisaged that the statutory planning would be completed by end 2012. Design competitions for other WKCD venues were in progress simultaneously to save time.

III. Financial arrangements for the West Kowloon Cultural District Project

[LC Paper Nos. CB(2)2369/11-12(05) and (06)]

- 11. <u>Members</u> noted the current financial situation and arrangements for the WKCD project as detailed in the information paper provided by WKCDA.
- 12. Members were advised that -
 - (a) in 2008, LegCo approved a one-off upfront endowment of \$21.6 billion for WKCDA to implement the project. WKCDA had been managing its finance prudently and was mindful of the investment objectives to meet project cash flow requirements, to preserve capital, to maintain a diversified portfolio investment risk and maturity profile, and to optimize investment yield. The current financial position of WKCDA was healthy and it had over \$23 billion; and
 - (b) the three selected Conceptual Plan Consultants had undertaken their own financial assessments based on their proposed CPs. Their estimated capital cost ranged from \$28 billion to \$29.6 billion, and taking into account the projected RDE income, their projected surplus on total project Net Present Value ranged from \$2.9 billion to \$8 billion.
- 13. <u>Members</u> expressed concern about the adequacy of the funding for the project and the alternative funding options. <u>WKCDA</u> advised that WKCDA would continue to exercise due care and diligence in handling its finances. The exercise of artistic control would be WKCDA's paramount consideration when WKCDA looked into the issue of funding options. The Mega Performance Venue, Exhibition Centre and Musical Theatre were subject to alternative funding options. The Mega Performance Venue would be the biggest indoor seated facility (with 15 000 seats) in Hong Kong designed for local and overseas concerts and large-scale entertainment events. Musical Theatre would have 2 000 seats for staging musicals, popular commercial productions and large-scale performances. Taking into account the nature of programmes to be

presented in the Mega Performance Venue, Exhibition Centre and Musical Theatre, it was considered that they could be built with alternative financing options without compromising the artistic control of WKCDA.

- 14. Mr Alan LEONG pointed out that the Subcommittee on West Kwoloon Cultural District Development formed in the Third Legislative Council ("LegCo") had considered a Build-Operate-Transfer mode inappropriate for the WKCD project as it would be difficult for the operators to preserve the artistic and cultural characteristics of the facilities. WKCDA should report to LegCo when WKCDA had made decisions on the options that would be adopted. He also raised concern about whether WKCDA would increase its revenue by setting up more RDE or hotel/office/residential facilities.
- 15. <u>WKCDA</u> responded that the key development parameters of WKCD including plot ratio, cap on residential GFA, provision of open space and building height control had been laid down in the OZP. DP had been formulated in accordance with these development parameters. WKCD site, as a whole, was subject to a maximum plot ratio of 1.81, provision of not less than 23 hectares of public open space, residential development of not more than 20% of total plot ratio, as well as building height restrictions of 50, 70 and 100 metres above Principal Datum under three sub-zones.

IV. Any other business

Report of the Joint Subcommittee

- 16. <u>Members</u> were generally of the view that as WKCD project was still in progress and would be in full swing in the next several years, a dedicated subcommittee should be formed in the Fifth LegCo to continue to monitor the implementation work of the project.
- 17. <u>Members</u> noted that a report on the work of the Joint Subcommittee in the Forth LegCo would be made to the Panel on Development and the Panel on Home Affairs. The draft report of the Joint Subcommittee would be circulated for members' consideration and endorsement.
