Action

I. Meeting with the Administration and representatives/members of District Councils

[LC Paper Nos. CB(2)1006/11-12(01) to (03), CB(2)1071/11-12(01) and CB(2)1129/11-12(01)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

Meeting with District Council ("DC") members

- 2. <u>DC members</u> attending the meeting urged the Administration to, in addition to the retrofitting programme in response to the Equal Opportunities Commission's Formal Investigation Report on Accessibility in Publicly Accessible Premises ("the EOC Report"), attach equal importance to respond to the strong community call for the provision of barrier free access and facilities, such as the provision of hillside escalator links and elevator systems and barrier free access and facilities in commercial premises under the management of private developers.
- 3. The Administration advised that the scope of the EOC Report was to conduct access audits on 60 publicly accessible premises. In drawing up the retrofitting programme to follow up on the EOC Report, the Administration had already comprehensively examined the existing government premises and facilities which had a frequent public interface on the basis of the latest Design Manual: Barrier Free Access 2008 ("DM 2008") and devised a retrofitting programme covering about 3 700 government premises and about 300 Housing Authority properties. Having regard to operational requirements, technical feasibility and time required for retrofitting works, the retrofitting programme would be completed by phases and nearly 90% of them would have works completed by end-June 2012. Where considered necessary, improvement works for other venues not covered under the programme could continue to be carried out under the regular maintenance programme. This apart, the Highways Department had also devised a retrofitting programme to improve the accessibility of the

public footbridges and subways under its maintenance. Furthermore, Access Co-ordinators and Access Officers had been appointed in bureaux/departments since April 2011 in enhancing the management of the barrier-free access and improving the accessibility of government premises and facilities.

4. In respect of the progress of the proposals of the hillside escalator links and elevator systems, the Administration advised that having regard to the available resources, the top 10 ranked projects had been taken forward, of which the feasibility studies for five proposals had been completed and the rest five were expected for completion within 2012. Upon completion of the feasibility studies, the Administration would then work on the preparatory works in the pre-construction stage. All preparatory works at the pre-construction stage involved complicated procedures, the actual timetable would depend on the extent and complexity of the proposals.

Progress of the retrofitting programme

- 5. <u>Members</u> noted the Administration's follow-up action as at 31 December 2011 on the EOC Report as detailed in its paper [LC Paper No. CB(2)1006/11-12(01)]. They urged the Administration to ensure the timely completion of the retrofitting works as scheduled.
- 6. that EOC Members noted had provided paper "Mainstreaming of Universal Design concept" [LC Paper No. CB(2)1006/11-12(02)]. Members expressed support for the incorporation of Universal Design concept and principles into government policies and urged the Administration to play an active role in promoting Universal Design in different policy areas as far as practicable.
- 7. <u>Members</u> noted with concern that pre-1997 buildings were not obliged to comply with the DM 2008 to incorporate barrier free facilities. <u>Members</u> urged the Administration to consider introducing the relevant legislative proposal in this respect.
- 8. To facilitate the Subcommittee to prepare its report, the Chairman invited EOC to provide further information, if any, on the approach to incorporate the Universal Design concept in the formulation and implementation of government policies and programmes as well as the introduction of legislative proposal relating to the provision of barrier free facilities for all pre-1997 buildings.

EOC

Action

Admin 9. The Administration was requested to -

- (a) convey members' views to respective responsible bureaux/departments on incorporating the principles of Universal Design in formulation and implementation of policies and action plans, with a view to building a barrier free community; and
- (b) provide information, if any, on the manpower deployment for taking forward the first phase of retrofitting works at public pedestrian footbridges (involving 10 facilities) and the measures adopted to expedite the progress of the works.

Work plan of the Subcommittee

- 10. <u>Members</u> agreed that a motion on the report of the Subcommittee should be moved at a Council meeting by 27 June 2012.
- 11. <u>Members</u> agreed that the next meeting of the Subcommittee would be held on 30 March 2012 to meet with representatives of the Mass Transit Railway Corporation, The Link Management Limited and the Hospital Authority to follow up on the implementation progress of the improvement/upgrading works in respect of barrier free access and facilities in premises and facilities under the management of these organisations. The Chairman added that two further meetings of the Subcommittee would be scheduled for April and May 2012 to discuss issues relating to the accessibility of schools and the latest progress of the Government's retrofitting programme respectively.

II. Any other business

12. There being no other business, the meeting ended at 11:05 am.
