Action

I. Meeting with the Administration

[LC Paper Nos. CB(2)1903/10-11(01), CB(2)2350/10-11(01), CB(2)2511/10-11(01) to (02), CB(2)1685/11-12(03), CB(2)1814/11-12(01) and CB(2)1890/11-12(01) to (03)]

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

- 2. <u>The Chairman</u> advised that the Research Division of the Legislative Council Secretariat had updated the research report entitled "Retirement Protection System in Selected Places" which was issued to members on 7 May 2012.
- 3. <u>Members</u> noted that the Administration had provided the latest position of the Administration's studies and measures related to the retirement protection system in Hong Kong, and a consolidated response to deputations' requests for the provision of statistical information relating to retirement protection.
- 4. <u>Members</u> expressed grave dissatisfaction at the refusal of the Central Policy Unit ("CPU") to make available any findings of its studies on the retirement protection system in Hong Kong to facilitate the discussion of the Subcommittee on the subject. <u>The Administration</u> advised that CPU was continuing its work in refining its study. This included, among others, conducting a territory-wide household survey in February 2012 to understand the latest economic situation of the elderly in Hong Kong and

their retirement plans. The initial results of the survey were expected to be available by the end of 2012 at the earliest. When taking forward its study on the retirement protection system in Hong Kong, CPU would make reference to the deliberations of the Subcommittee and the retirement protection models proposed by the deputations. Upon completion of its work on refining the studies, CPU would submit the overall study findings and recommendations to the Administration for review and consideration of the way forward.

5. <u>Members</u> did not subscribe to the Administration's explanation. They considered the unduly long time taken for the CPU study was unacceptable. <u>The Subcommittee</u> passed the following motion moved by Mr WONG Sing-chi and seconded by Mr LEE Cheuk-yan -

"本小組委員會譴責中央政策組漠視立法會研究全民退休保障工作,一直拒絕提交其所進行的任何有關研究,以利公眾討論。"

(Translation)

"That this Subcommittee condemns CPU for ignoring the Legislative Council's efforts in studying the subject of universal retirement protection and being reluctant to provide findings of any relevant studies that it has conducted so far, so as to facilitate public discussion."

- 6. <u>Members</u> considered the draft report of the Subcommittee prepared by the Legislative Council Secretariat, and agreed to make the following amendments to the draft report -
 - (a) to include the discussion made at this meeting, which included, among others, the passage of the above motion, in the report; and
 - (b) to revise the second sentence of paragraph 63(b) as follows: "The next Government should accord top priority to setting immediately set up a dedicated task force to study the subject matter, with a view to drawing up a concrete timetable for the launch of an extensive public consultation on the options and implementation details without further delay, and formulating concrete execution plans in the first year of tenure".
- 7. The Chairman advised that subject to any further views from members on the draft report by 5:00 pm on 10 May 2012, the

Subcommittee would submit the revised report incorporating the above amendments to the Panel on Welfare Services on 14 May 2012 and seek the support of the Panel and the agreement of the House Committee for priority allocation of a debate slot to the Chairman of the Subcommittee under House Rule 14A(h) for moving a motion on the Subcommittee's report at the Council meeting on 6 June 2012.

		(b) CPU was refining its studies on the retirement protection system in Hong Kong in the light of the latest developments and the results of the territory-wide household survey on the latest economic situation of the elderly and their retirement plans which were expected to be available by the end of 2012. That said, the Administration had briefed the Subcommittee vide LC Paper No. CB(2)2350/10-11(01) the initial findings of the studies, which indicated that the three pillars under the current retirement protection model in Hong Kong were complementary to one another.
